This manual contains information you need to know to do the physical installation of the TURBOWAYS 25 Adapter. Device driver installation, adapter configuration, adapter testing, and problem determination can be done using the STARTCD program on the TURBOWAYS 25 CD-ROM for ISA and PCI Adapters (CD-ROM). The TURBOWAYS 25 ATM PCI Adapter Installation and Testing Instructions manual is available on the CD-ROM in both viewable and printable format. The STARTCD program directs you to those parts of the manual that relate to your installation environment.

Chapter 1. Introduction

You should start your installation and configuration of the TURBOWAYS 25 Adapter by using this manual.

This manual contains the information you need to do the physical installation of the TURBOWAYS 25 Adapter. It also contains instructions on how to access the CD-ROM where you can either install the device drivers directly or you can make diskettes of the device drivers and the ATM installation and diagnostics program. The CD-ROM contains:

- The STARTCD program (which directs you through the device driver installation tasks)
- · Device driver diskette images
- ATMAID diskette
- · Viewable and printable documentation

The TURBOWAYS 25 ATM PCI Adapter Installation and Testing Instructions manual can be viewed or printed from the CD-ROM. See "Accessing the CD-ROM" on page 4-3.

If you do not have a CD-ROM drive installed on your machine, you can use another machine that does have a CD-ROM drive installed and create the necessary diskettes and documentation. See "Accessing the CD-ROM" on page 4-3.

If no CD-ROM drive is available, you can obtain diskette images and documentation from IBM through the Internet, the IBM FTP server, or the IBM Bulletin Board System. See "Obtaining Information from Sources Other Than the CD-ROM" on page 4-3.

You should be familiar with the personal computer in which the adapter will be installed and the computer's operating system and network software.

The TURBOWAYS 25 ATM PCI Adapter

The TURBOWAYS 25 Adapter provides a communications connection for a personal computer system to an Asynchronous Transfer Mode (ATM) network. It allows personal computer systems to communicate with other devices over the ATM network at a rate of 25.6 Mbps.

The TURBOWAYS 25 Adapter is designed to operate in a Peripheral Component Interconnect (PCI) bus personal computer equipped with the following hardware:

- A 486 or higher processor
- · An available 32-bit, PCI expansion slot with bus master capability
- 8 MB to 32 MB of memory, depending on your operating system

Special features of the TURBOWAYS 25 Adapter include:

- · Easy-to-use configuration and diagnostics
- Support for up to 32 active virtual circuits through the IBM 8285 Nway ATM Workgroup Switch, or a switch, or a concentrator using the 25.6-Mbps interface

Chapter 2. Preparing to Install the Adapter

This chapter contains information on how to prepare to install your IBM TURBOWAYS 25 Adapter in your personal computer. After you have completed the physical installation, store this manual with the instruction manual supplied with your computer for future reference.

Use the following checklist for installation of the adapter.

Adapter Installation Checklist Verify that you have the items listed under "Contents of the Adapter Kit" on page 2-2. Read "Collecting the Materials and Information That You Need" on page 2-3 and ensure that you have everything for the physical installation of the adapter. If you do not already know, contact your network administrator for the type of device driver you want to install or for any special addresses. (For example, Forum-Compliant LAN Emulation driver, Classical IP driver, LES ATM address, or the ARP server ATM address.) The TURBOWAYS 25 ATM ISA Adapter Installation and Testing Instructions manual on the CD-ROM. contains a complete description of device





If any item is missing or damaged, contact your place of purchase.

Collecting the Materials and Information That You Need

In addition to the TURBOWAYS 25 Adapter kit, you will need other materials and information to install the adapter and the drivers that are required for communication with the adapter. The following sections describe the materials you need and the prerequisites you need to meet. Ensure that you have everything you need before you begin the installation procedures.

Hardware Prerequisites

To install the adapter, you need to meet certain hardware prerequisites. You need:

- A PCI bus personal computer equipped with a 486 or higher processor.
- An available 32-bit, PCI expansion slot with bus master capability
- 8 MB to 32 MB of memory, depending on your operating system.
- A 3.5-inch, 1.44-MB diskette drive or a CD-ROM drive.
- A VGA or better monitor.

- A hard disk with at least 2 MB of available storage.
- Connection to an IBM 8285 Nway ATM Workgroup Switch, or a switch, or a concentrator using the 25.6-Mbps interface or equivalent.
- UTP or STP cabling with the appropriate connectors on either end. (See "Adapter Cables" for more information.)
- If you want to run the wrap test and you are using UTP cabling, you will need an RJ-45 ATM wrap plug (P/N 42H0540) or equivalent. (Refer to the "RJ-45 ATM Wrap Plug Specifications" in the TURBOWAYS 25 ATM PCI Adapter Installation and Testing Instructions manual on the CD-ROM for the specifications of the ATM wrap plug. See "Accessing the CD-ROM" on page 4-3 for information on how to read the online manual.)

Adapter Cables

Note: The TURBOWAYS 25 Adapter conforms to ATM Forum RJ-45 wiring standards. The following sections discuss cabling needs for the TURBOWAYS 25 Adapter when you are connecting it to a device (such as a switch) that also conforms to the ATM Forum wiring standards. For a fuller discussion of wiring standards and cabling specifications for both the current and earlier TURBOWAYS 25s, refer to "ATM 25–Mbps Interface Wiring Standards and Cable Specifications" in the *TURBOWAYS 25 ATM PCI Adapter Installation and Testing Instructions* manual on the CD-ROM.

To connect the TURBOWAYS 25 Adapter to an ATM network, you will need one or more of the cables described in the following sections.

UTP Cables

If you are connecting a TURBOWAYS 25 in a UTP cabling system, you must obtain a UTP cable (see Figure 2-1).



Figure 2-1. UTP Adapter Cable

Note: The minimum UTP cable quality must meet EIA/TIA-568 Specification for category 3 or equivalent UTP wiring. For additional information on how cable wires are terminated, refer to "Cable Systems" in the *TURBOWAYS 25 ATM PCI Adapter Installation and Testing Instructions* manual on the CD-ROM.

STP Cables




Figure 2-2. IBM RJ-45 STP Adapter Cable (ATM Forum Pin Assignment)

If you are connecting a TURBOWAYS 25 Adapter in an STP cabling system, you must use an IBM RJ-45 STP cable (P/N 42H0544) or equivalent (see Figure 2-2). This IBM STP cable uses the ATM Forum pin assignments and is identified by an *orange* dot on the tag of the cable. (Note that the TURBOWAYS 25 Adapter also has an orange dot on its bracket.)

Attention: Do not use the UTP Conversion cable (P/N 10H3904) or any other unshielded cable in an STP cable system. To do so will cause an impedance discontinuity and loss of the STP cable shield connection.

Other Manuals

In addition to this manual and the Safety Information manual, which are shipped with the TURBOWAYS 25 Adapter, you will need:

- The TURBOWAYS 25 ATM PCI Adapter Installation and Testing Instructions manual, which is located on the CD-ROM (The STARTCD program on the CD-ROM directs you to the appropriate sections of the manual depending on your operating system.)
- The manual provided with your computer
- · The manual provided with your network operating system or network application

Chapter 3. Physical Installation of the Adapter

This chapter contains instructions for physical installation of the adapter in your personal computer.

Installing the Adapter

In the following spaces, record the part number, serial number, and date code listed on the paper label located on the side of the adapter (Figure 3-1 is an example). You might need to know this information at some future time.

Understanding the Adapter Labels




Figure 3-2. The Adapter Labels

Figure 3-2 on page 3-2 illustrates the two labels on the bracket of the TURBOWAYS 25 Adapter.

The orange dot label indicates that the adapter can communicate at 25 (25.6) Mbps over an ATM Forum-compliant cabling system network.

The universally administered address label displays the adapter's universally administered address. This is the MAC address that was encoded in the adapter memory at the factory. This 12-digit, hexadecimal address is recorded on the label in 2-digit increments from left to right, starting on the first row. In the illustration, the universally administered address is X'0004 AC2C 0001' in noncanonical format, most significant bit (MSB) first. The universally administered address is unique and is used by network software to distinguish the adapter from others on the network.

Placing the Adapter in an Expansion Slot

- 1 Ensure that the computer is switched off and unplugged. Refer to the computer's instruction manual for directions on installing adapters.
- **2** Install the adapter in any available 32-bit, PCI expansion slot with bus master capability.

Note: Once you have installed the adapter, each time you switch on your computer the PCI network basic input/output system (BIOS) allocates system resources to the adapter by assigning it configuration settings. In order to remove the configuration settings and release the system resources, you must remove the adapter physically from the computer.

- **3** After you have replaced all of your computer's covers, plug your computer's power cord into an electrical outlet.
- **4** Continue with "Connecting the TURBOWAYS 25 Adapter to the Network."

Connecting the TURBOWAYS 25 Adapter to the Network

1 To attach the TURBOWAYS 25 Adapter to the network, you will need one of the cables listed in "Adapter Cables" on page 2-4.




Figure 3-3. Connecting the Cable to the Adapter

Connect one end of the cable to the adapter (see Figure 3-3 on page 3-4).

- **2** Connect the other end of the cable to the network.
- **3** Connection to the network is complete. Continue with Chapter 4, "Instructions to Complete Installation" to complete the physical installation of the adapter.

Note: For information about testing the adapter or about problem-solving, refer to the TURBOWAYS 25 ATM PCI Adapter Installation and Testing Instructions manual on the CD-ROM. (The STARTCD program directs you to the appropriate sections in the manual depending on your operating system.)

Chapter 4. Instructions to Complete Installation

This chapter contains instructions to complete the installation of the adapter. It also contains information on how to obtain assistance and service for your adapter.

To complete the hardware and software installations of the TURBOWAYS 25 Adapter, choose one of the following options:

- Access the CD-ROM: See "Accessing the CD-ROM" on page 4-3.
- If you do not have a CD-ROM drive installed on your machine but have access to one: See "Accessing the CD-ROM" on page 4-3.
- If you do not have access to a CD-ROM drive, use the Internet, the IBM FTP server, or the IBM Bulletin Board System to obtain device driver diskettes images and documentation: See "Obtaining Information from Sources Other Than the CD-ROM" on page 4-3.

Contents of the CD-ROM

The CD-ROM contains the STARTCD program, device driver code, ATMAID code, and supporting documentation. From the CD-ROM you can access required device driver diskette images to install your software and view (or print) supporting online documentation. The CD-ROM includes viewable BookManager files and printable PostScript and ASCII files.

The README.1ST Files

The STARTCD program helps you create the diskettes needed for your operating system. Before configuring the adapter and installing the device drivers for the TURBOWAYS 25 Adapter, consult the README.1ST files in the root directories of your TURBOWAYS 25 diskettes:

For the ATMAID diskette, you can select the README button on the first panel of the ATMAID program.

For the device driver diskettes, you can use any text editor to access the README file.

The files contain important information that was not available when this manual was published. You might want to print the README.1ST files so that you can refer to them while you are installing the adapter.

You will find the following information in the README.1ST files:

- · Any limitations and restrictions
- · Last-minute information updates

The README.1ST files also contain a summary of the directories and files on the diskette.

Files on the CD-ROM

The TURBOWAYS 25 ATM ISA Adapter CD-ROM contains the following files:

- The STARTCD program, which is in the Root directory
- The code:
 - Individual directories for all platforms supported by the TURBOWAYS 25 ATM ISA Adapter, for example, <DOS> and <WINNT> directories
 - The <DISKETTE> Directory contains all the diskette images supported by the TURBOWAYS 25 ATM ISA Adapter, for example, TURBOWAYS 25 ATM ISA Adapter Classical IP driver Diskette.
- The viewable and printable documentation, which is in the <PUBS18> Directory
 - The <SHELVES> Subdirectory, containing the master bookshelf and bookshelf search index
 - The <BOOKS> Subdirectory, containing all the viewable books

 The <PUBPRINT> Subdirectory, containing all PostScript and ASCII printable files

Accessing the CD-ROM

To access the CD-ROM, perform the following steps:

- 1. Insert the CD-ROM in your CD-ROM drive.
- Go to a Windows DOS box or to native DOS. At the DOS prompt, type d:startcd (where d is the CD-ROM drive). Press Enter. This will activate the STARTCD program.
- 3. The Welcome panel appears. Select PCI for the bus.
- 4. The Main panel appears. From this panel you can select the following action items:
 - [1] Create install programs for various operating systems
 - [2] List diskette images for the adapter
 - [V] View the documents
 - [P] Print the documents

From the Main panel select Action Item [1], **Create install programs for various operating systems**, and continue with the following panels to complete the installation of the TURBOWAYS 25 Adapter.
