Producer Lifecycle and Credential Management provides a single platform that insurance customers can use for producer and agency onboarding, producer and agency administration, producer self-service, hierarchy management, credential management, and credential validation.

This guide is intended for administrators who are installing and configuring Producer Lifecycle and Credential Management.

## Chapter 1. Installation overview

The IBM® Producer Lifecycle and Credential Management installation package contains the files that you need to install and configure the application as well as the rules and processes required to run workflows.

Producer Lifecycle and Credential Management is run as a Microsoft Windows service. After you configure the service to point to your database, you must start the Producer Lifecycle and Credential Management service.

The workflow rules and processes used by Producer Lifecycle and Credential Management must be imported into JBoss Drools Guvnor.

---

### Installation preparation

Before you install IBM® Producer Lifecycle and Credential Management, you must download the software that is required to run the application.

You must create an empty database for Producer Lifecycle and Credential Management by using Microsoft SQL Server. The first time that you log in to the application, the default tables and reference data are loaded into the database.

To run workflow and business rules in Producer Lifecycle and Credential Management, you must download and deploy JBoss Drools Guvnor and JBoss jBPM Designer on your web application server. These two applications work together as the workflow rules engine for the Producer Lifecycle and Credential Management application.

To review an up-to-date list of environments supported by Producer Lifecycle and Credential Management, such as operating systems, browsers, web servers, database servers, and application servers, see Software Requirements (<http://www.ibm.com/support/docview.wss?uid=swg27047461>)

### Pre-installation checklist

Before you can open the IBM® Producer Lifecycle and Credential Management application, you must download and install the software that is required to run the application.

You must install the following products:

#### **JBoss Drools Guvnor 5.5.0**

This is required to store workflows and business rules used in Producer Lifecycle and Credential Management.

#### **JBoss jBPM Designer 2.4**

This integrates with the Guvnor application to add and edit workflows used in Producer Lifecycle and Credential Management.

#### **Web application server**

This is used to deploy the Guvnor and Designer WAR files. Some examples of a web application server include Apache Tomcat, WebSphere®, and JBoss.

## Oracle Java™ Software Development Kit or Java Runtime Environment or Java Development Kit 8.0

This is required to run the web server application.

## Microsoft SQL Server 2008 R2 or 2008 SP3 or 2012

This is required to create and store the database used by Producer Lifecycle and Credential Management.

After you install and configure the required software, you can install IBM® Producer Lifecycle and Credential Management.

## Installing Java 8

To use Java 8 with IBM® Producer Lifecycle and Credential Management and Guvnor, you must update some configuration settings in both applications.

### Procedure

1. Install Java 8 on the server.

**Note:** If you are running different versions of Java on the server, you can override the wrapper.conf file to use the absolute path reference to Java 8.

- a. Open the wrapper.conf file and change the **wrapper.java.command** parameter to the full path of Java 8.

For example, type `wrapper.java.command = C:\Program Files\Java\jre1.8.0_66\bin\java.exe`

Escape any slashes as in the following example: `wrapper.java.classpath.1 = .\lib\*.jar`

2. Update the Guvnor library by performing the following steps:
  - a. Download the ecj-4.4.2.jar file from the following link:  
<http://mvnrepository.com/artifact/org.eclipse.jdt.core.compiler/ecj/4.4.2>
  - b. Stop the Drools service on Tomcat 6.
  - c. Go to Tomcat 6 on the server.
  - d. Go to %APACHE\_LOCATION%\webapps\drools-guvnor\WEB-INF\lib.
  - e. Delete the ecj-3.5.1.jar file.
  - f. Copy the ecj-4.4.2.jar file into the folder.
  - g. Start the Drools service on Tomcat 6 again.
  - h. Run Build Package.
3. Change any "switch" statements to "if" statements.

If there are any Drools rules that utilize the "switch" statement, they must be updated to use an "if" statement. In version 2.0.3, the core rules have been updated. Make sure any user-defined rules are also updated.

## Installing Microsoft SQL Server

You must install Microsoft SQL Server and create a database for IBM® Producer Lifecycle and Credential Management.



## About this task

**Important:** If at any time you restart the database server, you must also restart the IBM PLCM service. If the IBM PLCM service is not restarted, an error message is displayed in the Producer Lifecycle and Credential Management application.

## Procedure

1. Go to the Microsoft website (<http://microsoft.com>) and download Microsoft SQL Server 2008 R2.
2. Install the software.
3. In SQL Server Configuration Manager, under **SQL Server Network Configuration > Protocols for MSSQLSERVER**, make sure that **TCP/IP** protocol is enabled.
4. In SQL Server Configuration Manager, under **SQL Server Network Configuration > SQL Server Services**, make sure that the **SQL Server Browser** service is running.
5. If you made changes in SQL Server Configuration Manager, restart the server.

## What to do next

You must use Microsoft SQL Server Management Studio to create a database for Producer Lifecycle and Credential Management.

## Database creation

You must create a database in Microsoft SQL Server to store data for the IBM<sup>®</sup> Producer Lifecycle and Credential Management application.

When you create the database, you must add a user identifier that is used only by the Producer Lifecycle and Credential Management application to access the Producer Lifecycle and Credential Management tables. The application user identifier must have administrator rights to the Producer Lifecycle and Credential Management database.

To manage environments when there are multiple Producer Lifecycle and Credential Management databases on the same database server, you can name each database PLCM and add a suffix that indicates the type of environment that is contained in the database. For example, you can name your development database PLCM\_DEV and your production database PLCM\_PROD.

There is no initial size required for the Producer Lifecycle and Credential Management database; however, do not restrict the database to a specific size.

## Microsoft SQL Server database permission requirements

IBM<sup>®</sup> Producer Lifecycle and Credential Management does not require administrative access to the database server, but database ownership rights must be granted in order to access your database.

When you create a database to be used by Producer Lifecycle and Credential Management, make sure that Producer Lifecycle and Credential Management is set up as the database owner (dbo). If it is not possible to grant dbo rights, a user with the following minimum permission requirements must be added:

- Connect
- Create table

- Create view
- Execute
- Select
- Delete
- Insert
- Update
- View database state

**Important:** Granting Producer Lifecycle and Credential Management dbo rights is preferred.

## Installing JBoss Drools Guvnor

JBoss Drools Guvnor must be installed and deployed to configure workflows and business rules for IBM® Producer Lifecycle and Credential Management.

### Procedure

1. Go to the JBoss website (<http://download.jboss.org/drools/release/5.5.0.Final/guvnor-distribution-5.5.0.Final.zip>).
2. Download JBoss Drools Guvnor 5.5.0.
3. Rename the JBoss Drools Guvnor WAR file that matches your application server to `drools-guvnor.war`.
4. Deploy the WAR file on your application server.

### What to do next

By default, Guvnor does not enforce a password check. To enforce authentication, you must configure Guvnor to use an appropriate user directory. For more information, see the Guvnor documentation at <http://docs.jboss.org/drools/release/5.5.0.Final/drools-guvnor-docs/html/ch14.html>.

You must install JBoss jBPM Designer to integrate with JBoss Drools Guvnor.

## Installing JBoss jBPM Designer

JBoss jBPM Designer integrates with JBoss Drools Guvnor and is used to add and edit processes for IBM® Producer Lifecycle and Credential Management.

### Procedure

1. Go to the JBoss website (<http://sourceforge.net/projects/jbpm/files/designer/designer-2.4/>).
2. Install JBoss jBPM Designer 2.4.
3. Rename the WAR file `designer.war`.
4. Deploy the `designer.war` file on your application server.

### What to do next

Open JBoss Drools Guvnor and create a package to store the workflows and business rules for Producer Lifecycle and Credential Management. The workflows and rules files that are used in Producer Lifecycle and Credential Management must be imported after you set up JBoss Drools Guvnor and jBPM Designer.

## Installing the IBM Producer Lifecycle and Credential Management software

After you install and configure the required software, you can install IBM® Producer Lifecycle and Credential Management.

### Procedure

1. Double-click the Producer Lifecycle and Credential Management setup.exe file.
2. Follow the steps in the installation wizard.

### Results

The Producer Lifecycle and Credential Management installation files are saved to your computer.

## Installation files

The IBM® Producer Lifecycle and Credential Management application comes with several installation files.

The release folder contains the files that are necessary to configure and run the application and to set up rules and workflows in Drools Guvnor. These workflows and rules are used by Producer Lifecycle and Credential Management.

Table 1. Installation files.

Installation file name	Description
installService.bat	This service must be started to log into the application.
PLCMObjects.jar	This file contains the objects used by Producer Lifecycle and Credential Management rules and processes and must be imported into Drools Guvnor.
PLCMRules.dr1	This file contains the rules and processes required for Producer Lifecycle and Credential Management workflows and must be imported into Drools Guvnor.
<plcm workflow>.bpmn2 files	These files contain the workflows required by Producer Lifecycle and Credential Management and must be imported into Drools Guvnor.



---

## Chapter 2. Service configuration

The IBM® Producer Lifecycle and Credential Management service must be configured to point to your database and Guvnor before you can open the application.

In addition to configuring access to the database, you can configure the `application.conf` file to complete the following tasks:

- set the default language
- configure mail settings
- configure settings for the License Metric report

You can also configure the `wrapper.conf` to complete the following tasks:

- initiate SSL
- set memory space

You must install the new version of the IBM® Producer Lifecycle and Credential Management Windows service to upgrade the application.

---

## Configuring access to your database

You must configure the IBM® Producer Lifecycle and Credential Management Windows service to point to your Microsoft SQL Server database.

### Before you begin

Make sure that you have created a Microsoft SQL Server database.

### Procedure

1. Navigate to the following location: `C:\IBM PLCM\plcmservice\conf`

**Important:** This is the default location. If you installed Producer Lifecycle and Credential Management to another location, the file path is different.

2. Open the `application.conf` file.
3. Configure the `db.sql.url` value to point to your database.

**Important:** If you have special characters in any of the following values, you must comment out the special characters by using double quotation marks ("). For example, if your password is `s3cr*t`, type `s3cr"*t` as the value.

You must edit the following values:

#### SERVER\_ADDRESS

The host name of the computer where Microsoft SQL Server is installed.

- 1433** The default Microsoft SQL Server port. You might need to edit the port number if you connect to a named instance. Use Microsoft SQL Server Configuration Manager to check the port number.

**databaseName**

The name of the database that you created for Producer Lifecycle and Credential Management in Microsoft SQL Server.

**instance**

The name of your Microsoft SQL Server instance.

4. Set the **db.sql.user** value to the user who has access to the Microsoft SQL Server account that has appropriate rights to access the database.
5. Set the **db.sql.password** value to the password of the user who has access to the Microsoft SQL Server account that has appropriate rights to access the database.
6. Save the file.

**What to do next**

You must start the Producer Lifecycle and Credential Management service for the changes to take effect.

---

## Configuring access to JBoss Drools Guvnor

To store workflows and rule definitions that are used by IBM<sup>®</sup> Producer Lifecycle and Credential Management, you must configure access to JBoss Drools Guvnor.

**Before you begin**

You must download and install JBoss Drools Guvnor 5.5.0 and deploy it by using a web application server. In Guvnor, you must create a package to store the workflows and rule definitions for Producer Lifecycle and Credential Management.

**Procedure**

1. Navigate to the following location: C:\Program Files\IBM PLCM\plcmervice\conf

**Important:** This is the default location. If you installed the application to another location, the file path is different.

2. Open the application.conf file.
3. In the Drools configuration section, edit the following values:

**rules.packageURL**

This value must point to the JBoss Drools Guvnor package binary that contains the workflows and rule definitions for Producer Lifecycle and Credential Management. To find the value, in Guvnor, select the package you created, click the **Edit** tab, and view the URL next to the **URL for packaging binary** link.

**rules.PoJoModelURL**

This value must point to the URL to download the model set. This value must be configured to reload rules in Producer Lifecycle and Credential Management. To find the value, in Guvnor, select the package you created, click the **Edit** tab, and view the URL next to the **POJO Model** link.

**rules.ChangeSetURL**

This value must point to the URL for the change set. This value must be configured to reload rules in Producer Lifecycle and Credential

Management. To find the value, in Guvnor, select the package you created, click the **Edit** tab, and view the URL next to the **Change Set** link.

#### **rules.user**

This is the user who has access to the package that contains the workflows and rule definitions for Producer Lifecycle and Credential Management. By default, this is admin. If you changed the default authentication of Guvnor, use the user ID that you configured instead.

#### **rules.password**

This is the password of the user who has access to the package that contains the workflows and rule definitions for Producer Lifecycle and Credential Management. By default, this is admin. If you changed the default authentication of Guvnor, use the password that you configured instead.

4. Save the file.

### **What to do next**

You must restart the Producer Lifecycle and Credential Management Windows service for the changes to take effect.

---

## **Configuring the language**

You can set the language that is used in the IBM® Producer Lifecycle and Credential Management application.

### **About this task**

If you specify two or more languages in the configuration file, the language that is used is based on the browser's language. The following languages are available:

- English: en
- German: de-DE
- Spanish: es-ES
- French: fr-FR
- Italian: it-IT
- Japanese: ja-JA
- Brazilian Portuguese: pt-BR
- Chinese Simplified: zh-CN
- Chinese Traditional: zh-TW

To update the reference data that comes with the Producer Lifecycle and Credential Management application to the specified language, you must run the appropriate script file.

### **Procedure**

1. Navigate to the following location: C:\IBM PLCM\plcm\service\conf

**Important:** This is the default location. If you installed Producer Lifecycle and Credential Management to another location, the file path is different.

2. Open the application.conf file.
3. Set the **application.langs** value to the language that you want to display in the application.

4. Save the file.

## What to do next

To update the reference data that comes with the Producer Lifecycle and Credential Management application, you must run the appropriate language script. The language script files can be found on the IBM Client Success Portal (<https://varicent.support.ibmcloud.com>). You must restart the Producer Lifecycle and Credential Management service for the changes to take effect.

---

## Configuring mail settings

For IBM® Producer Lifecycle and Credential Management to automatically send emails to users, mail settings must be configured.

### Before you begin

Obtain the details of your company's mail server from your system administrator.

To enable emails in Producer Lifecycle and Credential Management, see “Enabling email notifications” on page 20.

### Procedure

1. Navigate to the following location: C:\Program Files\IBM PLCM\plcmservice\conf

**Important:** This is the default location. If you installed the application to another location, the file path is different.

2. Open the application.conf file.
3. Edit the following section:

```
# EMAIL configuration
clientName="<name>"
smtp.host="<localhost>"
#All below parameters are optional for Email configuration
smtp.port=<25>
smtp.ssl=<no>
smtp.tls=<no>
smtp.user="<user name>"
smtp.password="<secret>"
```

4. Save the file.

### What to do next

You must restart the Producer Lifecycle and Credential Management service for the changes to take effect.

---

## Configuring the migration delimiter

You can set the delimiter that is used in exported migration files in the IBM® Producer Lifecycle and Credential Management application.conf file.

### Procedure

1. Navigate to the following location: C:\IBM PLCM\plcmservice\conf

**Important:** This is the default location. If you installed Producer Lifecycle and Credential Management to another location, the file path is different.



2. Open the `application.conf` file.
3. Set the `migration.column.delimiter` value to the delimiter that you want to use between columns in exported files.  
This can be a character or set of characters. The delimiter must be unique. It cannot exist in any of the data being exported or imported.
4. Save the file.

## What to do next

You must restart the Producer Lifecycle and Credential Management service for the changes to take effect.

---

## License metric tracking

License metric tracking is enabled by default in IBM® Producer Lifecycle and Credential Management, which tracks metrics relevant to the licensing policy such as the number of administrator users and the number of active agencies, branches, and producers. This information helps determine if the current usage of Producer Lifecycle and Credential Management is within license entitlement levels and can prevent potential license violations.

License tracking details are gathered by specifying configuration properties in the `application.conf` file, and the data that is gathered is displayed in the License Consumption Report that is saved in the following directory: `C:\IBM\PLCM\plcmservice\logs`.

## Configuring your license tracking details

You can set the configuration properties to gather data that relates to license terms for the IBM® Producer Lifecycle and Credential Management application.

### About this task

License metric tracking is enabled by default.

### Procedure

1. Navigate to the following location: `C:\IBM\PLCM\plcmservice\conf`

**Important:** This is the default location. If you installed Producer Lifecycle and Credential Management to another location, the file path is different.

2. Open the `application.conf` file.
3. Navigate to the License Metric Settings section.
4. You can specify the following configuration properties, which enable administrators to gather the required data:

Configuration property	Description
<code>license.metric.enable</code>	Set the value to <code>false</code> if you do not want to collect license metric data.
<code>license.metric.scheduledTime</code>	Set the time at which you want the metric values to be generated everyday. The time must be set in the following format: <code>hh:mm:ss</code>
<code>license.metric.plcm.dir</code>	Set the absolute source directory.

Configuration property	Description
<code>license.metric.output.dir</code>	Set the location (relative directory) to which the IBM Software License Metric Tag files are saved.
<code>license.metric.logger.file.size</code>	Set the maximum size of the SLMT file.
<code>license.metric.logger.file.number</code>	Set the maximum number of SLMT file outputs per software instance.

5. Save the file.

## What to do next

You must start the Producer Lifecycle and Credential Management service for the changes to take effect.

## Integration with IBM License Metric Tool

IBM® Producer Lifecycle and Credential Management generates IBM Software License Metric Tag (SLMT) files. Versions of IBM License Metric Tool that support IBM Software License Metric Tag can generate License Consumption Reports. Read this section to interpret these reports for Producer Lifecycle and Credential Management.

By default, the IBM Software License Tag files are saved in the following directory: `C:\IBM\PLCM\plcm\service\logs`. For more information about configuring SLMT file settings, see “Configuring your license tracking details” on page 11.

Each Producer Lifecycle and Credential Management instance generates an IBM Software License Metric Tag file. The values in the file are refreshed every 24 hrs by the Batch Processor. The following metrics are monitored:

### Connection

The **Connection** metric can have the following subtypes:

#### FINRA

This metric displays a value of "1" if the Producer Lifecycle and Credential Management application is connected to FINRA. If there is no connection, a value of "0" is displayed.

#### NIPR

This metric displays a value of "1" if the Producer Lifecycle and Credential Management application is connected to NIPR. If there is no connection, a value of "0" is displayed.

### Authorized User

The number of advanced business users who have security authorizations to configure reference data, workflow queues, and user-defined fields or user-defined sections in Producer Lifecycle and Credential Management.

### Eligible Participant

The number of distinct PartyIds configured with active eligible product records that are being tracked on the current system day.

---

## Changing the name of the cookie

You can change the name of the IBM® Producer Lifecycle and Credential Management cookie that is stored in your web browser. This enables you to connect to multiple Producer Lifecycle and Credential Management instances if you have given each instance a unique cookie name.

## Procedure

1. Navigate to the following location: C:\IBM PLCM\plcm\service\conf

**Important:** This is the default location. If you installed Producer Lifecycle and Credential Management to another location, the file path is different.

2. Open the application.conf file.
3. Set the play.http.session.cookieName value to a unique name for this instance.

---

## Configuring SSL settings

### **NIPR integration**

If you have a contract with NIPR, Producer Lifecycle and Credential Management can integrate directly with NIPR. Real-time calls are made from Producer Lifecycle and Credential Management to the NIPR Producer Database to obtain license and appointment data. Producer Lifecycle and Credential Management sends requests for new appointments and termination of appointments and receives files of license renewals, revocations, suspensions, alerts, and other license or appointment changes.

### **FINRA integration**

If you subscribe to the FINRA webEFT Form Filing service, Producer Lifecycle and Credential Management can submit files with U4, U4 Amendment, and U5 forms to FINRA. Data from FINRA, such as exam results, exam windows, and state registrations, can be uploaded.

### **DTCC integration**

If you subscribe to the DTCC service and receive DTCC Training Update and Training Expiration records from external firms, Producer Lifecycle and Credential Management can upload continuing education, appointment, contract, and producer details received from DTCC.

### **CMIS integration**

If you have a CMIS document management system or other third party management system, you can configure Producer Lifecycle and Credential Management to store any uploaded documents in the document management system.

---

## Customizing the application branding

Home office users can customize the IBM® Producer Lifecycle and Credential Management application banner.

### **Procedure**

1. Click **System Operations > System Config Settings**.
2. On the **Theme** tab, click the **Edit** icon.
3. Click **Browse** to upload an image that you want to display on the application banner.

<b>Payment Type</b>	The payment type that is associated with the <b>Payment Account Identifier</b> field.
<b>NIPR FTP Server</b>	This is required to access the state appointment files from NIPR.
<b>NIPR FTP Username</b>	The user name used to log in to the NIPR FTP server.
<b>NIPR FTP Password</b>	The password used to log in to the NIPR FTP server.
<b>Inbound File Directory</b>	The name of the directory for inbound files.
<b>Outbound File Directory</b>	The name of the directory for outbound files.
<b>Alert Service URL (Host part)</b>	URL for alert service. Required to receive alerts from NIPR.

Configuring your country code sets the format of producer names in Producer Lifecycle and Credential Management tables. Also, when adding or editing producer names on the **Producer Details** tab, the middle name and suffix fields are not displayed if the country is set to Japan or China. Any other language setting results in the default behavior.

Configuring your country code also sets the available fields when adding an address for a producer. For example, setting your country to Canada (CAN) ensures that the **Province** and **Postal Code** fields are displayed when adding or editing an address.

1. Go to **System Operations > System Config Settings**.
2. Click the **Operations** tab.
3. Click **Edit**.
4. From the **Operations Configuration Indicator** drop-down list, select **Yes**.
5. In the **Sync Workspace Folder** field, type the name of the folder that is used for synchronization with Incentive Compensation Management.
6. Click **OK**.

## Chapter 4. Workflow and rule configuration

The workflows and rules that are required to run IBM® Producer Lifecycle and Credential Management must be imported into JBoss Drools Guvnor and configured to work the Producer Lifecycle and Credential Management application.

Workflows are required to run processes in Producer Lifecycle and Credential Management, such as the initiation of producer onboarding. The workflows contain business rules.

### Related tasks:

“Installing JBoss jBPM Designer” on page 4

JBoss jBPM Designer integrates with JBoss Drools Guvnor and is used to add and edit processes for IBM® Producer Lifecycle and Credential Management.

---

## Workflow descriptions

Several workflows are included as part of the IBM® Producer Lifecycle and Credential Management release.

The following list outlines the descriptions of the workflows that are included with your Producer Lifecycle and Credential Management release:

### **plcm.AgencyTermination**

This workflow is invoked when an authorized home office user selects to terminate an agency or agency contracts. It processes the agency termination, terminates all active contracts associated with the agency, and sends email notifications of the agency termination. This workflow can be modified to send agency termination messages to downstream systems that require real-time notifications.

### **plcm.CancelOnboardingKit**

This workflow is invoked when an agency manager or home office user selects to cancel the onboarding of a new agent. It can be modified to send cancellation messages to downstream systems that require real-time notifications.

### **plcm.CompleteContinuingEducation**

This workflow is invoked when an active producer submits a continuing education renewal course, such as general annuity training and long term care training, that is routed to the home office user for review and approval. If the producer is pending and submits the course during the onboarding process, this workflow is not invoked.

### **plcm.CompleteEOCoverage**

This workflow is invoked when an active producer submits an errors and omissions policy renewal that is routed to the home office user for review and approval. If the producer is pending and submits the errors and omissions data during the onboarding process, this workflow is not invoked.

### **plcm.CompleteOnboardingKit**

This workflow is invoked when a producer submits an onboarding kit. The workflow determines routings for review and approval, creates workflow tasks, and sends email notifications to the first reviewer. This workflow can be modified to send messages of pending producers to downstream

systems that require real-time notifications. If you use the pre-hire feature, the workflow is modified to call background check web services to initiate the background check.

**plcm.InitiateOnboardingKit**

This workflow is invoked when a home office user or agency manager creates a new producer or new producer contract. It assigns contract and producer codes, assembles the onboarding kit, and sends emails and alerts to the producers to notify them to complete their onboarding kits.

**plcm.InitiateOnboardingDualContract**

This workflow is invoked when a new contract that requires dual contract approval is created.

**plcm.NodeAssignmentChange**

This workflow is invoked whenever a node assignment is added, deleted, or updated.

**plcm.ProducerEndSuspendLOA**

This workflow is invoked when a home office user or agency manager reactivates a producer who has been suspended or was on a leave of absence. This workflow can be invoked by the manageProducerLifecycle web service to automatically start when a producer meets production requirements during the suspension period. This workflow reactivates the producer and sends email notifications of the reactivation. It can be modified to send a message of reactivation to downstream systems that require real-time notifications.

**plcm.ProducerReinstate**

This workflow is invoked when a home office user selects to reinstate a terminated producer. It processes the reinstatement and sends email notifications of the restatement. This workflow can be modified to send messages of reinstatement to downstream systems that require real-time notifications.

**plcm.ProducerSuspendLOA**

This workflow is invoked when a home office user or agency manager suspends a producer or starts a leave of absence for a producer. It can also be invoked from the manageProducerLifecycle web service and can be automatically started when a producer does not meet production requirements. This workflow processes the suspension or leave of absence and sends email notifications. It can be modified to send messages of the suspension or leave of absence to downstream systems that require real-time notifications.

**plcm.ProducerTermination**

This workflow is invoked when a home office user or agency manager terminates a producer or terminates one or more producer contracts. It can also be invoked from the manageProducerLifecycle web service and can be automatically started when a producer does not meet production requirements. This workflow processes the termination and sends email notifications. It can be modified to send messages of the termination to downstream systems that require real-time notifications.

**plcm.ReviewContinuingEducation**

This workflow is invoked when a home office user approves continuing education renewals or courses submitted by an active producer. It records the approval of the course, updates the continuing education status and credential summary of the producer, and sends email notifications of rejections back to the producer.

### **plcm.ReviewDualContractRequest**

This workflow is invoked whenever the user submits an action from one of the following dual contract tasks: Review Dual Contract Request or Transfer to New Agency.

### **plcm.ReviewEOCoverage**

This workflow is invoked when a home office user approves errors and omission coverage renewals submitted by an active producer. It records the approval of the errors and omission coverage and sends emails of rejections back to the producer.

### **plcm.ReviewOnboardingKit**

This workflow is invoked when an agency manager or home office user completes a review of an onboarding kit. It updates the status of the onboarding kit.

- If it is approved, the workflow executes rules to determine the next reviewer of the onboarding kit, generates workflow tasks, and sends emails to the reviewers. If there are no additional reviewers, the workflow activates the onboarding kit.
- If it is pending rejection, the workflow sends email notifications that include instructions for appealing the rejection based on credit score information, which is needed for the Fair Credit Reporting Act compliance.
- If it is rejected, the workflow sends email notifications to the producer.
- If it is canceled, the workflow sends email notifications.
- If it is returned for resubmission, the workflow creates alerts and sends email notifications to the producer to resubmit the onboarding kit.

This workflow can be modified to send notifications of the activation, rejection, or cancellation to downstream systems that require real-time notifications. It can also be modified to call background check vendor web services to initiate the background check after the agency manager has completed the review.

### **plcm.backgroundCheckResults**

This workflow is invoked for each background check result that is received in a file from an external vendor. It sends a notification that the results have been received to home office analysts so that they can review the results.

### **plcm.eAcknowledgment**

This workflow is invoked when there is a contract change to an active contract. It determines whether additional electronic acknowledgments must be signed and generates alerts and email notifications to the party who needs to electronically acknowledge the contract change.

---

## **Importing rules**

After you install JBoss Drools Guvnor and jBPM Designer, you must create a package in Drools Guvnor. This is required to import the workflows rules for IBM® Producer Lifecycle and Credential Management.

### **Before you begin**

Make sure you have installed JBoss Drools Guvnor, JBoss jBPM Designer, and Producer Lifecycle and Credential Management.

## Procedure

1. Open JBoss Drools Guvnor.
2. In the **Knowledge Bases** section, click **Create New > New Package**.
3. Select the **Import from drl file** option.
4. Click **Browse** and navigate to the location to which you saved Producer Lifecycle and Credential Management during the installation.  
By default, it is located in the following directory: C:\IBM PLCM\guvnor-imports\rules.
5. Select the PLCMRules.drl file.
6. Click **Import**.  
By default, this creates a package that is called plcmPkg that contains all the rules required for Producer Lifecycle and Credential Management workflows.
7. Click **File > Save Changes**.

## What to do next

You must upload the file that contains the business objects that are used in the workflows for Producer Lifecycle and Credential Management.

---

## Importing workflow objects

Use JBoss Drools Guvnor to upload the objects that are required by IBM<sup>®</sup> Producer Lifecycle and Credential Management workflows.

## Before you begin

Make sure that you have installed JBoss Drools Guvnor, JBoss jBPM Designer, and Producer Lifecycle and Credential Management.

## Procedure

1. Open JBoss Drools Guvnor.
2. In the **Knowledge Bases** section, click **Create New > Upload POJO Model jar**.
3. Leave the **Create new** option selected.
4. Give the model a name.
5. Leave the **Create in Package** option selected.
6. Click **OK**.
7. Click **Browse** and select the PLCMObjects.jar file located in your installation folder.  
By default, it is located in the following directory: C:\Program Files\IBM PLCM\guvnor-imports
8. Click **Upload**.  
The objects in the JAR file are imported into Drools Guvnor.
9. Click **File > Save and Close**.
10. Click **Check In**.

## What to do next

You must import the file that contains the processes that are used in Producer Lifecycle and Credential Management.

---

## Importing processes

Use JBoss Drools Guvnor to upload the processes that are required for IBM® Producer Lifecycle and Credential Management.

### Before you begin

Make sure that you install JBoss Drools Guvnor, JBoss jBPM Designer, and Producer Lifecycle and Credential Management.

### Procedure

1. Open JBoss Drools Guvnor.
2. In the **Knowledge Bases** section, click **Create New > New BPMN2 Process**.
3. Leave the **Create new** option selected.
4. Give the process a name, such as the name of the workflow that you are importing.
5. Leave the **Create in Package** option selected.
6. Make sure that the package that you created is selected in the list.
7. Click **OK**.  
This creates an empty process.
8. Click **Tools > Import from BPMN2**.
9. Click **Browse** and select the .bpnm2 file that is located in the Producer Lifecycle and Credential Management installation folder.  
By default, the files are located in the following directory: C:\Program Files\IBM PLCM\guvnor-imports\workflows. Make sure that you select the file that matches the process name.
10. Click **Import**.
11. Click **File > Save and close**.
12. Click **Check in**.
13. Import each process in the folder in the same way.

---

## Configuring workflows

Use JBoss Drools Guvnor to build a package to create a snap shot that IBM® Producer Lifecycle and Credential Management can access.

### Before you begin

On the **Edit** tab, make sure that you save the changes to the package and click the **Validate configuration** button.

### Procedure

1. Open JBoss Drools Guvnor.
2. Open the package that contains the Producer Lifecycle and Credential Management rules.
3. Click **File > Save**.
4. On the **Edit** tab, click **Build package**.
5. Note the **URL for package binary** link.
6. Navigate to the application.conf file.

By default, it is located in the following directory: C:\Program Files\IBM\PLCM\plcmService\conf.

7. In the Drools configuration section, edit the following value to match the **URL for package binary** link that you noted in step 4:  
rules.packageURL="http://localhost:8080/drools-guvnor/rest/packages/plcmPkg/binary"
8. Save the application.conf file.
9. Restart the Producer Lifecycle and Credential Management Windows service.

---

## Reloading rules

In IBM® Producer Lifecycle and Credential Management, you can reload rules and workflows.

### About this task

When you reload rules, the JAR file that has been imported into Guvnor is read and imported into Producer Lifecycle and Credential Management. If the rules are reloading while a user requests access to rules, the old rules are run until the reloading is complete.

You must have the appropriate permissions to perform this task and settings must be configured in the application.conf file. For more information on configuring the settings to reload rules, see "Configuring access to JBoss Drools Guvnor" on page 8.

**Note:** You must not rename the plcmObjects.jar file when uploading it into Guvnor. If this file is renamed, the rules cannot be initialized.

### Procedure

Go to **System Operations > Reload Rules**.



---

## Chapter 5. Authentication and sign-on

Various communication and authentication options are available when you configure Open SSO or LDAP for IBM® Producer Lifecycle and Credential Management authentication.

---

### Single sign-on configuration

IBM® Producer Lifecycle and Credential Management supports single sign-on authentication through an identity provider. When single sign-on is configured, users can log in to one system and gain access to multiple systems.

If you are not logged in to Producer Lifecycle and Credential Management and single sign on (SSO) is configured, then the application checks to see if you are logged in to the identify provider (IdP). If you are not logged in to the IdP, the IdP redirects you to the SSO page to log in.

If you are logged into the SSO provider, then your user name is checked against Producer Lifecycle and Credential Management immediately. If your user name matches, you are granted access to Producer Lifecycle and Credential Management without being required to log in.

When you log out of Producer Lifecycle and Credential Management, a log out request is sent to the IdP that logs you out of the application and invalidates the Producer Lifecycle and Credential Management session. This also logs you out of any other application that you are logged in to using the SSO system.

### Generating and extracting your own keystore

If the communication between the IdP and IBM® Producer Lifecycle and Credential Management must be encrypted, you must create a keystore and generate private and public keys for Producer Lifecycle and Credential Management to access the IdP.

#### Before you begin

You must create a keystore and a private and public key that Producer Lifecycle and Credential Management can use to encrypt requests to the IdP. You can create a keystore with the Java Keytool utility that comes with any standard JDK distribution.

#### Procedure

1. Open the command prompt window with administrator rights and switch the directory to the location of the Java Keytool utility.

For example, type the following text: `cd C:\Program Files\Java\jre1.8\bin`

2. Generate a keystore file and a public and private key by typing the following command in the command prompt window: `keytool -genkeypair -alias <alias-name> -keypass <your-password> -keystore <keystore-file>`

For example, type `keytool -genkeyair -alias ibm-plcm -keypass changeit -keystore ibmplcm-keys.jks`

The keystore file is saved in the same directory as you typed in step 1.

3. Extract the public key that is used by the IdP to decrypt requests from Producer Lifecycle and Credential Management by typing the following command in the command prompt window: `keytool -export -keystore <keystore-file> -alias <alias-name> -file <public-key-file>`

For example, type `keytool -export -keystore ibmplcm-keys.jks -alias ibm-plcm -file ibm-plcm-public.cert`

The public key is saved in the same directory as you typed in step 1.

## Configuring single sign-on

Single sign-on via Security Assertion Markup Language (SAML) can be configured for use with the IBM® Producer Lifecycle and Credential Management application.

### Before you begin

Single sign-on is initiated by a Service Provider, which is Producer Lifecycle and Credential Management. You must have an Identify Provider installed, such as Siteminder, PingFederate, or OpenAM. A keystore is required for generating digital signatures. You must set up a keystore and configure it on the Identity Provider (IdP). Open SSO provides a default test key for testing purposes. This key should not be used in production.

### Procedure

1. Navigate to the following location: `C:\IBM PLCM\plcm-service\conf`

**Important:** This is the default location. If you installed Producer Lifecycle and Credential Management to another location, the file path is different.

2. Open the `application.conf` file.
3. In the `#SAML Settings` section, configure the following values .:

Parameter	Description
<code>auth.useSAML</code>	Set the value to <b>true</b> .
<code>auth.baseUri</code>	Configure the value to point to the URL that you use to access Producer Lifecycle and Credential Management. The IdP must be able to access this link from the IdP server.  <b>Note:</b> OpenAM requires that you use fully qualified domain names when protecting web resources.

Parameter	Description
<b>auth.failUrl</b>	To redirect users to a login page after a failed SAML login attempt, you can configure this value  This parameter is used when a SAML user, who has successfully authenticated with their SAML identity provider, attempts to access Producer Lifecycle and Credential Management. If there is no matching security user in Producer Lifecycle and Credential Management, the user is redirected to the URL set by the <b>auth.failUrl</b> value. If no value is configured for this parameter, the user is redirected to the Producer Lifecycle and Credential Management failed login page, which includes a link to log out of the SAML SSO system.
<b>auth.idp.type</b>	Set this value to the appropriate IdP name, such as "siteminder" or "openam". This value is only used for audit table purposes.
<b>auth.idp.url</b>	Configure this value to point to the IdP metadata link.
<b>auth.idp.params.id</b>	Do not change this setting.
<b>auth.sp.jks.path</b>	Configure this value to point to the directory where the <code>ibmplcm-keys.jks</code> file is located. For more information, see "Generating and extracting your own keystore" on page 35.
<b>auth.sp.jks.pw</b>	Set this value to the password for the keystore. For more information, see "Generating and extracting your own keystore" on page 35.
<b>auth.sp.jks.entryid</b>	This value is set to <code>ibm-plcm</code> and should not change.
<b>auth.sp.jks.entrypw</b>	Set this value to the password for the keystore. For more information, see "Generating and extracting your own keystore" on page 35.
<b>auth.timeskew</b>	Set this value to the maximum allowable time skew for checking expiring times from the IdP. This value should be relatively conservative.

4. Save the file.

## What to do next

You must start the Producer Lifecycle and Credential Management service for the changes to take effect.

## Setting up access for the Identity Provider

To set up access to IBM® Producer Lifecycle and Credential Management for the Identity Provider (IdP), you must generate a metadata export file to import into the IdP.

### Procedure

1. Log in to Producer Lifecycle and Credential Management as the admin user.
2. Generate a metadata export file by typing the following text into your browser's address field: `http://<<PLCM URL>>/PLCM/sso/metadata`
3. Provide the IdP team with the following information:
  - The generated metadata export file. This file is imported into the IdP tool.
  - The `ibm-plcm-public.cert` public key. This is required if the communication between Producer Lifecycle and Credential Management and IdP is encrypted. The public key is imported into the IdP system.
4. The IdP team performs the following steps:
  - a. Import the Producer Lifecycle and Credential Management metadata export file into the IdP tool. This sets up everything that is required by the IdP to access Producer Lifecycle and Credential Management and creates an adapter that Producer Lifecycle and Credential Management can use to access the IdP.
  - b. Provide the URL of the adapter created in the IdP that Producer Lifecycle and Credential Management can use to verify credentials.
  - c. If the IdP encrypts the SAML header, a public key that Producer Lifecycle and Credential Management can use to decrypt the SAML header is provided.

### What to do next

In the `application.conf` file, set the `auth.idp.url` value to the URL of the adapter created in the IdP for Producer Lifecycle and Credential Management. You must restart the Producer Lifecycle and Credential Management service for the changes to take effect.

Single sign-on via Security Assertion Markup Language (SAML) can be configured for use with the IBM® Producer Lifecycle and Credential Management application.

## Importing the public key into the keystore

If the SAML header is encrypted by the IdP, you must import the public key of the IdP provider into the IBM® Producer Lifecycle and Credential Management keystore. This is used by Producer Lifecycle and Credential Management to decrypt the SAML header.

### Procedure

1. Open the command prompt window with administrator rights and switch the directory to the location of the Java Keytool utility.  
For example, switch to the following directory: `C:\Program Files\Java\jre1.8\bin`
2. Import the public key from IdP to the keystore by typing the following command in the command prompt: `keytool -importcert -alias <alias-name> -file <public-key-file> -keystore <keystore-file>`

For example, if the Siteminder team provided a file called siteminder-public.cert, then type `keytool -importcert -alias siteminder-public -file siteminder-public.cert -keystore ibmplcm-keys.jks`

---

## Configuring LDAP authentication

IBM® Producer Lifecycle and Credential Management can use LDAP to define access to the application. The system calls LDAP with the user identifier and password and receives a message if the authentication is successful.

### Procedure

1. Navigate to the following location: `C:\Program Files\IBM PLCM\plcm-service\conf`

**Important:** This is the default location. If you installed the application to another location, the file path is different.

2. Open the `application.conf` file.
3. In the LDAP configuration section, edit the following values:

Parameter	Description
<code>ldap.server</code>	The location of your LDAP server.
<code>ldap.domain</code>	The domain of your LDAP server.
<code>ldap.port</code>	The port on which your LDAP server runs.

4. Save the file.

### What to do next

You must restart the Producer Lifecycle and Credential Management Windows service for the changes to take effect.



---

## Chapter 6. Upgrade

You can update the IBM® Producer Lifecycle and Credential Management application with the latest features.

You must take the following steps to upgrade your application:

1. Back up your database.
2. Save your application.conf and wrapper.conf files.
3. Run the Model Upgrader tool to update your database.
4. Uninstall the previous Producer Lifecycle and Credential Management Windows service.
5. Install the latest Producer Lifecycle and Credential Management Windows service.

---

### Microsoft SQL Server database backup and restoration

A database backup duplicates all the data that is contained in the IBM® Producer Lifecycle and Credential Management database and creates a copy of the full database.

You can then recreate the entire database in one step by using the restore command. The restored database is an exact match of the database at the time the backup completed.

#### Backing up a database

You can use Microsoft SQL Server Enterprise Manager to back up an IBM® Producer Lifecycle and Credential Management database.

##### Procedure

1. Open Microsoft SQL Server Enterprise Manager.
2. Click **Tools > Backup Database**.
3. Select one of the following **Backup Types**:

##### Complete backup

Makes a full backup of your database. You will almost always need to start your backup strategy with a full backup of your database.

##### Differential backup

Stores all changes that have occurred to the database since the last full backup.

4. You can edit the backup file destination.

By default, the backup file is stored in the following location: C:\Program Files\Microsoft SQL Server\MSSQL\BACKUP\.

**Tip:** The database can remain online and accessible to users while the backup is created.

#### Restoring a database backup

In the backup file, Microsoft SQL Server stores the names and locations of the files used in the IBM® Producer Lifecycle and Credential Management database. After

the database is restored, SQL Server recreates all the necessary files and the database is restored to the point in time that the backup finished.

### Procedure

1. Open Microsoft SQL Server Enterprise Manager.
2. Click **Tools > Restore Database**.

The **Restore as Database** field is the name of your newly restored database. The name does not have to be identical to the name of the original (backed up) database.

3. To define your restoration parameters, select the original database name and the stored backup that you want to restore.

## Using backup and restore to transfer databases between servers

You can restore a backup of an IBM<sup>®</sup> Producer Lifecycle and Credential Management database on a new server by creating a backup of a database and saving it to a location that is accessible from the server where you are performing the restoration.

### Procedure

1. From the server that you want the database transferred to, open Microsoft SQL Server Enterprise Manager.
2. Click **Tools > Restore Database**.
3. Type the name that you want the database to be restored with in the **Restore as database** field.
4. Select the **From device** option.
5. Select **File name** and type the location of the backup file.

---

## Upgrading with Java 8

If you have both Java 7 and Java 8 installed on your computer, you must ensure the `upgrader.jar` file is associated with Java 8 before upgrading your IBM<sup>®</sup> Producer Lifecycle and Credential Management database.

### About this task

The `upgrader.jar` file is compiled with Java 8 and cannot run with Java 7. If you have both installed on your computer, you can run the `upgrader.jar` file from the command line or associate the `upgrader.jar` with your Java 8 installation.

### Procedure

1. To run the Model Upgrader tool from the command line, first check the Java version by typing the following command: `java -version`. Then perform one of the following steps:
  - If the Java version is 1.8, then you can run the Model Upgrader tool by typing the following command: `java -jar "path to upgrader.jar"`
  - If the Java version is 1.7, then you can run the Model Upgrader tool by typing the following command: `"C:\Program Files\Java\jre1.8.0_66\bin\javaw.exe" -jar "path to upgrader.jar"`
2. To make sure that you can run the Model Upgrader tool by double-clicking the `upgrader.jar` file, you must point the following registry keys to your Java 8 installation:



- HKEY\_CLASSES\_ROOT\jarfile\shell\open\command
- HKEY\_LOCAL\_MACHINE\SOFTWARE\Classes\jarfile\shell\open\command

---

## Upgrading the database

Use the Model Upgrader tool to upgrade your IBM® Producer Lifecycle and Credential Management database so that it is compatible with the upgraded version of the application.

### About this task

If your database and service are not running on the same version of Producer Lifecycle and Credential Management, a message is displayed on the log in screen that indicates that an upgrade is required.

### Procedure

1. In your release folder, double-click the Upgrader.jar file.
2. In the **Database URL** field, enter the URL of the database server that contains the database that you want to upgrade.
3. In the **Schema Name** field, enter the type of database to which you want to connect.
4. In the **Database Name** field, enter the name of the database that you want to upgrade.
5. In the **User Name** and **Password** fields, enter the login credentials of the user who has permission to alter the database.
6. Click **Connect**.
7. Select the **Roll back all upgrade on failure** check box to roll back the version to the last successful upgrade if the upgrade fails.
8. Click **Upgrade**.

---

## Upgrading the application

You must install the new version of the IBM® Producer Lifecycle and Credential Management Windows service to upgrade the application.

### Before you begin

Run the uninstallService.bat file. By default, it is located in the following directory: C:\Program Files\IBM PLCM\plcm\service\service installer

### Procedure

1. Install the new Producer Lifecycle and Credential Management Windows service.
2. Edit the application.conf and wrapper.conf files to match the saved files from the previous version.

The IBM® Producer Lifecycle and Credential Management service must be configured to point to your database and Guvnor before you can open the application.

#### appointment

The right to sell or service the products of a specified insurance carrier in a state.

#### authorization

#### corporate producer

An external corporation that is contracted to sell a carrier's products.

#### credential

A course, certificate, or regulatory license that is required by either the insurance carrier or a government regulator to sell an insurance product.

---

### D

#### database (DB)

A collection of interrelated or independent data items that are stored together to serve one or more applications.

**DB** See database.

---

### H

#### hierarchy

The organization of a set of entities into a tree structure, with each entity (except the root) having one or more parent entities and an arbitrary number of child entities.

### I

#### individual producer

An independent broker who is contracted to sell a carrier's products or an employee of an insurance carrier who is responsible for selling a carrier's products.

---

### L

#### license

A certificate of authorization that permits an individual to sell insurance products in a state.

#### line of authority (LOA)

The range of insurance products that a producer is allowed to sell under a license.

**LOA** See line of authority.

### N

**node** Any element in a tree.

---

### O

#### onboarding

An approach to equipping new employees and socially integrating them into an organization.

#### onboarding kit

The forms that a new employee must complete in order to set up a contract with an insurance carrier.

### **parameter (parm)**

A value or reference passed to a function, command, or program that serves as input or controls actions. The value is supplied by a user or by another program or process.

**parm** See parameter.

### **producer**

An individual or organization who sells the products of an insurance carrier.

### **sub-producer**

An employee of an external corporation who is contracted to sell a carrier's products.

---

## W

**WAR** See web archive.

### **web archive (WAR)**

A compressed file format, defined by the Java EE standard, for storing all the resources required to install and run a web application in a single file.

### **workflow**

The sequence of activities performed in accordance with the business processes of an enterprise.
