

# System z S/W Technical Account Management

#### What is it?

Like the old "IBM SE" Role

Regular pro-active technical engagement (i.e. not a sales engagement)

- An assigned System z S/W Technical Sales team member
- •NOT a replacement or bypass of the standard IBM support service/process

### Why?

Assists with System z issues, provides general System z-related advice and guidance, technical enablement and conduit to rest of local IBM System z team ... and beyond

•Has been requested by customers and is recognised within IBM as a "value add" service

#### Can I have one?

Yes, but you may have one already !





### System z S/W Customer Advocacies

#### What is a Customer Advocacy?

Part of the IBM "Unleash the Labs" initiative

•A valued relationship between the customer and a product development lab

Is a "window" into a product to assist with the customer's use of a product

•An enhanced point of contact for consultancy and advice relating to a product and a conduit for the customer to provide general feedback (but not a requirements gathering mechanism)

#### What is a product Advocate?

- •Typically a member of the product lab (e.g. an architect, developer, tester etc.)
- Has an understanding of the product strategy and the product portfolio

Is NOT a technical expert on every aspect of the product portfolio, but has a network within the product team and can leverage that





### System z S/W Customer Advocacies – Contd.

#### For which products do IBM offer a Customer Advocacy?

•The major z/OS Subsystems and selected program products

•Current focus is on CICS, IMS and zSecure Suite

# z/OS Security Health-check

### Highlights ...

A no-charge 2-day onsite engagement

 Provides customer with a better understanding of their current enterprise compliance and risk posture based on the existing security controls of one z/OS environment

 Designed to detect configuration conflicts and exposures in the Trusted Computing Base and Privileged Users and their ability to bypass RACF/CA-ACF2 security controls or cause risk of system crash

 Also highlights conditions that may represent, at a high-level, significant security risks or potential compliance failures

- •Undertaken by a System z Security specialist and utilizes the IBM Security zSecure Suite
- •Major deliverable is a report detailing findings, conclusions and recommendations

### CICS TS Developer Trial v4.2

### Highlights ...

CICS TS Developer Trial v4.2 is a 'try-before-you-buy' edition of CICS TS v4.2.

- It has a zero cost licence charge (\$0 OTC IPLA, + \$0 OTC S&S)
- It does not initiate any Single Version Charging (SVC) period
- Can be reordered as many times as a customer wants (the \$0 S&S provides entitlement)

CICS TS Developer Trial is designed for customers who want to...

- assess the value that could be gained from a CICS TS upgrade, prior to making an upgrade decision
- evaluate the latest CICS TS capabilities, in a non-production environment
- 'kick the tyres' before committing resources to a full production migration project
- conduct Proof of Technology (PoT) evaluations on the complete set of CICS TS v4.2 capabilities

•CICS TS Developer Trial v4.2 has the same capabilities as the full CICS TS v4.2.

- It can be used to evaluate how the latest capabilities in CICS TS v4.2 can be further enhanced and augmented with the latest capabilities of other IBM offerings, including those from the Rational, Tivoli, WebSphere and Information Management brands.
- Customers are encouraged to deploy the CICS TS Developer Trial v4.2 into their Rational Developer for System z UT environments, so their CICS application developers can explore the latest features of CICS in a dedicated, low-cost System z environment.

#### • CICS TS Developer Trial has a number of imposed technical and non-technical restrictions:

#### - Licensing Terms and Conditions:

- It is designated as "Non-Production"
- It can only be deployed as part of an internal development and test environment for non-production activities.

#### - Technical restrictions:

- Although all the latest features and capabilities are provided, there are performance and capacity restrictions.
- These are designed to significantly limit the overall workload that can be run in the system at any given time.

#### - Fixed expiry date:

- The offering will providing at least 90 days operation from the date of fulfilment.
- · New releases can be installed to extend this period.
- There is no limit to the number of times CICS TS Developer trial can be reordered, installed and used.

#### - Program support restrictions:

- Formal program support is not provided with CICS TS Developer Trial.
- Support enquiries can be submitted via a IBM developerWorks forum.
- Updated releases containing the latest service fixes, will be made available by IBM periodically.

 New Analyzer component – Interactive browser-based UI connects direct to z/OS-based Analyzer – generate asset spreadsheets via batch jobs

 Benefits from TADz S/W discovery can be achieved in the first week and ROI increases with continual usage monitoring

Reduce the risk of unexpected outages (e.g. see who would be impacted by a s/w upgrade, see which products a job is using, see where different maintenance levels are deployed etc.)

 Avoid license compliance violation penalties and plan for mergers, acquisitions and strategic outsourcing

 TADz Proof-of-concept – customer collects raw data (only takes 2-4 hours) and sends it to IBM to import into TADz database. Possible to show results the next day if lab resources have been booked in advance (tadz@au1.ibm.com)
