Chapter 1. Overview




Figure 1. CICS Universal Client for OS/2 to CICS TS through TCP62

The sample configuration shown in Figure 1 consists of a CICS Universal Client for OS/2 Version 3.1 connecting to CICS Transaction Server for OS/390 Version 1.3. Communication is through TCP62 provided with the IBM Communications Server for OS/2 on the client workstation and AnyNet® provided with VTAM on the mainframe server.

To understand how TCP62 works, refer to the CICS Universal Client Administration book for your platform, and to Revealed! CICS Transaction Gateway with More CICS Clients Unmasked.

For the sample configuration we chose to autoinstall an LU6.2 parallel connection rather than define a static definition. Combined with the ability to dynamically create VTAM logical units (LUs) and control points (CPs), autoinstall is advantageous as it enables you to use the same CTG.INI configuration file for all workstations without having to define multiple entries in VTAM and CICS.

Although we used the CICS Transaction Server for OS/390 Version 1.3 for the sample configuration, you could use earlier versions of the CICS Transaction Server for OS/390, or CICS/ESA Version 4.1.

Chapter 2. Software checklist

The levels of software we used in the sample configuration are not necessarily the latest levels available. Check the relevant products for levels of compatible software.

We used the following software on the CICS server:

- OS/390 Version 2.6
 - Includes VTAM Version 4.5
 - Includes AnyNet feature
 - Includes IBM TCP/IP for OS/390
- CICS Transaction Server for OS/390 Version 1.3

We used the following software on the client workstation:

- OS/2 Version 4 (workstation version FixPak 6)
- Communications Server for OS/2 Version 5.0 + APAR JR11589 within FixPak CSA5018
- CICS Universal Client for OS/2 Version 3.1
- Java Runtime Environment (JRE) Version 1.1.8 for OS/2 (necessary for running the configuration tool and other tools.)

Matching definitions

Chapter 5. Sample configuration

In this section we present examples of each of the definitions mentioned in "Chapter 3. Definitions checklist" on page 5. The values highlighted in the figures refer to the Example column of Table 1 on page 7.

OS/390 TCP/IP

The TCP/IP address and hostname are defined to the OS/390 TCP/IP in the PROFILE.TCPIP and TCPIP.DATA data sets. For the sample configuration, 9.20.101.6 is the TCP/IP address of our OS/390 system, and winmvs26 is our TCP/IP hostname. Refer to *IBM TCP/IP MVS: Customization and Administration Guide Version 3.2* for more information about configuring TCP/IP on OS/390.

AnyNet

In this section we present the AnyNet definitions for the server.

TCP Major Node

Figure 2 shows the TCP Major Node definition used in our configuration. The TCP Major Node defines the AnyNet interface between TCP/IP and VTAM. This definition specifies the domain name suffix, DNSUFX , and the TCP protocol port number that VTAM uses to support SNA sessions over an IP network. All nodes that establish SNA sessions over an IP network must use the same port number. The default value is 397 and has been registered with the Internet Activities Board (IAB).

Refer to VTAM AnyNet Guide to SNA over TCP/IP for more information about AnyNet.

CDRSC definitions

The CDRSC defines the remote client and instructs VTAM to route any session requests through the TCP/IP physical unit (PU). In our sample configuration we dynamically generated CDRSC definitions through a key and template defined in the client configuration, (see "Dynamic CP name generation" on page 19). Therefore you do not have to define a CDRSC major node.

VTAM

In this section we present the VTAM definitions for the server.

DYNLU

To dynamically allocate CDRSC definitions, specify DYNLU=YES as a startup option for VTAM. This parameter saves you the need to define multiple static CDRSC definitions within VTAM. The CDRSC names are dynamically generated from the **CP name** and **IP address mask for CP name** client configuration settings, along with the IP address of the client machine. See "Dynamic CP name generation" on page 19 for more details.

NETID

You specify the NETID **2** for VTAM in your VTAM start procedure. For the sample configuration, specify NETID=GBIBMIYA.

APPL

Figure 3 shows the VTAM APPL **3** definition required for the sample configuration. Because TCP62 supports only LU6.2 parallel sessions, specify PARSESS=YES.

LogMode

CICS Transaction Server for OS/390

In this section we present the definitions for the CICS Transaction Server for OS/390.

System Initialization Table parameters

Figure 5 shows the SIT parameters to enable intersystem communication (ISC) and to define the CICS region APPLID.

Autoinstall of LU6.2 connection

The autoinstall control program, DFHZATDY, is used in conjunction with the APPC autoinstall template for parallel sessions secondary (CBPS) to dynamically create an LU6.2 connection. The same program also automatically releases and uninstalls the connection once all sessions are released. By default, the CPBS sessions definition, found in group DFHAI62, uses a blank modename. As groups that start with DFH should not be altered, we copied this group as AXHAI62, altered the CBPS definition to have a modename of LU62PS 4, and changed the MAXIMUM sessions option to Max(8,1). The second value in the number of sessions specifies that the CICS server is to have one contention winner only. This value is for CNOS (change number of sessions) purposes and to enable START requests to be initiated by the server to the client. A value of 1 is recommended to ensure that START requests are shipped serially from the server to the client and thereby avoid committing all available sessions to START requests.

Figure 6 shows our altered APPC autoinstall template for parallel sessions.

To activate autoinstall control program DFHZATDY, you can issue the CICS CEMT command shown in Figure 7.

Communications Server for OS/2

This section describes how to define your values to Communications Server for OS/2 for our sample configuration.

We recommend that you use a new configuration file because adding values to an existing configuration file may cause conflicts with existing values.

To configure Communications Server for OS/2 as in our example:

- 1. Run Communications Manager Setup from the IBM eNetwork Communications Server folder.
- 2. Click on **Setup...** to get to the Open Configuration panel and then enter a name for your new configuration file. We used the name **TCP62**.
- 3. On the Communications Manager Configuration definition TCP62 panel select **Options**.




Figure 9. Communications Server for OS/2 Configuration definition - TCP62

- 4. From the **Options** pull-down select **Configure any profile or feature...** (see Figure 9).

- 5. On the Communications Manager Configuration List select **SNA local node characteristics** and then **Configure...**




Figure 10. Communications Server for OS/2 Local Node Characteristics

- 6. Enter your Network ID **2** and a unique Local node name, and select **OK**. The Local node name must be unique on the network. You can make this

meaningful to the end user. Figure 10 shows the values we entered.

- 7. On the Communications Manager Configuration List select **AnyNet base** parameters and then **Configure...**.




Figure 11. Communications Server for OS/2: AnyNet Parameters

- 8. Enter your SNA domain name suffix 1 . If this configuration is to be used for TCP62 communication only, select the **Default routing preference of Non-native only**. If this configuration is to be used for TCP62 and SNA communication, select **Non-native first**. In our sample configuration we used only TCP62 communication. Figure 11 on page 15 shows the values we entered.

9. After you have entered all of your Communications Server for OS/2 definitions, select **Close** on each window to exit. Communications Server for OS/2 verifies your values and reports any errors in your configuration in a pop-up window.

CICS Universal Client for OS/2 Version 3.1

You use the CICS Universal Client's configuration tool to define the settings for TCP62 communication. The configuration tool generates the CTG.INI file, which is located in the \bin subdirectory. The CICS Universal Client uses the CTG.INI file to establish a connection to a CICS server.

For information on using the configuration tool, refer to your *CICS Universal Client Administration* book.

You need to define the following **Server** configuration settings, (see Figure 14 on page 18 and Figure 15 on page 20).

Server name

An arbitrary name for a particular CICS server.

Description

An arbitrary description for the CICS server.

Network protocol

The protocol for communication with the CICS server, in this case, TCP62.

Partner LU name 2.3

The LU Name of the server as it is known to the APPC configuration at the CICS Universal Client. This must be a qualified 17-character name, as in our example, GBIBMIYA.IYCQCTS5.

Local LU name or template

The name of a local LU to be used when connecting to the server. You can enter a real LU name or a template for the name of a local LU to be used when connecting to the CICS server.

If you enter a template, you must fill in the **IP address mask for LU** name template field.

See "Dynamic LU name generation" on page 19 for more information.

IP address mask for LU name template

An IP address mask in most-significant-byte-first order. This must be a hexadecimal number, as in our example FFFFFF80.

Mode name 4

The mode name to be used when connecting to the server.

The settings on the Common TCP62 settings tab are as follows:

Fully qualified CP name or template

A fully-qualified CP name, or a template for the fully-qualified CP name, of the node to be started.

If you enter a template, as in our sample configuration, you must fill in the **IP address mask for CP name (optional)** field.

See "Dynamic CP name generation" on page 19 for more information.

IP address mask for CP name

An IP address mask in most-significant-byte-first order. This must be a hexadecimal number, as in our example FFFF8080.

Anynet domain name suffix 1

The AnyNet domain name suffix. This parameter is used with the partner (Partner LU name) to determine the IP address of the host associated with that LU.

On the **Advanced TCP62 settings** tab you can leave the settings with their default values.

The *CICS Universal Client Administration* book and the configuration tool's online help provide descriptions of the configuration settings for CICS Universal Client.




Figure 12. TCP62 settings in configuration tool




Figure 13. Common TCP62 settings in configuration tool

The CICS Universal Client Administration book for your platform provides definitions of the parameters in the CTG.INI file.

Dynamic LU name generation

With dynamic name generation for the Local LU name, you can use the same CTG.INI file on all client machines because different Local LU names are generated on the basis of the IP address of the client machine. Therefore you do not have to define multiple LUs within VTAM.

In our configuration, the Local LU name of CTS5AH** indicates that a name must be dynamically generated to replace the two template replacement characters, that is, asterisks (*). Using the Local LU name, IP Address Mask, and the workstation IP address, the algorithm creates a Local LU name of CTS5AH38. If several hundred clients will be using dynamic LU name generation to connect to the server, you should have more template replacement characters in your Local LU name, for example, CTS5****.

Dynamic CP name generation

You can dynamically generate CP names with an algorithm similar to that for dynamic LU name generation (see "Dynamic LU name generation"). Using the CP name, IP address mask for the CP name, and the workstation IP address, a CP is dynamically generated within VTAM. Therefore you do not have to define multiple CPs to VTAM. In our configuration the CP name of GBIBMIYA.CP62**** indicates that a name must be dynamically generated to replace the four template replacement characters, that is, asterisks (*). If several hundred clients will be using dynamic CP name generation, you should have more template replacement characters in your CP name, for example, GBIBMIYA.CP******. The NETID 2 must not contain any template replacement characters.

TCP/IP HOSTS file

In this section we present the definition required for the TCP/IP HOSTS file. The definition maps the IP address of the OS/390 system to the generated IP name. The IP name is generated by concatenating the NetName 3, the Network name 2, and the DomainNameSuffix 1.

Figure 15 on page 20 shows the TCP/IP HOSTS file definition we used for our configuration. Note the order of the parameters. The IP address of the OS/390 system is first. After one or more spaces, the NetName 3 precedes the Network 2 name, which in turn precedes the DomainNameSuffix 1.

Chapter 6. Testing your configuration

After you have installed and configured all relevant products for the sample configuration, we recommend that you:

- 1. Start the CICS Transaction Server for OS/390.
- 2. Check that autoinstall control program DFHZATDY is available (see "Autoinstall of LU6.2 connection" on page 11).
- 3. Start Communications Server for OS/2.
- 4. Start the CICS Universal Client for OS/2 using the CICSCLI /S=CICSTS13 command. (CICSTS13 is the name of server in the client configuration, see Figure 14 on page 18.)
- 5. Check the status of the CICS Universal Client, using the CICSCLI /L command. The connection status to the CICS server should show "Available."
- 6. Issue the CICSTERM /S=CICSTS13 command to install a terminal on the CICS Transaction Server for OS/390.
- 7. Run a CICS server transaction, for example, CEMT or CECI.
- 8. Problems?
 - Check that the Subsystem Management services are started. The Subsystem Management icon is found on the Administration folder of Communications Server for OS/2.
 - Check that your AnyNet logical link is active. From Subsystem
 Management select **Details**, **SNA subsystem**, and **Logical links**.




Figure 16. Communications Server for OS/2: AnyNet Logical Link

 Figure 16 shows our AnyNet logical link to be active with three active sessions.

In the sample configuration, the CTG.INI definition dynamically creates an LU with netname CTS5AH38, and sample autoinstall control program

Testing your configuration

DFHZATDY dynamically creates a connection name of AH38 by using the last characters of the netname. The CICS server CEMT command displays the netname and connection dynamically created and CBPS, the autoinstall template for parallel sessions (see Figure 17).

Chapter 7. Security implementation

To provide the necessary security for your CICS regions, CICS Transaction Server for OS/390 uses the MVS SAF to route authorization requests to an External Security Manager, such as RACF, at appropriate points within CICS transaction processing. There are many types of security available, from transaction security to CICS resource security. The CICS Transaction Server for OS/390 provides the following security mechanisms for the APPC environment:

- Bind-time (or session) security prevents an unauthorized connection between CICS regions.
- Link security defines the authority of the remote system to access transactions or resources to which the connection itself is not authorized.
- User security checks that a user is authorized both to attach a transaction and to access all resources the transaction requires.

For CICS Universal Clients connecting to the CICS Transaction Server for OS/390, you may want to consider configuring link security.

Preparing link security for our sample configuration

For link security on incoming ECI, EPI, and CICSTERM requests, CICS Transaction Server for OS/390 needs the following settings in the SECURITY section of the connection definition for the client:

SEcurityname = HOLLING (RACF-authorized TSO ID)

ATtachsec = Verify

Usedfltuser = Yes for signon incapable terminals;

= No for signon incapable terminals, see

"Signon capable terminals".

In addition, you must specify SEC=YES as a SIT override.

Signon capable terminals

Security checking done in the server for transactions started at a signon capable terminal installed by a Client application does not depend on what is specified by the **ATtachsec** option for the connection representing the Client. Instead security checking depends on whether the user signs on while using the terminal.

Security implementation

If the user does not sign on, the Client installed terminal is associated with the default user defined for the server in the SIT. When a transaction is run, the security checks are carried out against this default user. A check is also done against the userid associated with the connection to see whether the Client itself has authority to access the resource.

When a user does sign on, the terminal is associated with the userid just authenticated. For transactions attempting to access reosurces, security checking is done against the userid associated with the connection and the signed-on user's userid.

It is recommended that the **Usedfltuser** parameter on the server connection definition is set to Yes if using signon capable terminals and to No if using signon incapable terminals.

Running CICS Universal Client applications with link security

To establish a connection between the CICS Universal Client and CICS Transaction Server for OS/390 issue the CICSCLI /S=server command as described in see "Chapter 6. Testing your configuration" on page 21. Link security is initiated when the first ECI, EPI, or CICSTERM request is made on a newly established connection.




Figure 18. Example of CICS Universal Client security pop-up window

If you have not provided a userid and password, CICS Universal Client may request that you enter a valid userid and password in a security pop-up window (see Figure 18).

For more information about the circumstances under which security pop-ups are displayed, see the CICS Universal Client Administration book.

To prevent the security pop-up window from appearing you can:

- Specify the CICSCLI /C /U /P options to assign a userid and password to each request sent to the server specified by the /C option.
- Pass the userid and password in the ECI parameter block.

Security implementation

- Specify the CICSCLI /N option to suppress all pop-ups. In this case a security error is returned to the ECI, EPI, or CICSTERM request.
- Ensure that **Enable popups** is not selected in the client configuration.
- Set a default userid and password using the ESI function CICS_SetDefaultSecurity.

Chapter 8. Useful commands and utilities

You will find the commands discussed in this section useful during installation and configuration.

TSO VTAM commands from SDSF

The following commands are entered from system display and search facility (SDSF) on TSO:

Display TCPIP status

The display command, d tcpip, indicates whether TCP/IP is active (see Figure 19).

Figure 19. SDSF: Display TCPIP status

Display AnyNet PU state

The display command, d net,id=any1pu,e, shows the state of the AnyNet PU (see Figure 20 on page 28). For AnyNet to work, the status must be ACTIV. The following parameters are also of interest: CP NETID 2 shows the network name, DYNAMIC LU=YES confirms that dynamic LU generation is enabled, MAJNOD shows the TCP Major Node, and LOGICAL UNITS: indicates that our dynamically generated LU, CTS5AH38, is active.

Display version of VTAM running

The SDSF command, d net, vtamopts, displays the version of VTAM running on OS/390.

SDSF Vary command

It may be necessary to activate nodes that are currently inactive. The vary commands are similar to the display commands. For example, to vary the TCP Major Node active in our sample configuration, you would issue this SDSF command: v net,act,id=ap26anyn.

TCP/IP Commands

The following commands are entered from a command prompt:

Ping utility

To verify the TCP/IP communication between the client and the server, use the ping utility. You can specify either the IP address or IP name. Figure 25 shows the messages returned from the ping utility when the IP name is specified.
