Connects data, accounts and legal entities from IBM Cognos 8 Controller directly to a solution that delivers XBRL output and reports

Sharing financial performance information with regulators, auditors and others in a form that complies with international standards has become critical as more and more countries mandate greater transparency in financial reporting. XBRL (eXtensible Business Reporting Language) has developed as the worldwide-accepted standard for defining data, business rules and reporting requirements and, as a result, regulator bodies are requiring that reports submitted to them be in XBRL.

Companies that are required to file financial data electronically in XBRL filings must now combine the processes of financial consolidation and corporate reporting with the creation of XBRL output. Although XBRL is very flexible, the standard itself includes more than 1,200 pages of specification. It is not likely that they have the funds or a team of developers with a deep understanding of the standard and many years of hands-on experience to create such a solution.

So, companies need a tool or solution that not only can generate XBRL reports but can also integrate with the close, consolidate and report

solutions they already have in place. IBM Cognos® 8 Controller is the optimum solution for the consolidation and reporting tasks, but can it be extended to enable XBRL output?

With the *XBRL Blueprint*, it can.

The right tool

Delivering financial statement output to legislative and regulatory bodies in XBRL is already required in some countries and others are planning on making it a requirement. The United States, with its large number of companies under the jurisdiction of the Securities and Exchange Commission (SEC), is moving towards mandatory adoption. In fact, the SEC has already mandated the delivery of XBRL filings for quarterly and annual reports.

The *XBRL Blueprint* enables data, accounts and legal entities from IBM Cognos 8 Controller to be connected directly to a solution that delivers XBRL output and reports. Developed with Semansys Technologies, the *Blueprint* extends IBM Cognos 8 Controller to include XBRL reporting. The *Blueprint* is easy to use and manage and can integrate data from multiple sources, including financials, non-financial data and text.

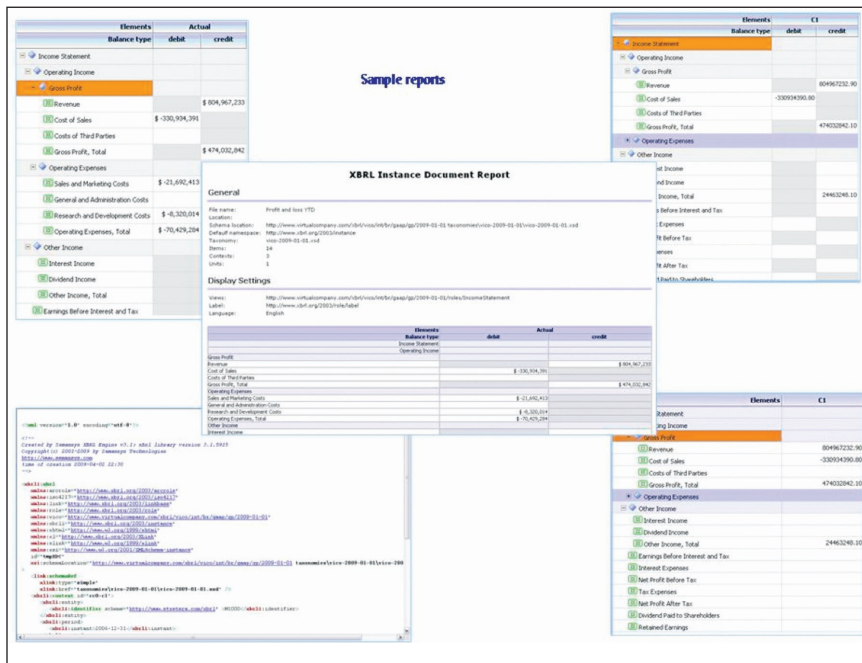
