What this exercise is about

This document describes how to configure WebSphere Partner Gateway to accept a EDI document, deenvelope it, and envelope the resultant transactions and send them to different gateways based on connection profiles

WPG users can be categorized into 3 administrative roles.

Community Operator: The Community Operator is responsible for managing the day-to-day operation of the hub community. Pre-defined user— cannot be deleted. Acts as "sysadmin" for WPG. Defines and maintains the WPG's capabilities. Typically does NOT send or receive documents



Community Participant: External business partners to WPG. Can be as many defined as desired



Community Manager: The Community Manager is the primary driving force within the hub community. Also a participant, but is the principle one. Can only have one Community Manager in WPG. Operational manager for the community



Part 1: Introduction

Objective:

Source partner sends an EDI document with two 850 messages each in a different Group segment. Each of the 850's need to be enveloped using a different Envelope Profile and the enveloped EDI message are to be sent to two different gateways of the Target trading Partner.



This above figure shows an example of the use of Connection profile using a simple example of an EDI envelope that has 2 groups, each containing 1 850 transaction, T1 and T2 as shown in the EDI document. We want to translate T1 to T1` document and T2 to T2` document and apply different attributes. There is one participant connection for the 850 transaction. Using Connection profiles, the administrator can specify different attributes, maps, actions and gateways on the same participant connection.

The connection profile will be used to specify different gateways and envelope profiles on the participant connection. The participant connection will use 2 different connection profiles, CP-1 and CP-2, as shown. The attributes of CP-1 match the 1st group application sender and receiver attributes, namely APP1 and APP2. Similarly, the attributes of CP-2 match the 2nd group application sender and receiver attributes, namely APP3 and APP4.

The attributes and gateways specified for the participant connection for CP-1 will be used for T1 transaction. Whereas, the attributes gateway specified for the participant connection for CP-2 will be the used for T2 transaction.

Hence, connection profiles can be used as part of participant connections to change the attributes, maps, gateways for the document flows using the same participant connection.


Part 7: Create Interactions

For the connection Profiles scenario, we need to create 3 interactions. First interaction for deenveloping the incoming EDI Document to an EDI messages850 in this case), the second interaction for enveloping the incoming EDI message and the third to send the enveloped EDI messages to the Target trading Partner.





Enabled B2B capabilities for a participant define the types of documents the participant will be allowed to send and/or receive. The B2B capabilities for a partner are a subset of the Package, Protocol, and Document Flows that Hub supports.




Community Operator has the privilege for Creating Connection Profiles.




Normal connection lookup is based on Sender and Receiver Partner Id, Gateway type (for example: production or test), source document packaging, protocol and document type. For EDI there is an additional criterion that may be used. This additional criterion is defined in a connection profile, which is then associated with the connection and used when the connection is looked up for a received document. Although there may be only one participant connection available, we can add connection profiles to the participant connection and each connection has have its own set of attributes, gateways etc.

The following steps show how to create a connection profile from WBIC Console





In this section, we configure the Gateways for the ISA channel. This is for the enveloped documents. Two enveloped documents will be generated and they will be routed to two different gateways based on the connection profiles.

Note: File gateways "ManagerFileGateway" and "ManagerFileGateway2" are already created for the destination partner Manager

1.	Go to Participant Connections
2.	For the N/A – EDIX12 – ISA to None – EDIX12 –ISA channel, select "Connection Profile 3" the Active Profiles.
3.	Click on Gateways and select "ManagerFileGateway" in the Target Gateway
4.	Click Save
5.	Similarly, select "Connection Profile 4" from the Active Profiles
6.	Click on Gateways and select "ManagerFileGateway2" in the Target Gateways
7.	Click Save



Part 12: Allow Elements With Duplicate IDs

Each enveloped EDI document has a control number associated with it as part of the ISA segment. The control number is used to uniquely identify the incoming document. In order for us to use the same input document more than once, we need to tell the WPG system that it is ok to allow duplicate control numbers. This is done by setting the "Allow documents with Duplicate id's" attribute to Yes. With out the "Allow documents with Duplicate id's" set to Yes, the WPG would not process the document and throw an error saying that it found an duplicate interchange.

- ____ 1. Go to Hub Admin → Hub Configuration → Document Flow Definition
 - __ a. Click on the icon next to **Package: None**. This should list all the protocols available under **Package:None**.
 - b. Click on icon next to Protocol: EDI-X12 (ALL)
 - __ c. Locate the "Allow documents with duplicate ids" attribute listed under the Document Flow Context Attributes and select "Yes" as the value from the drop down menu.
 - d. Click Save

2.	Open the edi2ediConProf.inp file.
3.	Update the edi2adf.inp for the WPG partner ids. The id's are located at the 7 th and 9 th fields in the ISA segment. The first id is the source ID and the second the target ID

4.	Place the edi2ediConProf.inp in the C:\WPGLabs\edifiletarget\Documents\Production directory.
5.	The EDI document should be de-enveloped into two 850 transactions
6.	The two 850 transactions will be sent for enveloping and they will be enveloped into two separate envelopes
7.	One envelope will be routed to filegateway and the other to filegateway2 for the Manager.
8.	Check the filegateway and filegateway2 under C:\WPGLabs\Manager
9.	On the Document Viewer note that one envelope has the profile attributes for EnvProfile 1 and the other has the attributes for EnvProfile 2 .

The status of the document in the system can be viewed by using the Document Viewer

You will the see the transactions in the Document Viewer.
