

This presentation covers the ESB integration model in practice and provides a simple scenario that highlights the ESB function.



The agenda starts with two approaches to the ESB Integration model in practice, then shows a simple scenario that highlights the ESB function.



In this approach, there is only one mediation module between the service requestor and the provider. The wiring from the requestor to the mediation module, and from the module to the service provider is done by the integration developer. In this approach, the integration developer needs to understand the external interfaces. The system administrator uses the mediation module as is, in the runtime.



In this approach, the mediation module uses only default bindings.

This means that the mediation module can be rewired by the administrator to different other modules.

In the diagram shown, the other modules do not (need to) contain any components, just imports and exports.

The administrator can specify which 'requester' modules (this is an informal term, and in this case refers to the left-hand module) connect to the mediation module.

More than one 'requester' module can be connected to the mediation module.

The solution administrator can also change which (single) 'provider module' (again, an informal term, this time identifying the right hand module) is used.

[For experts: Note that, for asynchronous, one-way operations only, it is possible to connect multiple providers to a single (one-way) import.

Each provider will be sent a copy of the message; since the interaction is one-way, no response will be sent back.

Note that, in ESB 6.0.1, This advanced option requires WebSphere messaging skills]

The next section covers a simple ESB scenario that highlights the ESB function.



The simple Stock Quote scenario is used to highlight the ESB functions.

The scenario includes a simple stock quote service. The service company wants to differentiate itself from its competition by offering tiered levels of service and by proactively offering real-time stocks to their "gold" customers (customers who pay a subscription).

The scenario described in the next page will show how they can use the ESB function to respond in a flexible and non-disruptive way to the changing requirements which are expected to arise.



The simple Stock Quote scenario is used is implemented in several phases:

In the first phase, the service provider uses an external slow stock quote provider, called XQuote in this example, using Web Service, to get delayed stock quotes, rather than real time stock quotes. This may be fine for regular customers, but now the service provider wants to add better real time service for their premium gold customers. The real time quote is provided by another external stock quote provider, called XIgnite in this example. The service provider wants a way to know the type of customer and call XIgnite for premium customers. The mediation services in ESB allow the ability to call different external service providers based on certain criteria, like customer type, that can be determined by mediation services in the ESB.

Additionally, error handling logic can be added to the mediation services for a given request so that the failures can be reported to some business monitoring system, like the WebSphere Monitor.



The first phase of the scenario is shown here, where there is only one external stock quote service provider, namely, XQuote.

The request for a stock quote comes to the service provider into the Bus. The bus in turn makes a call to the external service provider XQuote. The reply is passed back through the bus to the requestor.

[1] As seen from the animation, the request flows through the bus to the external XQuote service provider and the response returns back the same route.



This time, the request when passed through the Mediation Module goes through a mediation primitive that provides the service of logging the request. The primitives are building blocks that process of the service message as it passes through the bus. The primitive used in the scenario is the Message Logger Mediation Primitive to log the message to a database.

The Request continues on its way as before.

[1] As seen from the animation, the request flows through the bus through the mediation module, the message is processed by the Message Logger primitive, where the message is logged into a database. The message than is sent to the external XQuote service provider. The response returns back through the module. In the return path, there are no primitives defined in the module, and therefore the response is sent back to the requestor



In this phase, a premium real time stock quote service, called XIgnite, is provided to the premium gold customers. The ESB mediation module will handle all the logic of incorporating the new service provider. This time, when the request passes through the Mediation Module, a DataBaseLookup Primitive is used to look up the user id in a table of "gold" users, then a Filter primitive is applied to choose between the two paths.

[1] The requestor sends the request to the Bus. The mediation module in the bus receives the service message.

[2] Now a regular non-premium service customer sends a request. The request passes through the Mediation Module and the DataBaseLookup Primitive. Because the customer is not a gold customer, the filter routes the message to XQuote, which is the delayed stock quote provider. The response comes back through the module and is sent back to the non-gold requestor.

[3] Next, a request comes in from a gold customer. The request passes through the Mediation Module and the DataBaseLookup Primitive. The customer is now identified as a gold customer. The message needs to be send to the real time stock quote provider, XIgnite. However, since the XIgnite message format is not the same as what the requestor had sent for XQuote, and since the message format coming from the requestor interface has not been modified for the new service, the bus has to do some transformation to which the interface for the formation of the transform mediation primitive, shown between the transformed message is then sent to XIgnite.
