What is a sizing estimate?

A sizing estimate is an **approximation** of the hardware resources required to support a specific software implementation. It is a pre-sales effort based on information available at a point in time, providing an **entry** into understanding the customer's hardware requirements. Customers' actual experiences will vary from the sizing estimate for many reasons, including batch and reporting workloads, and custom code. The degree of variability can range from small to very significant. IBM assumes no liability for actual results that differ from the sizing estimate.

I. Introduction

Thank you for allowing IBM the opportunity to provide you a sizing estimate for ERP 8.0 or World software from J.D. Edwards running on an IBM eServer platform. We are requesting information in order to arrive at a system recommendation and architecture based on your requirements and business environment. This information will allow us to provide you with an estimation of the processor class, memory, and disk space requirements for your database/enterprise server, and if applicable, Business Function servers, Batch servers, Windows Terminal Servers and HTML servers.

The sizing process initiated by the completion of this Sizing and Planning Questionnaire is called a pre-sales sizing estimate. A pre-sales sizing is based on minimal input and is intended to be a very rough estimate of server resource required to support a given ERP 8.0 or World workload. The accuracy of the sizing estimate is dependent upon many variables such as the accuracy of the information provided by you, the customer, (we recognize that it may be difficult to provide exact numbers on your environment) and the actual usage of the system in a real-time environment. Sizing is an iterative process and the sizing issue should be revisited a number of times during the pre-implementation phase. Performance data gathered during the pilot phase should be used to generate a more accurate estimate of server resources required for a given ERP 8.0 or World workload. Once you are in production, future hardware requirements should be determined through the Capacity Planning process.

In this pre-sales sizing estimate, we will provide to you an estimate of disk space required to support the ERP 8.0 or World database based on the number of users defined in your workload estimate. This will be a very rough estimate, as the disk space required does not always correlate with the number of active users.

Currently we are able to provide pre-sales sizing estimates for a standard World implementation along with two tier implementations and three tier implementations of ERP 8.0. For a description of two tier and three tier implementation options please see the appendix in section VI at the end of this document.

For World only implementations, only sections II, IV B and V need to be filled in.

IV. User Environment

User Counts

Please complete this information as accurately as possible. Be sure not to double count users. Classify users in the application where they spend a majority of their time each day. We are trying to size the database/enterprise server for a peak hour of a day when the most users are online and actively working.

Active users: users are judged to be active if they are clicking the "OK" button or using Fn keys 2 to 3 times a minute. Users that are signed on, but are not actually using the system should not be counted. For this sizing, the number of users reported should be the total number of active users during a peak period.

"Fat" clients: Fat clients are those that have the business application logic running locally on the client.

"Mapped" clients: Mapped clients are those that have some or all of the business application logic mapped to the enterprise server or some machine other than locally.

WTS clients: Those clients which are connected via Windows Terminal Server or Citrix.

HTML/Java clients: Those clients which use a browser interface to connect to ERP 8.0.

Note: Fat clients are not recommended over a Wide Area Network due to bandwidth requirements.

World/WorldVision Active Users: indicates the maximum number of active users of World or WorldVision software. Use the same definition for active user as above.

C. Transaction Information

The standard scripts used to perform the sizing tests and benchmarks process transactions at a high rate. A typical user may not process transactions at the same rate. To assist in accurately accounting for users, please provide transaction rates below. The information required is transaction lines per hour during a peak period. If your peak period is not known then we will account for the peak by taking twice the average.

For example: If a company processes 100,000 sales orders per month, with an average of 5 lines per order. Given a 20 workday month and a 10 hour work day. We would use 100,000 orders x 5 lines per order / 20 days / 10 hours per day = 2500 lines per hour average. To size for a peak period, we would assume twice the average or 5000 lines per hour.

E. Batch production environment

A standard IBM sizing accounts for a significant batch workload, and fits most environments. In certain cases, there are mission critical batch processes that need to be processed at the highest priority. The default assumption if no input is provided to this question is that some capacity for typical batch jobs to execute is reserved, but all critical batch processes will be run overnight or during non-peak interactive users periods. Care should be taken when answering this question since each specified performance critical batch process during the same time period will require an additional processor for the server running the batch processes.

Explanations of some of the above questions:

EDI

Electronic Data Interchange is a method of importing data such as sales orders though a batch process. Documents are transferred from vendors or other sources and converted to ERP 8.0 transactions via the import process. Transaction volumes for sizing purposes are converted to lines per hour, such as sales order lines per hour, which need to be processed during a peak period.

Batch Requirements

UBEs (Universal Batch Engines) are ERP 8.0 batch and reporting processes. Most ERP 8.0 batch processes are CPU intensive. Because of this, running multiple concurrent UBEs on a single processor will cause some degradation in performance of the UBE. Since users generally process at a higher priority, their performance should not be impacted as much. In most environments, this UBE degradation will be acceptable and running more than 1 batch process per processor will provide adequate performance. In some environments there are critical batch processes that must complete in the shortest time possible. In these cases, the system is sized to allow for an extra processor for each concurrent performance critical UBE. Care should be taken in answering the number of critical batch processes. Multiple concurrent critical UBEs will require multiple processors and can quickly drive the cost of the system higher. A standard IBM sizing accounts for a significant batch workload and should suffice in most environments.

Multiple Instances of ERP 8.0

Some circumstances require multiple instances of the ERP 8.0 application running on the same installation. Implementing multiple ERP 8.0 instances requires duplicates of the all ERP 8.0 objects, including database files and application code. Some examples of when multiple ERP 8.0 instances may be required include support for multiple double byte languages or multiple code pages. When multiple instances are required careful customized planning for handling consolidated reporting, merged or

separate file schemes, languages and time zones is needed. Additional disk space must be added to allow for the duplication of files for each instance. Additional servers, such as TSE servers may also be required. To determine if multiple instances are required and the number of instances necessary, contact your J.D.Edwards representative.

High Availability

A highly available system can be implemented using technologies including IBM's HACMP product on the UNIX platform, MIMIX (from Lakeview Corp.), OMS (from Vision Solutions), or Datamirror (from Datamirror Corp.) on the iSeries, or MSCS on the xSeries. In all cases, a second system is required for implementation.

VI. Appendix A – sizing scenarios explanation

Currently we are able to provide pre-sales sizing estimates for two tier implementations and three tier implementations of ERP 8.0. In a two tier implementation, the proposed server functions as the central database server supporting client PCs running ERP 8.0 business logic and the ERP 8.0 user interface. A two-tier implementation of ERP 8.0 is shown below:





Diagram 1. 2-tier

In a three-tier implementation, the business logic (called a Business Function) can be moved from the client PC to the database server, this is known as a virtual three-tier implementation. Alternatively, the Business Function logic can be mapped to an intermediate layer on another system, this is known as a physical three-tier implementation. These two options are shown here:



Support of WAN attached clients with ERP 8.0 is best achieved by using Windows Terminal Server technology or by using the ERP 8.0 HTML / Java client support. These options are shown below:




Diagram 4. Physical 3-tier with Windows Terminal Server




Diagram 5. Physical 3-tier with HTML / Java Clients
