#### Reporting a Problem:

All Clients must have an IBM Client Number (ICN) with current support entitlement to engage RCS EMEA. You can report problems via IBM Service Request ("SR"), email or telephone. A Problem Management Record ("PMR") is opened to track and communicate information on the issue. Authorised clients and IBM staff can track PMRs on the web via SR. When you wish to update or escalate a software problem please ensure you have the PMR number available.

#### **Support Hours:**

Severity 1 24x7 (Important: during Offshift hours, Severity 1 issues **MUST** be raised by telephone)
Severity 2-4 8am to 5pm, local country time, Monday to Friday, public holidays (excluding NYD, 1st January)

#### **Engagement Model:**

SR: Call Back Model - PMR queued directly to RCS, based on product and geography and language

Email: Call Back Model - PMR queued to RCS, based on product and language. To facilitate optimal response,

please provide complete information (see below) within Email.

Phone: Client telephones RCS call center. Call center gather basic information from Client, and create PMR. RCS is

engaged either by Live to Engineer transfer, or call back, depending on Severity of PMR, and whether new or existing issue. Phone is preferred method for Severity 1 issues, and after hours, phone MUST be used for

Severity 1 issues:

Severity 1 — Direct transfer to RCS, all PMR call entries
Severity 2-4 — Call back model for new PMRs creation
Severity 1-4 — Direct transfer to RCS for existing PMR updates

### Always be prepared to provide the following when you submit a PMR

- 7 Digit IBM Client Number (ICN)
- Contact name
- Telephone number where you can be reached
- Description of the issue information
- Severity of the issue (see below)

- Company name
- Preferred means of contact (voice or email)
- Related product and version information
- Related operating system, or database

#### Checking the Severity Level of a PMR

**'Severity'** lets the support team know the impact the problem is having on your business. RCS makes best effort to respond to PMRs within 2 business hours. Agreed Severity 1 issues are worked 24x7, when you are available to do so.

Severity 1 Critical business impact, or system down, This condition requires an immediate solution.

Severity 2 Significant business impact, this indicates the program is usable but is severely limited.

Severity 3 Some business impact, this indicates the program is usable with less significant features.

Severity 4 Minimal business impact
