IBM® Rational® Change is a generic change request management system that is Web-based and integrated with IBM® Rational® Synergy. This chapter provides basic information needed to install Rational Change:

To make your installation easier, a "Worksheet" on page 27 is included in this document. Print a copy of the worksheet, and fill in as much information as possible before installing the product.

## Readme

The <u>Readme</u> contains vital information about your Rational Change software, including information about new features in this release, and a list of the supported hardware and operating systems. Review this information before installing your software. The *Readme* is available on the Rational Software Information Center Web site and on the Documentation section of the DVD that was shipped with Rational Change.

When necessary, the *Readme* is revised and reissued to provide the most current information. To ensure you have the latest version, download an electronic copy from the Rational Software Information Center at <a href="http://publib.boulder.ibm.com/infocenter/rsdp/v1r0m0/index.jsp">http://publib.boulder.ibm.com/infocenter/rsdp/v1r0m0/index.jsp</a>.

### Changes in version 5.2

Telelogic Change is now called IBM Rational Change. Also, if you are upgrading from Telelogic Change 5.1, the feature called Telelogic Change Distributed is now referred to as Rational Change Distributed and is included in the Rational Change product.

### Submitting problems

To submit your problem to IBM Rational Software Support:

1. Determine the business impact of your problem. When you report a problem to IBM, you are asked to supply a severity level. Therefore, you need to understand and assess the business impact of the problem that you are reporting.

Use the following table to determine the severity level.

Severity	Description
1	The problem has a <i>critical</i> business impact: You are unable to use the program, resulting in a critical impact on operations. This condition requires an immediate solution.
2	This problem has a <i>significant</i> business impact: The program is usable, but it is severely limited.
3	The problem has <i>some</i> business impact: The program is usable, but less significant features (not critical to operations) are unavailable.
4	The problem has <i>minimal</i> business impact: The problem causes little impact on operations or a reasonable circumvention to the problem was implemented.

- 2. Describe your problem and gather background information, When describing a problem to IBM, be as specific as possible. Include all relevant background information so that IBM Rational Software Support specialists can help you solve the problem efficiently. To save time, know the answers to these questions:
  - What software versions were you running when the problem occurred?

To determine the exact product name and version, use the option applicable to you:

- Start the IBM Installation Manager and select File > View Installed Packages. Expand a package group and select a package to see the package name and version number.
- Start your product, and click **Help** > **About** to see the offering name and version number.

- What is your operating system and version number (including any service packs or patches)?
- Do you have logs, traces, and messages that are related to the problem symptoms?
- Can you recreate the problem? If so, what steps do you perform to recreate the problem?
- Did you make any changes to the system? For example, did you make changes to the hardware, operating system, networking software, or other system components?
- Are you currently using a workaround for the problem? If so, be prepared to describe the workaround when you report the problem.
- **3.** Submit your problem to IBM Rational Software Support. You can submit your problem to IBM Rational Software Support in the following ways:

## **Terms and Concepts**

To perform the operations described in this guide, you should first understand the following Rational Change terms and concepts:

central CR database	A <i>central CR database</i> contains change requests (CRs) only. These CRs might be associated to tasks in multiple development databases. The central CR database is connected directly to the central server. There is only one central server and one central CR database in a cluster.
central server	A <i>central server</i> stores CRs in the central CR database. Remote development databases and the central server can be linked using remote servers. There should be only one central server. See "Server Modes and Types" on page 15.
change request	A <i>change request</i> is a database object used to track problem or enhancement requests.
development database	A <i>development database</i> contains tasks and objects (as opposed to CRs). It can be connected directly to a central server or indirectly through a remote server. If it is connected to a remote server, it is known as a remote development database.
Jetty Web server	The <i>Jetty Web server</i> is bundled with the delivered product.
local admin user	The <i>local admin user</i> , which replaces the <i>ChangeAdmin</i> user from previous releases, is a special Rational Change user account that is defined during installation. Unlike regular user accounts, the <i>local</i> <i>admin</i> user is authenticated by Rational Change directly, rather than by the IBM® Rational® Directory Server (RDS), and is used to perform certain background activities. See "Installing Rational Change" on page 35.

Rational Synergy back-end session	A Rational Synergy back-end session is used by Rational Change to carry out database operations for each user logged in to Rational Change. Rational Synergy sessions can be run on the Rational Change server machine or any compatible machine on which Rational Synergy is operational.
Rational Synergy database	The Rational Synergy database is a repository of change requests for an installation of Rational Change.
Rational Change Login page	The Rational Change Login page is where you start a Rational Change session.
Rational Change server	The Rational Change server is the machine on which Rational Change is installed. The Rational Change server is also used to represent the Rational Change Web server.
Rational Directory Server	The Rational Directory Server (RDS) performs authentication and stores Rational Change user data.
remote server	A <i>remote server</i> is a proxy between the central server and remote development databases. Multiple remote servers can be associated with the central server. See "Server Modes and Types" on page 15.
stand-alone server	A <i>stand-alone server</i> is a "traditional" server that stores CRs in development databases. See "Server Modes and Types" on page 15.
task	A <i>task</i> represents a unit of work that needs to be done, for example, in your software application. You can associate one or more tasks with a change request. A task includes a description of the unit of work and the user name of the person responsible for completing it. When a change needs to be made, someone in your organization creates a task. If you

	are responsible for making the change, the task is assigned to you within Rational Synergy. After you select an assigned task, objects you check out are associated with that task.
WAS	This is the IBM® WebSphere® Application Server. It is not bundled with the delivered product but can be installed optionally.
WASCE	This is the IBM® WebSphere® Application Server Community Edition. It is not bundled with the delivered product but can be installed optionally.

### **Rational Change server machine**

The following requirements are for the host that will run the Rational Change server.

#### Hardware requirements

The hardware requirements for each host running a Rational Change server are described in the *<u>Readme</u>*.

#### Software requirements

The software requirements for each host running a Rational Change server are as follows:

- One of the supported operating systems must be installed and operational on the server. For information about supported platforms, see the <u>Readme</u>.
- Rational Synergy must be installed and operational. For detailed information about installing Rational Synergy, see the *IBM Rational Synergy Installation Guide for UNIX*®, located in the <u>Rational Software Information Center</u>.
- The IBM® Rational® License Server TL must be installed and operational. For information about the license server, including when and how to install it, see the <u>IBM Rational License Server TL Guide</u>.
- RDS 5.0 must be installed and operational. See the <u>IBM Rational Directory</u> <u>Server Product Manual</u>, or the Help for information about RDS, including when and how to install it.
  - If you are using Rational Change by itself, you can use IBM® RDS 5.0 for Apache, which takes up less disc space and is not as complex to install.
  - If you are using the IBM® Rational® Change for DOORS® Interface, you must use IBM® RDS 5.0 for Tivoli.

For information about upgrading from older versions of RDS, see the "Data Migration" chapter in the *IBM Rational Directory Server Product Manual* or see the Help.

### **Rational Synergy session machine**

The following requirements are for a Rational Synergy session host, which runs Rational Synergy sessions for Rational Change. You can run Rational Synergy and Rational Change on the same machine.

**Note** For maximum performance, run Rational Synergy sessions on the database server.

#### Hardware requirements

The hardware requirements for each host running a Rational Synergy session are described in the <u>Readme</u>.

If you expect a large number of users for your Rational Change installation, you can increase capacity by dedicating additional Rational Synergy session hosts. You can do so later by logging on to a Rational Change session using the *Admin* interface and changing the host settings on the **Administration** action **Server** tab.

#### Software requirements

The software requirements for each host running a session are as follows:

- One of the supported operating systems must be installed and operational on the server. For information about supported platforms, see the <u>Readme</u>.
- Rational Synergy must be installed and operational. For detailed information about installing Rational Synergy, see the *Rational Synergy Installation Guide for UNIX*, located on the <u>Rational Software Information Center</u>.
- All session hosts must be able to respond to remote execution requests using the rsh protocol on Rational Change UNIX servers, or rexec for Windows servers to UNIX databases.

If using rsh protocol, their rshd daemons must be enabled.

An alternative solution, ESD, is available if rsh is not supported.

To configure ESD:

- 1. Ensure that ESD (ccm\_esd) is running on any host that will run Rational Synergy sessions. See the <u>Rational Synergy Administration Guide for UNIX</u> for details.
- 2. Set the ENGINE\_DAEMON option to true in the pt.cfg file: [CCM\_SYSTEM] [ENGINE\_DAEMON] true [/ENGINE\_DAEMON] [/CCM\_SYSTEM]
- 3. Restart Rational Change.

## Modes of operation


Rational Change supports two modes of operation:

- Stand-alone
- Central

### Stand-alone mode

In stand-alone mode, CRs are stored in development databases connected to the server. To access a CR, a user must log on to the database where the CR is stored. To establish a CR-task relationship, both items must be in the same database. The available databases are limited to the ones available to a particular Rational Synergy server on which Rational Change depends. This is the way it worked prior to the 5.0 or earlier release.

The following diagram shows the stand-alone Change server setup.



### Central mode


In central mode, all CRs are stored in the central CR database, which is a repository exclusively for CRs. Because Rational Change is always implicitly connected to the central CR database, a user can log on to any database within the central server cluster and still have access to all CRs. CR-task relationships are not restricted by the location of either item. In addition, the databases in the central server cluster can span the Rational Synergy servers and can be in geographically disparate regions.

### Central mode server types

There are two complementary server types in the central mode: central and remote. Within a central server cluster, there is always a single central server and zero or more remote servers. Each server, regardless of its type, can host multiple databases. The central server hosts the central CR database and, optionally, other databases. It is the only server end-users interact with.

A remote server acts as a proxy between the central server and remote development databases. A remote server is needed when you want databases that are hosted by different Rational Synergy servers to be part of the central server cluster.



Consider this example, using the figure above. A company has its headquarters in San Francisco (Central Change Server) and offices in Madrid and Berlin (Geographic Regions 1 and 2, above). This company has Rational Synergy databases in each geographic region, each hosted by a Rational Synergy server per city. The central server and the central CR database are located in San Francisco and are able to communicate with the databases in Madrid and Berlin through a remote server located in each city. In this deployment situation, there is a central server and two remote servers. All users access Rational Change through the central server (not a remote server) and have access to all CRs, regardless of the database they are logged on to for task work.

### Choosing a server type

The server type (stand-alone, central, or remote) is designated at the time of installation and cannot be changed thereafter. See "Installing Rational Change" on page 31.

Stand-alone servers work independent of each other, whereas a central server and its corresponding remote servers work together to form the central CR cluster. The order in which you install the central and remote servers is not a concern as they are linked together as a post-installation step. See "Connecting the central and remote servers" on page 51.

# Determining whether to upgrade from a stand-alone to a central server

To upgrade from a stand-alone server to a central server, you need to:

- Select a central CR database.
- Migrate all existing CRs into the central CR database.

A central server offers many benefits, which are mentioned above. However, sometimes it is not the correct choice for all users.

**Caution** Make sure you read this entire section so that you

understand all of the caveats before upgrading to a central server. Once you have upgraded, you cannot revert to a stand-alone server.

You should **not** use a central server if you use:

Certain nested queries

In central server mode, CRs and tasks are stored in separate databases, which impact the types of queries you can run on the different databases. When you know where objects are created, you understand on which queries you can rely.

Your central CR database contains only CRs. As a result, you cannot use query strings that bridge the relationship from CRs to tasks. For example, the following query string would not return accurate results:

has\_associated\_task(cvtype='task' and release='1.0') and crstatus='assigned'

Queries in your development databases are not as limited. Although CRs are not created in development databases, ghost CRs, which are non-modifiable copies of CRs with subsets of their real CR attributes, are created in the development database. Ghost CRs primarily exist to allow CR-based Update Members queries from Rational Synergy. When a task is associated to a CR, a ghost CR is created in all the development databases where that task is found. The ghost CR is directly related to the task to support most nested queries in those databases.

A ghost CR acts as a stand-in for the real CR. Rational Change automatically maintains ghost CRs so that they always reflect their corresponding real CRs. The attributes that are created on them can be controlled through the Rational Change Admin interface and should normally be agreed upon with your Rational Synergy build managers. With ghost CRs, a Rational Synergy Task Folder, in a development database, could still rely on a query, such as the following:

is\_associated\_task\_of(cvtype='problem' and release='1.0' and crstatus='resolved')

With ghost CRs, you can continue to use most CR-to-task nested query strings for CR-based Update Members. However, they have limitations. Ghost CRs only maintain the attributes they have been told to sync, though you can sync as many attributes as needed for your queries. They do not maintain any relationships beyond associated\_task, and they only exist for CRs that have associated tasks. Besides their use in Update Members, ghost CRs can also be queried for through the Rational Synergy CLI, but they cannot be edited there.

Most other ways of traversing between CRs and associated tasks continue to work as always, including Queries and Reports using report formats with associated tasks, Relationship Reports to associated tasks, the associated tasks control on Show Forms, and the Change Requests Explorer in Rational Synergy.

• The Rational Change for DOORS Interface

The Rational Change for DOORS Interface does not support transferring CRs between databases. If you are already using this product, you cannot migrate your existing CRs to a central CR database. If you do not currently use the interface, you can use the interface after you upgrade to a central server.

The CreateMiscObject API

The **misc** objects created by this API cannot be transferred to other databases. If you have used this API to create **misc** objects related to CRs, you must first delete those objects or unrelate them from your CRs. Otherwise, you cannot migrate your existing CRs to a central CR database.

Uncommon CR relationships

When you migrate, your existing CRs, the CRs, and their directly related objects are transferred to your central CR database. If any of those objects must remain in their current development databases, do not migrate. Normally, CRs are only directly related to other CRs, attachments, and tasks. This setup is safe to migrate. However, if you have created any direct relationships from CRs to other objects, those objects would be incorrectly transferred. Examples of unsupported relationships that do not work in a central server include:

- CRs directly related to source files (for example, Java<sup>TM</sup>, Visual C++®, Perl, and so forth). Source files should only be related to tasks.
- CRs directly related to projects or directories.
- CRs directly related to baselines.

Rational Synergy has features to show which CRs are included in a baseline. These features do not rely on relationships and continue to work in central server mode.

• Relationships from non-CRs to CRs.

#### Selecting a central CR database

In a central server, all CRs live in a single, central CR database so you can view, modify, and report on CRs without switching databases. This database is dedicated to CRs. Your tasks and objects are kept in separate development databases, but with Rational Change, you can associate CRs in your central CR database to tasks in any of the your development databases. Before installing Rational Change, decide which database will be your central CR database. You select it during the installation process, see "Installing Rational Change" on page 31, and you **cannot** change it later.

In most cases, you unpack a new, empty database to be your central CR database. This ensures that there are no development objects, such as tasks or source files, in the database. Then, you can transfer all existing CRs into that database with the CR migrate feature. See "Performing a CR migrate" on page 62.

Alternatively, you can designate an existing, non-empty database as your central CR database. You should do this only when you have a database completely dedicated to CRs. For example, you initially submit all CRs into one database and use Rational Synergy Distributed, also called Distributed Configuration Management (DCM), to transfer them to other databases before associating tasks. If you have any tasks or objects, anything other than CRs and their attachments, in that initial database, they might become inaccessible or damaged

in a central server. The advantage of using an existing database is that it might speed up migration if most of your CRs are already modifiable in that database.

### Understanding how a central server changes data

This section discusses how the central server affects the following:

- "Database queries, specific reports, and preferences" on page 21
- "Change requests" on page 21

#### Database queries, specific reports, and preferences

Queries, reports, report formats, and preferences are no longer database specific. You see the same sets of these items no matter which development database you log on to. Existing items in your development databases are automatically transferred to your central CR database. You do not need to explicitly migrate them.

If there are name conflicts between items in different databases, the conflicting items are automatically renamed. For example, if one development database used to contain Report A and Report B, and another contained Report B and Report C, after upgrading to a central server, your central CR database contains Report A, Report B, Report B (2), and Report C.

#### Change requests

If you are converting an existing database into to your central CR database, the CRs are not affected.

However, the CRs in your development databases are not initially visible in a central server. To make them visible, migrate them to the central CR database, see "Performing a CR migrate" on page 62.

When migrating CRs from a development database, the system:

• Transfers all CRs from a development database to the central CR database.

All CRs that are local to the development database are transferred to the central CR database and made local. Their modifiable\_in attributes are changed. In some cases, non-modifiable copies of the CRs remain in the development database, but you should assume that CRs will be deleted from that development database. Non-local CRs are skipped. You must migrate their development databases separately to transfer them.

• Transfers all CR attachments and other directly related objects to the central CR database.

If you have any objects associated to CRs that should not be transferred to the central CR database, you should not migrate. See "Determining whether to upgrade from a stand-alone to a central server" on page 18.

Preserves your CR-to-CR relationships.

These relationships remain intact in your central CR database. If you have CRs related to non-local CRs because you previously used DCM, the non-local CRs are not be migrated yet and do not show up as related CRs. When the databases that they are local to are migrated, then the CRs and relationships show up.

• Preserves CR-to-task associations.

Associated tasks and their associated objects remain in the development database, but the relationships from CRs to tasks are preserved. When a CR with associated tasks has been migrated, you can see its original associated tasks.

If you have determined that you should upgrade from a stand-alone server to a central server, see "Planning the upgrade from a stand-alone server to a central server" on page 57 for instructions.

## Selecting a Change Request Process


This chapter provides a high-level overview of the available change request processes to help you determine which process package to install.

### **Development process**

The development process, contained in the dev\_process.xml file, is a methodology for tracking CRs as they transition from being entered into the system to being resolved. The development process provides a basic software development change management lifecycle and is a good starting point for first time users.

Ultimately, the CR is either concluded successfully, marked as a duplicate of another change request, made obsolete, or rejected. The possible transitions and states for the development process are shown in the following figure.



### **Benefits**

The development process provides the following benefits:

## Unpacking a database and preparing it for use

A database is required when installing Rational Change. Use the following information to determine whether an existing database can be used during installation:

- **3.** In **Password**, type the password, and then click **Connect** to connect Rational Change to RDS.

If the connection attempt should fail, an error message appears with the reason the connection failed.

## Connecting the central and remote servers

Remote servers must be connected to the central server to participate in the central server cluster. It is possible to have a central server without any remote servers. This just means your cluster does not have any remote development databases (although it likely has, or will have, local development databases connected directly to the central server).

To connect remote servers from the central server, see "Add a Remote Server" in the Rational Change Admin Help.

To connect to the central server from a remote server, see "Add a Central Server" in the Rational Change Admin Help.

## Preparing Rational Change for use

After Rational Change has been installed, a single user, *local admin*, is available in Rational Change so that you can use the *Admin* interface. You must log on to Rational Change and install a process package before other roles can be used. You must also define user privileges in the database.

Perform the following steps to prepare Rational Change for use. For more information, click the **Welcome Pages** link.

1. If you are upgrading Rational Change, initialize RDS before proceeding.

When using OS authentication through RDS, the administrator must migrate the users into RDS. This may be done manually by recreating each user through RDS, or by importing users from a file. If you already have users defined in Rational Synergy databases, you can easily export them to a file through the Rational Change **Admin > Users > Export Database Users**. This file can then be imported into RDS.

**c.** Set up email for triggers and the subscription feature by setting the "SMTP Server" and "From E-Mail Address" in the "Sending E-Mail" section of **Administration > General**.

## Updating Rational Synergy mail triggers

Rational Synergy mail triggers send email to a predefined list of users when a task is assigned. You must update mail triggers after installing Rational Change.

To update mail triggers for the Rational Change installation, run the webdb\_patch script using the path *CHANGE\_HOME*, <u>item 10</u>, *database\_path*, <u>item 11</u>, and *mailserver\_host*, <u>item 14</u>, on your worksheet.

## Upgrade guidelines

To prepare for an upgrade, read the following guidelines before installing Rational Change.

- Ensure that you have installed RDS 5.0. For information about installing the RDS, see the <u>IBM Rational Directory Server Install Guide</u>.
- If you are using Rational Change Distributed, see the <u>Rational Synergy Upgrade</u> <u>Instructions</u> for information about Rational Synergy Distributed compatibility.
- You can upgrade customizations performed using the Lifecycle Editor by copying your XML file to the new Rational Change 5.2 cr\_process directory, loading the XML file, and following the instructions in the popup dialog box. In most cases, all that is required is saving the XML file, creating the package, and then installing the package.
- You can also upgrade a customization that was made manually. However, depending on the extent of the customization, additional work might be required to make it compatible with Rational Change 5.2.

Save your manual customizations in a package template. If you have done so, you can copy your package template into the Rational Change 5.2 package\_templates directory and use the package template to re-create your package.

• You must apply customizations that were made in the ptcli.cfg file.

In version 5.2, this file is located in:

For Jetty:

CHANGE\_HOME/jetty/webapps/context/WEB-INF/wsconfig

For WAS:

CHANGE\_HOME/context.ear/context.war/WEB-INF/wsconfig

For WASCE:

CHANGE\_HOME/context/WEB-INF/wsconfig

In prior versions, the file is located in:

CCM\_HOME/etc

• Pre- and post-transition TRELATIONs are no longer supported. Their functionality can be duplicated with bean scripting framework (BSF) trigger scripts, found in the wsconfig/triggers directory. Although the built-in TRELATIONs are automatically mapped to the replacement BSF scripts when the CR process is upgraded, other TRELATIONs might require manual replacement.

• If you are upgrading from version 4.7 or older, attribute controls (for example, base.CCM\_LISTBOX) were significantly updated in Rational Change 5.0. Most of the JavaScript<sup>TM</sup> that previously existed in the controls has been extracted into the file ctrlUtils.js, which is included on base templates. While an effort was made to preserve backward compatibility, certain types of customizations, such as interdependent controls, must be manually upgraded.

## **Populating the Rational Directory Server**

Rational Change stores user profile information in the RDS.

For information about migrating from older versions of RDS, see the <u>Rational</u> <u>Directory Server Product Manual</u> or the Rational Change Help.

## Planning the upgrade from a stand-alone server to a central server

Before you continue with this section, make sure you have read "Determining whether to upgrade from a stand-alone to a central server" on page 18 so that you understand all of the caveats before upgrading to a central server.

Caution Once you have upgraded, you cannot revert to a standalone server.

### Remote servers

A Rational Change remote server acts as a bridge between a central server and remote development databases. A remote server is needed when you want databases that are hosted by different Rational Synergy servers to be available to your central server. Each remote server can potentially be paired with a different Rational Synergy server. By registering your remote servers with your central server, you give the central server access to all of the development databases those remote servers can access. Also, with remote servers, Rational Change can access more development databases. Users only need to log on to the central server. All CRs are stored in the central CR database.

When planning your upgrade, plan on one remote server for each additional Rational Synergy server. Remote servers can be installed on any host that can be reached from the central server over HTTP or HTTPS.

### **Required space for CRs**

Before you upgrade, run the ccm cr\_summary Rational Synergy command for each development database you want to migrate into your central CR database. This command provides the number of objects that will be migrated to your central CR database and an estimate of the space that database requires. Knowing this ensure there is enough free space in the following locations:

The Rational Change installation area

While migrating CRs, each of your Rational Changes installations need a minimum of 500 MB of free space. If the underlying Rational Synergy installations are on different file systems, there should be 500 MB of free space on those as well. This space is used to hold temporary copies of CRs while migrating and should be large enough to accommodate about one hundred CRs, plus their tasks and attachments, at the same time.

• Database server space

Your database server holds information about CRs and their related objects. To determine the amount of space needed, use the total object count from your cr\_summary output. If you are migrating multiple databases, sum the totals from each database. For every 1,000 objects in your total, you need about 5 MB of database server space. For example, if your total is 11, 500 objects, round up to 12,000. You need about 60 MB (12,000/1000 x 5 MB = 60 MB). Use the ccmsrv expand command to increase your database server space. This command is located in your Rational Synergy installation.

• File system space

The file system where your central CR database is located (for example, /vol/ccmdb/central\_cr\_db) needs enough free space to accommodate all the attachments you will migrate. The total size (MB) of your attachments is listed in your cm\_summary output. If you are migrating multiple databases, sum the sizes from each database.

Overestimating the amount of space needed ensures that the CR migrate will be completed. It also allows for future growth of the central CR database.

### Existing DCM Transfer Sets

While in central server mode, do not use DCM to transfer CRs between databases. Remove CRs from all of your DCM transfer sets in Rational Synergy by setting the **CR Scope** of your transfer sets to **None** and deleting their **CR Query** strings. You should also remove the modifiable\_in attribute (Work In DB) from the show and transition forms of your existing, stand-alone Rational Change servers to prevent users from trying to transfer CRs before a CR migrate. Or you can remove the databases to be migrated from those servers.

Receiving all outstanding DCM transfer packages before you migrate your CRs ensures that no CRs are in transit between databases when you perform a CR migrate. If you later realize that you missed some CRs that were in transit, you can always migrate the database again to pick up the remaining CRs.

When you turn off CR transfers between your new central CR database and remote databases, consider what other data will continue to be transferred between the databases, and update your DCM transfer sets and scripts accordingly. For example, if you centrally administer releases and process rules, you need transfer sets and DCM scripts to continue maintaining that process, even after you turn off the transfer of CRs. For a discussion on the replication of releases, processes, and templates, see the "Advanced DCM Topics" chapter of the *IBM Rational Synergy Distributed Guide*, located at http://publib.boulder.ibm.com/infocenter/rsdp/v1r0m0/index.jsp.

## Upgrading from a stand-alone server to a central server

To upgrade to a central server, you need to install a new copy of Rational Change. If you will continue to run your previous server in stand-alone mode, remove any databases from that server before adding them to your central server. This document gives you an overview of the steps necessary to install and setup a central server cluster. For more detailed installation instructions, see the Rational Change Help.

### Prerequisites

Before upgrading to a central server, ensure that the:

• Databases are DCM initialized and DCM compatible with each other.

Your central CR database and the development databases you will use with it must all be DCM initialized with unique database IDs. Additionally, you can only migrate databases that are DCM compatible with your central CR database. For example, your development databases must have the same case setting, LOWER or PRESERVE. For more details, see the *IBM Rational Synergy Distributed CM Guide*.

• System clocks are synchronized.

If you are migrating from a remote Rational Change server on a different host than the central server, the system clocks of the two hosts must be synchronized.

### Installing and setting up the central server

To install and set up the central server:

1. Install Rational Change.

During installation, when prompted, select Central Server.

For your database, type the path to the central CR database you selected in "Selecting a central CR database" on page 20. You **cannot** change this database later.

- 2. Optionally, install Rational Change remote servers.
  - If you will access any of your development databases using remote servers, proceed to the next step to connect those servers now.
  - If not, skip to step 4.
- 3. Connect your central server and remote servers.

On each remote server, log on to the Admin interface. Click the **Administration** link in the panel. Navigate to the **Server** tab, the **Central Server** sub-tab, and click **Register**. Type the HTTP or HTTPS address of the central server. This can also be done from the central server.

4. Add development databases.

Log on to your central server. Click the **Administration** link in the panel, and then navigate to the **Server** tab. Add your development databases that are local to the central server. Repeat this for each remote server and the development databases that are local to them.

At this point, a functional central server is connected to its development databases, and, optionally, the development databases of your remote servers. You can submit new CRs and associate them to tasks in any of the development servers, but you cannot see any pre-existing CRs from those development databases. To access those CRs, migrate them into your central CR database. For instructions, see "Performing a CR migrate" on page 62.

### Performing a CR migrate

Before starting this procedure, note that CR migrate can take a long time to complete, sometime hours or even days for very large databases. Also, any DCM packages received while CR migrate is in progress can dramatically extend this time.

To perform a CR migrate:

1. Back up your databases.

Be sure you have a full backup of your central CR database and the development database that you want to migrate.

2. Log on to the Admin interface.

If you have one or more remote servers, log on to the server that manages the development database from which you wish to migrate.

- 3. Open the CR Migrate window.
  - a. Click the Administration link in the panel.
  - **b.** Click the **Admin** tab.
  - c. In Properties, click CR Migrate.
- 4. Select the database to migrate.

All of your development databases managed by this server are listed in a drop-down menu. Select the database containing the CRs you want to migrate.

5. Optionally, type an email address.

Since migration can take a long time, you can request email notification of its completion. If your central server is configured to send email through an SMTP server, check the **E-Mail When Done** option. If your email address is incorrect, type the correct address.

**6.** Start the migrate.

Click **Migrate**. If no errors occur, the CR migrate continues without any further intervention.

#### During the migrate

During the migrate, you can monitor its progress using the **CR Migrate** dialog box. Closing the dialog box does not stop the migrate. Reopen the **CR Migrate** dialog box at any time to check its current progress. To stop the migrate, click **Stop**. You can restart the migrate later by migrating the same database again.

Rational Change resumes from where you last stopped. A migrate can also be resumed if it fails midway due to a network problem or other error.

Users can use Rational Change during a CR migrate. Both the central CR database and the development database can remain enabled. As CRs are migrated into the central CR database, they are immediately available for users to view and edit, even before the entire migrate is complete. The newest CRs are transferred first.

### After the migrate

After the CR migrate has finished, run the ccmdb update\_statistics command to optimize your central CR database. This command can be run in the middle of a CR migrate. If you suspect the migrate is getting slower as it progresses, running this command in the background might improve performance.

### Troubleshooting

The section discusses some common issues that can occur during the migration and provides possible solutions.

• The CR migrate failed.

If CR migrate fails because of a transient problem (such as a network failure, a server restart, and so forth), re-migrate the failed database. Rational Change continues the process where the failure occurred. CRs that were already migrated are preserved.

If the failure is not self-correcting, see the log files for more details. CR migrate uses Rational Synergy DCM technology to migrate your CRs, and, in many cases, the Rational Synergy and DCM related logs contain the most detailed information. The ccm\_ui.log files for your Rational Change servers often describe failures in enough detail to resolve them. For even more details, including listings of every migrated CR, see the detailed DCM logs, which are in the database dcm/log directories. Depending on when the failure occurred, you might need to consult the logs in either your development or central CR database.

• Not all of the databases are DCM compatible.

A few DCM compatibility checks can be disabled during CR migrate, specifically the checks for compatible version delimiters and release delimiters. If you are already running in a DCM environment where you know these checks can be safely ignored, disable them by creating the following file in your Rational Change central server installation area:

For Jetty:

CHANGE\_HOME/jetty/webapps/context/WEB-INF/wsconfig/system/ app.user.properties

For WAS:

CHANGE\_HOME/context.ear/context.war/WEB-INF/wsconfig/system/ app.user.properties

For WASCE:

CHANGE\_HOME/context/WEB-INF/wsconfig/system/app.user.properties

Then add the following lines as necessary:

migrate\_ignore\_version\_delimiter = true
migrate\_ignore\_release\_delimiter = true

Finally, restart Rational Change to apply the changes.

# **Uninstalling Rational Change**

To uninstall Rational Change, run the Uninstall Rational Change program. Depending on the type of server, you are provided with information about the effects of uninstalling the server.

Also, if you are using WAS or WASCE, the:

- User who installed Rational Change has to uninstall the software.
- Servers should be up and running during uninstall.

Use the following procedure to uninstall Rational Change.

**1.** Stop the Rational Change server.

For steps, see "Stopping the Rational Change server for Jetty" on page 71.

**2.** Change the directory to the Rational Change installation directory (<u>item 1</u> on your worksheet).

\$ cd CHANGE\_HOME

3. Change the directory to the uninstaller directory.

\$ cd uninstaller

4. Set the DISPLAY variable, unless you are uninstalling in command-line mode.

\$ DISPLAY=host\_name:0.0; export DISPLAY

- Note You must have write access to the DISPLAY (*display\_setting*). For the correct DISPLAY setting, contact your system administrator.
- 5. Add CCM\_HOME/bin and CCM\_HOME/jre/bin to the beginning of the path.

\$ PATH=\$CCM\_HOME/bin:\$CCM\_HOME/jre/bin:\$PATH; export PATH

6. Uninstall Rational Change.

Add "-nogui" to the command to uninstall in command-line mode.

\$ ./Uninstall\_RationalChange.sh

#### **Resolving port conflicts for Jetty**

Jetty port conflicts can occur when Rational Change installations are using the same port that are in use by another application. Look in the change.xml file to obtain the port number used by Rational Change. Port conflicts can also cause related errors, including undefined users and port access failures. These problems might not appear immediately.

Resolve any port conflicts by assigning a different port number to one of the conflicting port users. Then, restart the Rational Change server.

If the Jetty Web server log reports that there are port conflicts or that subsequent use of Rational Change causes errors, check the log files for warnings about port conflicts and related errors. For more information, see "Log files" on page 68.

To resolve port conflicts, see "Resolving Rational Change port conflicts on Jetty" on page 70.

#### Resolving Rational Change port conflicts on Jetty

If Rational Change port conflicts on Jetty occur, change the Rational Change port number to an unused number by editing the change.xml and web.xml files.

1. Stop the server.

See "Stopping the Rational Change server for Jetty" on page 71.

- 2. Change the directory to CHANGE\_HOME/jetty/etc (CHANGE\_HOME is item 1 on your worksheet).
- 3. Make a backup copy of the change.xml file.
- 4. Open the change.xml file.
- 5. Change the Rational Change port entry.
  - **a.** Find the entry for the Rational Change port, for example:

```
<Call...>
<Arg...>
<Set name="Port">XXXX</Set>
...
</Arg>
</Call>
```

**b.** Change the port setting to an unused port number, for example:

```
<Call...>
<Arg...>
<Set name="Port">8888</Set>

- 6. Save and close the change.xml file.
- Repeat steps 4 6 for the web.xml file in the CHANGE\_HOME/jetty/ webapps/context/WEB-INF directory (CHANGE\_HOME is item 1 on your worksheet).

Start the Rational Change server by running the control script.

- Change the directory to the Rational Change installation directory.
   \$ cd CHANGE\_HOME/jetty
- 2. Start the Rational Change server.

\$ ./csctl.sh start

# Starting and stopping the Rational Change server for WAS and WASCE

To start or stop the Rational Change server for WAS and WASCE, you need to start or stop the entire application server. Do not merely start and stop the Rational Change Web application.

#### Installing multiple Rational Change servers for a database

Rational Change provides no explicit support for server load balancing, but it is possible to achieve a similar effect by installing duplicate Rational Change installations onto multiple servers. Ideally, each server should access a different set of databases, but multiple servers can share access to a common set of databases—provided you are willing to manually keep the settings of all the installations in sync. Different groups in your organization can then access the common databases through different servers, spreading the load among them.

#### Stand-alone server installation and planning

If you are using a stand-alone server, install Rational Change as usual on each of the servers that you want to access the common databases. Each installation must:

- Be the same release of Rational Change.
- Use the same authentication mechanism.
- Point to the RDS server.
- Point to the same Rational Synergy release.

Additionally, when a common database is added—either during installation or later through the **Admin Server** tab—its path must match exactly, including capitalization, across all installations.

At this time, you should mentally designate a single one of your installations as the primary server for the common databases. All other installations will be secondary servers. Rational Change does not distinguish primary and secondary servers, but changes to the CR process, listbox values, and other settings should always be made and controlled on the primary server, and then manually propagated to the secondary servers.

#### Settings requiring manual synchronization

CR Process

You should control and edit your CR process XML file only on the main server. The process package you generate from this file must be copied from the main server to all secondary servers. Your generated process package can be found on your primary server, and must be copied to the same directory on every secondary server. For each server, install the process package with the Package Installer as normal.

For Jetty:

CHANGE\_HOME/jetty/webapps/context/WEB-INF/packages

For WAS:

CHANGE\_HOME/context.ear/context.war/WEB-INF/packages

For WASCE:

CHANGE\_HOME/context/WEB-INF/packages

Listboxes

You should control and edit your listbox entries only on the main server. Listbox values are saved in the applicable directory below. When modified, this file must be copied to the same location on every secondary server. For each secondary server, load the new listbox values by selecting **Load** on **Admin > General**.

For Jetty:

CHANGE\_HOME/jetty/webapps/context/ WEB-INF/wsconfig/pt\_listbox.cfg

For WAS:

CHANGE\_HOME/context.ear/context.war/WEB-INF/wsconfig/ pt\_listbox.cfg

For WASCE:

CHANGE\_HOME/context/WEB-INF/wsconfig/pt\_listbox.cfg

• ACLs

You should control and edit your access control lists (ACLs) only on the main server. ACL definitions are saved in several files in the applicable directory listed below. When modified, all of these files must be copied to the same location on every secondary server. For each secondary server, load the new ACL definitions by selecting **Admin > General > Load**. Next, go to **Admin > ACL**, and enable the same ACLs as on your primary server.

#### For Jetty:

CHANGE\_HOME/jetty/webapps/context/WEB-INF/wsconfig/acl

For WAS:

CHANGE\_HOME/context.ear/context.war/WEB-INF/wsconfig/acl

For WASCE:

CHANGE\_HOME/context/WEB-INF/wsconfig/acl

Other Packages

As with your CR process package, any packages installed onto the primary server must be copied to and installed on all secondary servers.

• Admin > General Tab

If you modify any settings on **Admin** > **General** of the primary server, you must apply the same changes on every secondary server.

• Manual pt.cfg Settings

If you manually modify any pt.cfg settings on your primary server, you must make the same changes on every secondary server. For each secondary server, load the new pt.cfg settings values by selecting **Admin > General > Load**.

#### Limitations

Rational Synergy has a number of features that interact with Rational Change. These features continue to work, but they know about only one of your Rational Change installations: the last installation on which you installed your process package. If your users primarily access Rational Change using Rational Synergy, then this solution does not provide any benefit. All users are connected to the same Rational Change server.

By default, each server maintains its own search index. Since the indices are not necessarily updated at the same time, different servers might show different results. This only applies to search results. Queries and reports always reflect what is currently in your databases.

It is possible to have multiple Rational Change servers configured against the same databases to share a search index. This is done by setting the pt.cfg configuration entry [CCM\_SYSTEM] [SEARCH\_INDEX\_DIRECTORY] full path to search directory [/SEARCH\_INDEX\_DIRECTORY] [/CCM\_SYSTEM] to have the same path on all servers. The default value for the search index is the wsconfig/system directory.

Do not point to another server wsconfig/wsconfigsystem/wsconfigindex directory as that creates another index. Point to its wsconfig/wsconfigsystem directory or point all servers to another directory outside of the Rational Change directory hierarchy.

#### Licensing

Using multiple servers does not affect your licenses. The same number of licenses are available whether you use one or more Rational Change installations.

#### **Configuring Change to use HTTPS**

#### Updating the RDS configuration file

RDS is normally configured as a post-installation step, and the RDS connection information is stored in the rds\_config.xml file. The administrator needs to edit rds\_config.xml file only when the following occurs:

• The RDS URL changes when you want to use a different RDS server or when it is moved to another server.

See "Editing the RDS URL" on page 76.

• The RDS admin user name or password was changed.

See "Editing the RDS admin user name and password" on page 77.

The rds\_config.xml file is located in the following directory.

For Jetty:

CHANGE\_HOME/jetty/webapps/context/WEB-INF/wsconfig

For WAS:

CHANGE\_HOME/context.ear/context.war/WEB-INF/wsconfig

For WASCE:

CHANGE\_HOME/context/WEB-INF/wsconfig

All changes made to this file are applied when the configuration data is reloaded or when the server is restarted.

#### Editing the RDS URL

To edit the RDS URL:

1. In the rds\_config.xml file, edit the <url> line.

<user-id>rdsadmin</user-id>
<password>xxxxxxxxx/xxxxxxxx==</password>
</rds-config>
```

2. Save the file.

#### Editing the RDS admin user name and password

To edit the user name and password:

1. In the rds\_config.xml file, edit the <user-id> line.

4. Save the file.

The user name is changed, but the original password> is replaced by
password-unencrypted>, whose content is a clear-text password. When
the server reloads, the password is encrypted.
