




Key Features of Successful e-Forms

- High-value on-line transactions need to be:
 - **Enforceable** Secure enough to be a transaction document.
 - Automated Manual processing adds errors and time, creating unnecessary costs.
 - Secure If someone attempts to alter a signed transaction, it is detected immediately.
 - Auditable Can keep track of all the steps taken.




Summary of Benefits – Pure XML eForm Components
