Modification of the 'L' generation parameter date format -> X(10) $\,$ CCYY/MM/DD $\,$

Retrieval: entering a site Administrator is now required.(C:021677)

Two cases can prevent system initialization: . VA Pac is already under the control of a security system and no user has been declared via PARM, . the new number of licenses is lower than the number of users declared via PARM and the alphabetical sort of these users' retrieval rejects the Administrators at the end of the list. To solve that, a user input - required - in the retrieval procedure makes it possible to create an Administrator user. This input consists of the user's code and name. The Administrator's code will be automatically positioned. The Workbench and WorkStation codes will be made invalid and the assigned profile will be PBDEFAULT.

It is now possible to create "Virtual libraries" which will then be initialized in TP or batch (MLIB) mode. The maximum number of libraries in a network is increased from 300 to 595.

SAVE, MLIB, SASN and UXSR: these four procedures are now gathered in a single procedure PACS.

Database locked when session number reaches 9990(C:017367)

To avoid a reset to 0 of the Database session number once it has reached 9999, and to allow time to the Database Administrator for a backup execution, before that of the Session Compression Utility, the Database automatically locks when its session number reaches 9990.

Number of licenses control.(C:020511)

The 3.0 access key, besides the notions of modules and platforms, contains the following information: the grand total of users, the number of "Designer" licenses, the number of "Developer" licenses. Now the control of users number is no longer based on the calculation of the number of users connected but on the number of users registered. A user can be registered in the administration workspace even if he/she has no access authorization. A user registered in the system may be assigned: a simple license (use of a dumb terminal), a Designer license including a simple license, for the use of PacDesign workstation, a Developer license including the simple license for the use of ADWorkbench workstation.

Virtual Libraries: improvement of their management and processing of TP deletion(C:020934)

VIRTUAL LIBRARIES

A virtual Library is only visible to the Administrator. You cannot perform updates in a virtual Library. The virtual Library is created by the MLIB procedure in the '0001Z' session. When first created, a virtual Library can only be 'not initialized'. A special 'V' action code is used to transform a virtual Library into a 'not initialized' Library. This can only be done on line. This update is performed in the 0001Z session. At the same time, the Library code can also be modified. DELETION OF A LIBRARY The deletion of a Library is only authorized in a current session and only if it does not have sub-Libraries. For the Administrator, this Library remains visible in previous frozen sessions ('*** Library deleted ***' message displayed in 'LC*' on line command). For the

non-Administrator users, this Library is no longer visible.

Prohibit a less than 4-characters database code.(C:021298)

The (logical) database code, essential for connection, must not be shorter than 4 characters. The associated transaction code, if it exists, respects the same rule.

PG retrieval: users creation(C:021512)

PG file retrieval: creation of users. All user, present in the 2.5 PG file, will be created in the ADMIN database. The update will be done in creation mode, to avoid overwriting existing data.

This allocation mode contains some restrictions: . no other licensee can be allocated to a user owning a reading licensee. . A site Administrator must own one license at least, and not a "reading" license. . A Developer, Designer or Dumb terminal license, should be allocated only if the number of corresponding subscribed licensees is not reached. . A user can be created (or modified) with no license requirement. . As a consequence, this user is not authorized to connect to any terminal or workstation (Dumb terminal, ...). He is however authorized to launch batch procedures, if the Administrator of his site allocated the required authorizations to this user. 3 - Authorization hierarchy The licensees control brings in a new layer in the access controls. It is a priority among the current authorizations. By example, today an administrator has complete access. . Especially, a database administrator is authorized to access to all defined databases. Henceforward, the administrator needs an 'AD Workbench Developer' license to access to all defined databases. 4 - Users issued from the Retrieval During the retrieval, all created users are considered as "Dumb terminal" license owners. If the expected number of "Dumb terminal" licensees is reached, a reading license is allocated. When the expected number of reading licensees is reached, the user is created with no license requirement.

Two new values of the line type allow for Text Assignment (beginning and end) on all the types of entities : . "B" identifies the beginning of the assignment of the text which follows on the entity defined in the description part, . "E" identifies the end of the assignment of the current text on the entity defined in the description part.

These two types of lines, contrary to I- and J-type lines, can contain only one entity code, knowing that the length of this code can reach up to 30 characters for User Entities. The Entity type is always left-aligned and is 3-character long whatever the entity type. The available values for the entity type are the same as for I- and J-type lines.
