About this document

This document provides details of all the APAR service fixes that impact upon documentation, for IBM File Manager for z/OS Version 5.1, since the most recent edition of the product manuals in December 2004. These editions are:

Initial problem description

AbendS0C4 may be received when running the FMN2GEN utility. Additional Symptom: IBM0534S ONCODE=8094 Protection exception from compile unit ADB2GEN at entry point GEN_INDEX.

Outline of solution

File Manager, DB2 component has been updated to correct the problem.

Documentation impact

This APAR requires changes to be made to the Customization Guide (GC18-9378-02).

Changes to the Customization Guide

Part 2. Customizing File Manager/DB2 Component

In Chapter 10, Preparing to Customize File Manager/DB2, in Table 11, "Summary of steps for customizing File Manager/DB2 and the operating environment", add the following after step 9:

• Create a segmented table space in a TEMP database - required.

In Chapter 12, Customizing File Manager/DB2, add the following new DBRMs to the list in the section "Binding DB2 (**required**)":

DBRM ALIAS

FMN2ARM	ADB2REM
FMN2ARP	ADB2REP
FMN2ARR	ADB2RER
FMN2ARS	ADB2RES

In Chapter 12, Customizing File Manager/DB2, add the following section after the section "Binding DB2 (**required**)":

Creating a segmented table space (required): File Manager/DB2 uses DECLARE GLOBAL TEMPORARY TABLE statements to implement some features of reverse engineering. Each DB2 subsystem that runs File Manager/DB2 must have a database that is defined as TEMP that contains a segmented table space to support the use of declared temporary tables. The page size of the segmented table space must be at least 8 KB.

After File Manager/DB2 is installed, you must create a database that is defined as TEMP and a segmented table space in this database on each DB2 subsystem that runs File Manager/DB2, and that is not already set up to support the use of declared temporary tables.

A sample job, FMN2CGEN, is provided in FMN.SFMNSAM1, to help you do this. Sample statements are supplied to create the objects necessary to support declared temporary tables. You must run a version of this job for each DB2 subsystem you want File Manager/DB2 to use. Refer to the comments in the job for information about changes you may need to make to the job.

PK33455

Initial problem description

1. Error "FMN0355I Record size (80) invalid for FIXED,90 output" may be reported and changed member corrupted.

2. FCH may never complete (loop) when performing a CHANGE with record limit NLRECS (PK34692).

3. File Manager may abendS0C4 abend S0C4 in FMNRDRLA + 380x (PK31568).

4. When editing a V(B)S data set allocated with LRECL 32760, File Manager will allow for edit and change LRECL/record length to 32756/32752 or issue "Function terminated" error message (PK32493).

5. "Member in use" error may be reported and ISPF stats could be deleted from a PDSE member when performing FCH with JCL=YES and DIRINTEGR=YES. The "member in use" condition may not be properly detected when editing a PDSE shared across systems (PK32120).

6. ABENDS0C4 in IRXINIT, ABENDS978 in ISPF, ABENDS0C4, ABEND S0C4, or unpredictable results after specifying template criteria using the by field panels and RG operators (PK33920).

7. FCH may never complete (loop) when performing a CHANGE with record limit NLRECS (PK34692).

Outline of solution

1. Program logic has been corrected to allow for JCL records to be up to 160 bytes, regardless of PAD setting. Only data in columns 1 - 72 is considered to be JCL statements, data past column 72 is treated as non-changeable sequence numbers/comments. Note that when change

causes a JCL record to spill over and cause a continuation record to be created then any data in columns 72-end-of-record will be copied from the original record to the newly inserted record.

2. Program logic has been corrected.

3. Program logic has been corrected to properly invoke the utility functions.

4. Program logic has been corrected to allow for edit of V(B)S records upto 32760 bytes and to provide an error message (and refuse the edit) when LRECL > 32760 for a V(B)S non-LRECLX dataset.

5. Program logic has been corrected. Enhanced FCH to allow for CHANGE of cross-system shared PDSE's with JCL=YES processing option.

6. The storage overlay has been fixed.

7. Program logic has been corrected.

Changes to the User's Guide and Reference

Chapter 17, "Functions"

In the section, "FCH (Find/Change)", in the description for the JCL=YES option, replace the following text:

"The data set must be a non-VSAM data set and must contain fixed-length 80-byte records."

with

"The data set must be a non-VSAM data set and must contain fixed-length or variable-length records with maximum length of 160 bytes. If the record exceeds 80 bytes then the references to columns "72-80" in the above paragraph should mean columns "72-record length". Data past column 72 will be treated as non-changeable sequence numbers/comments."

PK34944

Initial problem description

1. "Invalid value" error may be reported when updating BIT fields in TABL view with HEX ON.

2. No convenient way to dynamically change the TEMPHLQ setting (PK25408).

Outline of solution

1. Program logic has been corrected.

2. For all FM components, the SET function has been enhanced to allow for a change of the TEMPHLQ value dynamically in batch processing (for the duration of the batch job).

Changes to the User's Guide and Reference

Chapter 17, "Functions"

In the section, "SET (Set Processing Options)", add the following to the syntax diagram:

_____TEMPHLQ=*temp hlg*___

In the descriptions following the syntax diagram, add the following:

TEMPHLQ

TEMPHLQ specifies an installation-specific high-level qualifier for the temporary data sets created during a File Manager session. You can specify any valid qualifier, including multilevel if required, up to a total length of 24 characters. If you specify &USER. for any part of the qualifier, this is replaced with the user's userid. A multilevel qualifier with symbols follows the same rules as in the specification of a data set name with symbolic parameters in JCL procedures. Thus, a single period used after a symbol combines the symbol with the text following it (See Example 1 below); a period separating parts of a multilevel qualifier must be doubled (see Example 2 below).

Example 1

If the userid is XXXX, then specifying &USER.1.TEMP results in a high-level-qualifier of XXX1.TEMP

Example 2

If the userid is ZZZZ then specifying FMN.&USER..ABCD results in a high-level-qualifier of FMN.ZZZZ.ABCD

Notes:

- 1. The TEMPHLQ parameter can be up to 24 characters long. However, temporary data sets can have different lengths, and the system part of the data set name may be longer than 20 characters. In this case, minor levels of TEMPHLQ are ignored, to the extent that the final data set name is less than or equal to 44 characters.
- 2. Concatenation of &USER.string could result in a part of the high-level qualifier being longer than 8 characters. In this case, the string is shortened to the extent that the final part of the qualifier is 8 characters long.

PK27651

Initial problem description

When one uses FCH and specifies a CHANGE command with the JCL option, and *string2* is shorter (different) than *string1*, then data (sequence numbers) get shifted in the non-JCL records.

Outline of solution

When using the **JCL source format** option, the columns searched for FIND or CHANGE command processing are set to 3 through 71, unless the statement is not a JCL statement. A statement is considered to be a JCL statement if it begins with any of the strings '/*' or '//'. If the statement does not begin with any of these strings, it is not considered to be a JCL statement in which case any column range specifed on the CHANGE or FIND command (or preset using BOUNDS command) is honored. This method can be used to stop data being moved in non-JCL records.

Documentation impact

This APAR requires changes to be made to the User's Guide and Reference (SC18-9380-02).

Changes to the User's Guide and Reference

Chapter 15, Panels and fields

Add the following comment to the description of the **JCL source format** option on the Find/Change Utility panel:

"When using the **JCL source format** option, the columns searched are set to 3 through 71, unless the statement is not a JCL statement. A statement is considered to be a JCL statement if it begins with the strings "/*" or "//". If the statement does not begin with either of these strings, it is not considered to be a JCL statement in which case any column range specified on the FIND (or CHANGE, respectively) command or preset using the BOUNDS command is honored. If no column range has been specified, the full record is seached."

Chapter 16, Primary commands

Add the following comment to the documentation for the BOUNDS Primary command:

"If this command is used in the Find/Change utility and the **JCL source format** option has been selected, the columns searched are set to 3 through 71, unless the

statement is not a JCL statement. A statement is considered to be a JCL statement if it begins with the strings "/*" or "//". If the statement does not begin with either of these strings, it is not considered to be a JCL statement in which case any column range specified is honored."

Replace the existing **Note** in the description of the **col1** parameter of the CHANGE primary command with:

"When you use the CHANGE primary command in the Find/Change Utility, if the **JCL Source format** option is selected, the columns searched are set to 3 through 71, unless the statement is not a JCL statement. A statement is considered to be a JCL statement if it begins with the strings "/*" or "//". If the statement does not begin with either of these strings, it is not considered to be a JCL statement in which case any column range specified on the FIND (or CHANGE, respectively) command or preset using the BOUNDS command is honored. If no column range has been specified, the full record is seached."

Replace the existing **Note** in the description of the **col1** parameter of the FIND primary command with:

"When you use the FIND primary command in the Find/Change Utility, if the JCL **Source format** option is selected, the columns searched are set to 3 through 71, unless the statement is not a JCL statement. A statement is considered to be a JCL statement if it begins with the strings "/*" or "//". If the statement does not begin with either of these strings, it is not considered to be a JCL statement in which case any column range specified on the FIND (or CHANGE, respectively) command or preset using the BOUNDS command is honored. If no column range has been specified, the full record is seached."

Chapter 17, Functions

Add the following comment to the description of the JCL=YES parameter of the FCH (Find/Change) function:

"The columns searched are set to 3 through 71, unless the statement is not a JCL statement. A statement is considered to be a JCL statement if it begins with the strings "/*" or "//". If the statement does not begin with either of these strings, it is not considered to be a JCL statement in which case any column range specified on the FIND (or CHANGE, respectively) command or preset using the BOUNDS command is honored. If no column range has been specified, the full record is seached."

PK11733

Initial problem description

1. A REPLIMS/DELIMS call without a WHERE clause should replace/delete the segment that the preceding GETIMS call retrieved. But when this segment or one of its parents has a nonunique key or no key, the REPLIMS/DELIMS call may replace/delete the wrong segment.

2. If you position on the parent of the segment that you want to insert and then issue an ISRTIMS call without a WHERE clause, the segment should be inserted under this parent. But when the parent or one of its parents has a nonunique key or no key, the ISRTIMS call may insert the segment under the wrong parent.

3. A GETIMS call with the ROOT parameter should retrieve the root segment that the current segment is under. But when the root segment has no key, the GETIMS call retrieves the first root segment in the database. When the root segment has a nonunique key, the GETIMS call retrieves the first root segment with the same root key as the current segment.

4. A GETIMS call with the TOP and the USING_VIEW parameters may retrieve the first root segment in the database even when the root segment is not included in the view. This call should retrieve the first segment in the database that is in the view.

5. An ISRTIMS call without a SET clause should obtain the data for the new segment from the OUTREC variable. But when the ISRTIMS call has a WHERE clause, it may obtain the data from the first segment in the database that satisfies the WHERE clause.

6. A REPLIMS call without a SET clause should replace the segment in the database with the data in the OUTREC variable. But when the REPLIMS call has a WHERE clause, it may not modify the I/O area before it executes the DL/I REPL call.

Outline of solution

The FM/IMS IEB function has been modified as follows:

1. When the preceding GETIMS call has the USING_VIEW parameter, a REPLIMS/DELIMS call with no WHERE clause will replace/delete the segment that the GETIMS call retrieved (as it should). But when the preceding GETIMS call does not have the USING_VIEW parameter and the segment you are attempting to replace/delete or one of its parents has a nonunique key or no key, you will be required to add the new HOLD parameter to the GETIMS call (see 9 below). IEB will let you know if this parameter is required.

2. If you position on the parent of the segment that you want to insert and then issue an ISRTIMS call without a WHERE clause, the segment will be inserted under this parent.

3. A GETIMS call with the ROOT parameter and the USING_VIEW parameter will retrieve the root segment that the current segment is under (as it should). But when a GETIMS call with the ROOT parameter does not have the USING_VIEW parameter and the root segment has a nonunique key or no key, the GETIMS call will issue a diagnostic and the EXEC will be terminated.

4. A GETIMS call with the TOP and the USING_VIEW parameters will retrieve the first segment in the database that is in the view.

5. An ISRTIMS call without a SET clause will obtain the data for the new segment from the OUTREC variable.

6. A REPLIMS call without a SET clause will replace the segment in the database with the data from the OUTREC variable.

7. The dynamic PSB that is generated for the IEB function will have one database PCB. Before this APAR fix, the dynamic PSB had two database PCBs -- a read PCB that the GETIMS call used and an update PCB that the REPLIMS, DELIMS and ISRTIMS calls used.

8. The GETIMS, REPLIMS, DELIMS and ISRTIMS calls all use the same PCB.

9. You may now specify the HOLD parameter on a GETIMS call that does not have the USING_VIEW parameter. A GETIMS with a HOLD parameter will retrieve the segment with a hold. Although in most cases it is not required, if you add a HOLD parameter to each GETIMS call that precedes a REPLIMS or DELIMS call your EXEC will execute less DL/I calls and run more efficiently.

10. When a GETIMS call with a HOLD parameter precedes a REPLIMS/DELIMS call without a WHERE clause, the REPLIMS/DELIMS call skips the GET HOLD DL/I call that, previously, it always executed.

11. An ISRTIMS call with no WHERE clause will only reposition on the current segment when the previous IMS call was a GETIMS call with a USING_VIEW parameter. In all other cases, repositioning before the insert is no longer required because all the calls now use the same PCB.

Please note that with these modifications, existing EXECs may behave differently.



1. A GETIMS call with the NEXT parameter and a WHERE clause should retrieve the next segment in the database that satisfies the WHERE clause. But it retrieves the first segment in the database that satisfies the WHERE clause.





Initial problem description

FM/IMS component:

1. The Edit and Browse functions do not always correctly handle an IMS abend.

2. When a view with a selection criteria on the root segment is used to edit or browse an HDAM database, FM/IMS does not always display all the segments that satisfy the selection criteria.

3. Segment Update/Delete Warning popup displayed when another user hasn't updated or deleted the segment you were attempting to update or delete. 6. The Logical Relationship Information panel only displays the insert, delete and replace rules and the key information for the logical child segments. It should display this information for all segments.

7. When the INSERT...segment-name command is issued and: a. the current segment is not a segment-name segment b. the segment-name segment has a parent with a nonunique key or no key the Insert Segment panel does not allow you to enter the occurrence number of the parent.

8. The Database Data Set Specification panel is displayed when you specify a logical HALDB on the Browse, Edit, Extract or Load Entry panel. FM/IMS should display the Database Data Set Display panel.

9. Message 'Data contains non-display characters. Use command HEX ON to view or alter them.' is displayed twice in a message popup window.

10. When multiple line commands are entered on the Edit or Browse data panel, FM/IMS does not validate them all before processing them.

11. If the FIND...ALL command is issued when the scope is DBREC and the top of window line is displayed, the editor scrolls down one line.

12. A CHANGE...ALL command issued when the scope is DBREC does not change an occurrence of the search string in the current database record and after the command is executed the editor displays a different database record.

13. A FIND...ALL command issued when the first occurrence of the search string is on the current page scrolls the data. The editor should only scroll when the first occurrence of the search string is not on the current page.

14. A FIND...ALL command issued when the first occurrence of the search string is before the start of the current page does not always display the target string at the top of the page.

15. An RFIND command issued after a FIND...REC command searches for strings outside of the search range when you place the cursor outside of the search range.

16. An RFIND command issued after a FIND...ALL command doesn't wrap to the top of the search range after the bottom of the search range has been reached.

17. A FIND...NOREC...FIRST command issued when the scope is DBREC does not find the first occurrence of the search string in the database.

18. The FIND...REC command and the FIND...CHILD command highlight occurrences of strings that are outside the search range.

19. The FIND...SEGMENT(segment-name) command highlights strings in all segments.

20. An RFIND command issued after a FIND...CHILD command issues message 'Segment has no dependents' when you place the cursor outside of the search range.

21. An RFIND command issued after a FIND...CHILD command wraps to the start of the database (rather than to the start of the search range) when the bottom of the search range has been reached.

22. If you: a. issue a FIND...CHILD command, then b. scroll the occurrence of the search string that is found to the top of the page, then c. issue RFIND commands the RFIND command does not wrap when it reaches the bottom of the range. It issues the message 'No chars found' instead.

23. Message "DFS0929I BLDL FAILED" and IMS U929 abend PFM1634 in the Edit or Browse dialog when you return to the Database Data Set Specification panel and then go forward in the dialog again.

All components:

24. If the cursor is in the data when a FIND, CHANGE, RFIND or RCHANGE command is issued and the search reaches the end of the search range without finding an occurrence of the search string, the cursor moves back to the command line. It should remain where it was before the command was issued.

Initial problem description

Manager/IMS security exit, FMN1SXT.

The Compare utility read-ahead logic is biased and may produce different results depending on which file is specified as the 'new' file.

When comparing 'source' files, false synchronization may occur.

When comparing data sets using a template containing multiple record layouts using read-ahead synchronization, the incorrect template record layout may be associated with a record.

Outline of solution

The read-ahead synchronization logic has been rewritten to reduce the perceived bias.

A new read-ahead synchronization parameter 'Read-ahead synchronization length' has been introduced. This field specifies the number of records that must match during read-ahead processing for synchronization to occur. Use this field when comparing "text" or "source" records, where false matches due to blank records or other commonly repeated records might be common.

The template record id will be saved with each record when performing read-ahead synchronization and used with this record when the record is retrieved from the read-ahead buffer.

 - When a change would cause truncation due to the insertion of characters, the card is split at a suitable position. If possible, File Manager inserts the part that was cut into the next card; otherwise, an extra card is be created.
 - When a change causes the removal of data, the card is changed to a comment card.
 - In both of the above, File Manager attempts to maintain the integrity of matching quotes, matching brackets, and commas between parameters.
- The rules do not apply to:
 - Comment (//*) cards.
 - Imbedded comments at the end of a legitimate JCL card
 - Non-JCL cards. For example, data cards.
 - JCL cards contained within a DD DATA construct as these are considered to be data cards.

The rules detailed above only apply to cards that are changed. If a card is not changed then the syntax is *not* checked.

Any JCL file that is referenced is assumed to have valid syntax. The integrity checking performed by File Manager should not be seen as a method of remedying invalid JCL.

When reformatting JCL cards, File Manager takes into account the following:

- The first card of a logical JCL statement contains one of the following statement types:

CNTL COMMAND DD ENDCNTL EXEC IF THEN ELSE ENDIF INCLUDE **JCLLIB** JOB OUTPUT PEND PROC SET XMIT

- Each logical JCL card may be comprised of one or more physical JCL cards.
- Comment (//*) cards are not candidates for reformatting.
- Data cards (no "//" in columns 1-2) are not candidates for reformatting.
- Each logical JCL card may have imbedded comment (//*) cards which are also not candidates for reformatting.
- The logical JCL statement line consists of the logical JCL statement itself (name, operation, and parameter fields), with continuation syntax removed. The logical JCL statement will be delimited with a x'FF'. Any comments will

then be appended with each comment being separated by a x'FF' delimiter. If there is no comment in a physical JCL card, a delimiter will still be appended to denote this.

- Each physical JCL card is comprised of 4 parts:
 - Name part

Contains the contents of column 1 up to the last character before the *parameter part*, including the card type. For example, DD, JOB, and so on. This part may also only contain "//" as in the case of a continuation line.

Parameter part

Contains the contents of the first character after the *name part*, up to the character before the first blank character after the *parameter part*.

Embedded comment part

This part is optional. It contains the contents of the first blank character after the *parameter part* up to column 71 inclusive. Column 72 is a special column and as such is not considered a candidate for reformatting.

Sequence number part (including continuation character) Contains the contents of columns 72 to 80.

When building a new set of physical JCL cards from a logical JCL statement, the following processing takes place:

- If the logical JCL statement line is unchanged, File Manager does not change any part of the associated physical records.
- If the logical JCL statement line content changes in any way, then File Manager reflows the logical JCL contents into the associated physical records.
 - **Note:** It is possible for a logical JCL statement change to require reflowing even if the old and new strings are identical in length-- the changed logical JCL statement might need to be broken into physical records differently.
 - File Manager attempts to maintain the contents of the existing physical line (columns 73–80) and the existing JCL statement comment fields. However:
 - File Manager does not attempt to associate any part of a logical JCL statement with the related physical line columns (columns 73–80), or with the JCL statement comment fields. The physical columns (columns 73–80), the JCL statement comment fields, and logical lines are treated independently of each other.
 - JCL statement comment fields may be truncated.
 - File Manager may remove redundant blanks from, and otherwise reformat, the physical JCL lines.
 - If a logical JCL statement is changed and it requires fewer physical records, File Manager turns the "extra" physical records at the end into JCL comment statements, which start with //* and contain blanks in the JCL statement area. Data in the comment record columns 73–80 remains unchanged from the original non-comment record data.
 - If an entire sub-parameter is removed as a result of a change, and this was the only information on a card, the card is changed to be a comment card.

- The REXX input and output buffers (INREC and OUTREC) contain the logical JCL statement, including the // at the front.

- Different (and unique) plan and package names are used for each File Manager/DB2 installation.
- The File Manager/DB2 plan and packages are bound using the appropriate DBRM modules for each version of File Manager/DB2.
- Each version of File Manager/DB2 uses a unique FMN2POPT module, and that module must specify the correct plan name for that version of File Manager/DB2.
- When File Manager/DB2 is used to access remote DB2 systems, the plan and packages for each File Manager/DB2 version must be bound on every DB2 system that might be accessed using File Manager/DB2.

The notes below cover the situation where an existing version (say version n) of File Manager/DB2 is installed. A new version (say n+1) of File Manager/DB2 is available and will be installed. The two versions of File Manager/DB2 are to be run concurrently while acceptance testing is completed for the new version of File Manager/DB2.

The default plan names are used for the existing version of File Manager/DB2 that is already installed:

- FMN2PLAN
- FMN2GEN

Similarly, the default package names are used for the existing version of File Manager/DB2 that is already installed:

- FMN2PLPK
- FMN2GNPK

For the new version of File Manager/DB2, select new plan and package names, for example:

- FMN2PLNA (instead of FMN2PLAN)
- FMN2GENA (instead of FMN2GEN)
- FMN2PLPA (instead of FMN2PLPK)
- FMN2GNPA (instead of FMN2GNPK)

Note that any new plan/package names can be selected, as long as the new names are different to all other File Manager/DB2 plan/package names already in use.

For the new version of File Manager/DB2, modify the sample FMN2BIND job to specify the amended plan and package names, as shown above. Run the FMN2BIND job on every DB2 system that the new version of File Manager/DB2 will have access to, either via direct or remote connection. Ensure that the DBRM library specified in the new bind job is for the new version of File Manager/DB2.

Modify the sample FMN2POPT job for the new version of File Manager/DB2. Specify the new plan names in the FMN2SSDM macro definition for each DB2 system that File Manager/DB2 will access, either directly or remotely, as shown below:

FMN2SSDM SSID=XXXX,PLAN=FMN2PLNA,PLAN2=FMN2GENA

Assemble the new FMN2POPT module, and ensure that is available when a user executes the new version of File Manager/DB2.
