Business Scenario

- Complying with regulations as well as understanding risk
 - SOX is on agenda for every public company
- Increased concern over all corporate "records"
 - Ramifications range from penalties to high reactive costs
- What, really, is required?
 - Proactive best practices





Compliance and recordkeeping is not new — new compliance initiatives are broader and deeper than before



Electronic vs. Physical Divide

Many formats

- Documents, images, emails, voice mails, websites, IM, structured data
- Multiple versions, renditions, duplicates
- Disparate content repositories and use
 - Shared drives, personal hard drives, email servers, backups
 - Access needs and storage limitations do not determine retention

Another chasm to cross

Records Management Foundations

- Records Mgmt Infrastructure
 - Lists of records categories
 - How is corporate RM organized
 - Retention Period
 - Types of records
- Provide access and processing
 - For full lifecycle
 - Storage options/formats
 - Support various users

- Assure an accurate and complete record
 - Content, Context, and Structure maintained

- Demonstrate integrity
 Prove immutability
 - Audit Trails



Email Realities and Liabilities

- Legislative/regulatory and litigious environment
 - How does the organization assess and commit to risk management
- Rate of infusion and usage of email in the organization
 - Pure communication vs. business transaction
- Huge volumes involved
 - Operational management can aid risk mitigation goals

- Expungement
 - Copies may exist on archives, backup tapes, or user computers
 - Emails easily copied and forwarded to locations unknown
- Court judgments for email discovery
- Increasing source for journalist/headline news stories
 - Getting on executive radar screens



Content and Compliance Linkages

- Provides a single application and repository for enterprise content and records management
 - Documents, records, knowledge and storage policies
- Governance infrastructure
 - Lifecycle metadata
 - Ownership, personal usage

ECM, RM, and Storage infrastructure integration is an evolving ecosystem



The Promise of RM-ECM Integration

- Embed record declaration functions into the business process
 - Author/Declare/Classify/Extract/Verify
- Structured Lifecycle Management
 - Time- and Event-based structured retention and disposition
- Accommodate existing recordkeeping practices
 - Expand physical classification and file plans
- Single System Classification
 - Minimize human error in assigning retention rules

IT must work with defined risk and compliance requirements to implement the records infrastructure



Proactive Best Practices

- Demonstrate proof of continuing awareness and accountability
- Address cultural and behavioral realities
- Start with a PMO that includes executive, legal/compliance, existing RM, LOB, and IT
- Conduct internal assessments of all organizational data
- Legal review for categorization, retention, and disposal



 - Outpacing IT's ability to collect, store and manage it by traditional means




The volume of information is growing rapidly
