






Success Stories

A Global Oil Producer

- "In the first year we identified 76 products that were seldom or never used and could be eliminated. We saved \$1.25MM in software license and maintenance costs."
- "We had a modeling product that cost \$144,000 per year but was used by only one application to produce a weekly service station sales report. Converting that application to a PC spreadsheet eliminated the service station sales report."
- "We also identified products that were licensed on multiple CPUs, but were only required on one. We have been able to eliminate approximately 200 licenses."






SAM Success Stories



European Patent Office



- The European Patent Office and IBM Global Services Integrated Technology Services worked together to implement the Tivoli License Manager software.
- The Tivoli License Manager software monitors usage of approximately 6,000 to 7,000 applications. The applications include Microsoft Internet Explorer, Adobe Acrobat, IBM Lotus Domino, Microsoft Visio and Microsoft SQL server software.
- With information obtained through the Tivoli License Manager software, EPO executives expect to reduce related software costs by being better positioned to negotiate new software contracts, plan for future software deployments and match resources with demand. The EPO believes that it will only need to achieve a few percentage points of savings to realize a full return on investment for the new Tivoli software solution.

- TCS faced challenges related to employees' compliance with corporate software licensing policies, software distribution and asset management, and server monitoring and maintenance. To satisfy requirements for becoming listed on India's stock exchange, TCS had to ensure compliance with national standards related to controls for enterprise software licenses.
- To manage employee behavior and gain better control over software and similar assets, the company established an enterprise system management program. Company goals were to collect complete asset inventory across the entire organization and comply with regulations related to licensing.



- To give some insight to how effective the mainframe SAM product has been for us, consider our experience:
 - "We started with 635 MIPS, 150 program products, and software expenses that were a little over \$7,000,000; the software cost per MIP was around \$11,000."
 - ▶ "Four years latter we have ~ 1,100 MIPS, 65 program products, and software expenses around \$4,400,000. Today our software cost per MIP is around \$4,000."





Required Detail for Software Costs Analysis




To address the issues related to software costs, businesses require detailed analysis of software use. This includes information on software that is underutilized, as well as software that is being used cost effectively within the terms and conditions of the contract.


