What's new in 2nd half 2004

Introducing on demand memory

Permanent Capacity:

• CUoD ... pay when purchased (processors & memory)

Temporary Capacity:

- On/Off CoD ... pay after use (processors & memory)
- Reserve CoD ... pay before use (processors)
- Trial CoD ... no-charge for use (processors & memory)





Introducing Reserve Capacity on Demand

Reserve CoD represents an "automatic" way to leverage temporary capacity.

No contracts and no reporting to IBM is required for Reserve CoD.

The purchase of Reserve CoD activation time is prepaid, in blocks of 30 Processor Days.

Reserve CoD enables the user to place a quantity of inactive processors into the server's Shared Processor Pool which then become available to the pool's resource manager.

When the server recognizes that the number of base (purchased/active) processors assigned across uncapped partitions has been 100% utilized, and at least 10% of an additional processor is needed, then a Processor Day (good for 24 hours) is charged against the Reserve CoD account balance.

Another Processor Day will be charged for each additional processor put into use based on the 10% utilization rule. No charging will occur when the 24 hour clock expires and there is no longer a need for additional processors.

The break-even pricing for Processor Days is approximately 90 Processor Days.





Introducing Trial Capacity on Demand

It's quick, it's easy, and ready when you are. Use it for whatever purpose you want. Ask for trial processor capacity or trial memory capacity or ask for both ... you really can't go wrong, because it is offered at no additional charge!

All you do is go to the CoD website and make a request We will provide you with a code ("key") to start the trial. The code is good for 30 consecutive powered on days, after it is entered at the server console.

A request for trial processor (up to 2 processors) or trial memory (up to 4 GBs) capacity can be made after initial install, after a processor upgrade, or after the purchase of one or more permanent processor activations.

You must make the trial capacity available to be re-claimed by the server at the end of the Trial Period.





"Trial capacity" is offered differently by model

Pre-2003 hardware (830, 840, and 890), *trial capacity* is available as part of the CUoD option, it represents a means of "trying" on demand capacity before permanently activating it. Trial capacity, allows you to temporarily activate 100% of your inactive processors for a period of 14 elapsed days by starting the trial period at the server console.

2003 hardware, the new models (i825, i870, and the new processors of the i890), <u>do</u> <u>not offer trial capacity</u> as part of the CUoD option. Instead, Bonus Days (14 Processor Days of credit) are available for use when/if a customer enables their machine for temporary capacity ... On/Off CoD.

2004 hardware, the new models (550 and 570), <u>do not offer trial capacity</u> as part of the CUoD option and <u>do not offer Bonus Days</u> (14 Processor Days of credit) as part of the On/Off CoD option. Instead, the new CoD option called **Trial CoD**, allows you to activate capacity (memory and/or processors) at no-charge, for a pre-determined number of consecutive powered on days, by making a request at the CoD website.

Capacity Upgrade on Demand (CUoD)

It's very simple ... whether you purchase an Activation Feature to permanently activate a processor or memory, when the server is initially purchased or sometime later ... you pay the then current list price for the Activation Feature ...

Once you have determined that you want to permanently activate some or all of your inactive capacity (processors or memory), you must contact your IBM Business Partner or IBM Sales rep to place an order for the purchase of a quantity of Activation Features.

Once an order reaches the IBM manufacturing site, an Activation Code unique to the target server is generated, mailed, and posted at the following web-site for quick access ... http://ibm.com/servers/eserver/iseries/ondemand/cod

Several days should be allowed for order processing and the resulting Activation Code posting to take place.

Ordering permanent capacity

Once you have determined that you want to permanently activate some or all of your inactive capacity (processors and/or memory), you must contact your IBM Business Partner or IBM Sales rep and ask to purchase one or more Activation Features.

Once an order reaches IBM manufacturing, an Activation Code unique to the target server is generated, mailed, and posted at the following web-site for quick access: http://www.ibm.com/servers/eserver/iseries/ondemand/cod

Several days should be allowed for order processing and the resulting Activation Code posting to take place. This is an important consideration when determining if you should leverage On/Off CoD or Reserve CoD to have access to temporary capacity. Temporary capacity can be used to satisfy any peak workload requirements while an order for the activation of permanent capacity is being fulfilled.







Step by Step

- Step1: Customer determines the number of inactive processors they wish to permanently activate
- Step2: Customer contacts their Sales Channel (IBM or Distributor/Partner) to place an

order for a quantity of Activation Features

- **Step3:** Sales Channel places an order in the IBM configurator for a specific quantity of Activation Features.
 - => If the Machine Serial# and/or the Anchor/Capacity Card Serial# have not been altered outside of the IBM manufacturing/field maintenance process ... then go directly to Step4
 - => If the Machine Serial# and/or the Anchor/Capacity Card Serial# have been altered outside of the IBM manufacturing/field maintenance process ... then print CoD Data (VPD) from the server and FAX to 507-253-4553

Step4: Customer retrieves the Activation Code from the web or waits for the Activation Code to be sent by mail. The Activation Code will be posted on the web usually within one business day of receiving the order on the IBM manufacturing floor. To retrieve the Activation Code follow these steps:

- 1) Go to the following Web-site.... http://www.ibm.com/servers/eserver/iseries/ondemand/cod
- 2) Enter the Machine Type and Serial number of the target server on the web page
- 3) Print and/or record the POD Activation Code displayed on the web page

Step-by-Step (continued)

Step5:

For iSeries servers (Pre-2004): Customer enters the Activation Code at the System Console

1) Start System Service Tools (SST) with the STRSST command or start DST with Function 21

on the control panel (key in manual position)

2) Sign on using service tools user profile of System capacity - administration

3) Select the option to WORK WITH SYSTEM CAPACITY

4) Enter POD Activation Code and press Enter

5) Press Enter to confirm change and exit the System Capacity service function

For i5 servers (2004): Customer enters the Activation Code at the Hardware Management Console (HMC)

Step6:

For iSeries servers (Pre 2004) Assign the activated processors to a partition to use the new permanently activated capacity

You must do steps A through F, even if your machine is not configured for LPAR!

A) Start the Work with system partitions option in DST or SST

- B) Enter Option 3 (Work with partition configuration)
- C) Enter Option 2 (Change partition processing resources) next to the PRIMARY
- D) Enter a value for "New number of processors" (The value should represent TOTAL active processors)
 - Note: If a configuration error is signaled at the bottom of the screen, it means that the default Primary
 - partition has been altered (logical partitioning is actively being used) and it is necessary to refer

to your logical partition plan to properly assign the activated processors to the server.

- E) Press Enter to confirm the change
- F) Exist DST or SST

For i5 servers (2004): Assign the activated processors to a partition to use the new permanently activated capacity

On/Off Capacity on Demand







On/Off Capacity on Demand (On/Off CoD)

On/Off CoD is perfect for spikes in needed capacity (a.k.a. peak loads). You will be required to pay for each Processor or Memory Day you request, but you only request what you need when you need it.

The number of Processor and/or Memory Days you will be billed for is determined by how many processors or memory you want temporarily activated over what period of time (qty of capacity X qty of days).

Customers are required to sign a contract and then report activity on a monthly basis. IBM will collect the reported information, consolidate it, and then send it to the registered IBM Business Partner. The IBM Business Partner places an order with IBM for a quantity of billing features (equal to the number of processor or memory days requested) and then bills the customer accordingly.

The break-even pricing for Processor Days (Note: includes temporary licensing for I5/OS and 5250 OLTP) on i5 servers is approximately 90. In other words, you could <u>permanently</u> activate a processor for the same price it would cost you to request 90 Processor Days of On/Off CoD capacity.





2003: On/Off CoD Enablement and Billing Features for processors

You pay full price for each Processor Day you request (qty of processors x quantity of days). If you request a processor to be temporarily activated for 90 days, you will pay approximatly the same price it would have cost you to permanently activate that processor.

What is a Processor or Memory Day?

Temporary capacity is activated, measured, and billed in units called "Processor Days" or "Memory Days"...

- Requested Days:number of processors or GBs of memory multiplied by
the number of days specified on a request for temporary
capacity
- Un-Returned Days: number of processors or GBs of memory multiplied by the number of days that remain available for use beyond the expiration of the request for temporary capacity





How is a Processor or Memory Day counted?

Scenario-1: When a request for temporary capacity is made (once the confirmation screen is pressed), a request is considered "started". Once the request is started, a 24 hour period (Processor or Memory Day) begins. At the beginning of each 24 hour period the capacity is in use, the server will record one Requested Processor Day or one Requested Memory Day depending on which capacity was requested.

Scenario-2: A request for temporary capacity can be stopped at any time, when the request is stopped, the server recorded information will be adjusted to reflect the appropriate number of Requested Processor Days (number of processors multiplied times the number of days that the temporary capacity was actually available for use). If a request for temporary capacity is stopped anytime before a 24 hour period has expired ... the server will have recorded a Requested Processor Day for each processor that was specified on the request and made available for use per the previous paragragh (Note: Each time a request is started for a processor, a Requested Processor Day is recorded .. if the request is stopped and a new request is then started within the same 24 hour period, the result will be the recording of an additional Processor Day).

Scenario-3: If processors remain available for use beyond the number of days specified on a request for temporary capacity, the server will record Un-Returned Processor Days. One Un-Returned Processor Day will be recorded for each processor that is still available for use (customer has not removed the processors from the assigned partitions and made them available to be re-claimed by the server) at the expiration of the request . An additional Un-Returned Processor Day will be recorded for each processor that is still available for use at the beginning of each subsequent 24 hour period. (Note: Multiple warning messages will be provided on the server alerting the customer to the pending expiration of a request for temporary capacity)







Prepaid, Bonus, and Complementary Days

Prepaid, Bonus, and/or Complementary Days credited to a customer's machine records will reduce the number of Billable Days to be charged at the end of each calendar quarter.

Prepaid Days – NOT available on @server i5 announced in 2004 (See Reserve CoD)

Thirty processor days will be credited to a customer's machine records each time an On/Off CoD Prepaid Feature is purchased.

Bonus Days -- NOT available on @server i5 announced in 2004 (See Trial CoD)

Fourteen processor days (this will vary on models purchased with the Capacity BackUp offering) will be credited to a customer's machine records the first time a TCOD Enablement Code is applied to the server. If and when the machine is upgraded (processor feature is changed), and a new TCOD Enablement Code is applied to the server, the number of credit days will be set to 14.

Complementary Days

Complementary Processor Days can, **at IBM's option**, be credited to a customer's machine records for special purposes (e.g., customer incentive to "try" new workloads) ... an e-mail from the IBM GEO pricer approving such action must be forwarded to the TCOD Administrator at icod@us.ibm.com.





Enable, use, and bill temporary capacity

- Enable temporary capacity is enabled on the server
 - Customer signs a contract with IBM
 - Sales Channel (IBM or Business Partner) places a customer order for an Enablement Feature
 - Customer enters resulting Enablement Code (either processor or memory) on the server
- Request -- temporary capacity is requested and then used
 - Request temporary capacity via server screen (specify units of processor or memory)
 - Electronically report temporary capacity activity (minimum of once per month)
- Bill -- temporary capacity is monitored, billed, and paid for
 - IBM consolidates the customer reported information
 - IBM notifies the Sales Channel about customer activity related to temporary capacity
 - Sales Channel places an "after-the-fact" configurator order for Billing Features
 - Sales Channel bills their customer

Temporary Capacity Enablement

Prior to requesting temporary capacity on your server, you must "enable" your server. To do this, order an Enablement Feature (MES only feature) and sign the required contracts.

Placing an order for an Enablement Feature will result in an Enablement Code being generated and mailed to you, as well as being posted on the Web for you to retrieve and enter on your server.

An Enablement Code "enables" the server to a limit of Processor Days (up to 192 for iSeries servers and up to 360 for i5 servers) that can be requested as temporary capacity. This means, you can make requests for temporary capacity over the life of the machine as long you don't exceed this value. When the limit is reached, a new Enablement Feature must be ordered and a new Enablement Code entered. Every time a new Enablement Code is entered it will reset the limit of Processor Days that can be requested to 192 for iSeries servers or 360 for i5 servers (Enablement Codes are not additive!)



Guidelines for Temporary Capacity Enablement

New Box Orders

the order for the new server <u>cannot</u> include an Enablement Feature because an Enablement Feature is MES only

Edition-to-Edition Conversion, Processor-to-Processor Conversion, or Model-to-Model Upgrades

- => All records of Enablement Features ordered prior to the conversion/upgrade are removed from the machine records (you will need to order a new Enablement Feature for the new hardware)
- => You can include an Enablement Feature on these types of orders (see warning) and have your Enablement Code mailed to you as well as posted on the web, so it is ready to enter on your server as part of the conversion/upgrade.

Enablement Feature Orders

=> For orders that have an Enablement Feature but don't contain a Processor or Edition Feature .. if the Machine Serial# and/or the Anchor/Capacity Card Serial# have not been altered outside of the IBM manufacturing or field maintenance process, then an Enablement Code will be generated and mailed/posted without requiring CoD Data (VPD) to be collected from the server and sent to IBM





Enable: Step-by-Step

PRE-REQ #1: Sales Channel (IBM Business Partner) must sign the following contract: IBM Business Partner Agreement, Attachment for On/Off Capacity On Demand PRE-REQ #2: Sales Channel (IBM Business Partner or IBM Direct) must register themselves at the following website:

http:/www.ibm.com/servers/eserver/iseries/ondemand /cod

Step1: Customer asks Sales Channel to enable their machine for temporary capacity
Step2: Customer must complete and sign the following contracts. It is the Sales Channel responsibility to return the signed contract to the GEO CSO organization and fax a copy to IBM at 1-507-253-4553
Required: IBM Customer Agreement, Attachment for On/Off Capacity On Demand Required: IBM Supplement for On/Off Capacity On Demand Optional: IBM Addendum for On/Off Capacity on Demand Alternative Reporting
Step3: Sales Channel places an order for an Enablement Feature
Step4: Sales Channel updates their website registration data (see pre-req #2 above) with information about the customer machine being enabled for temporary capacity.
NOTE: The order for an Enablement Feature will not be fulfilled until this step is completed!
Step5: IBM generates an Enablement Code and mails/posts it
Step6: Customer retrieves the Enablement Code and applies it to the server using the appropriate DST/SST Screen or for i5 servers, the appropriate HMC screen



Temporary Capacity Requests

When you decide you actually need to use temporary capacity ... you simply go to the proper screen on the server console (HMC for i5 servers) and specify how many of the inactive processors you would like activated and for how many days you would like them activated.

You will be billed for the processor days you request, so it is important to assign the processors to a LPAR partition as soon as they are activated to get the full benefit of the temporary capacity.

At the end of the temporary period (days you requested), you must make the temporarily activated processors "available" (LPAR state) to be re-claimed by the server, or you will be billed (per the contract you signed) for any Un-Returned processor days.





Temporary Capacity Billing

The contract signed by the customer prior to receiving the enablement code, requires the customer to report billing data, at least once per month (whether there is activity or not). This data is used to determine the proper amount to bill the customer for at the end of each billing period (calendar quarter).

For iSeries servers, any Prepaid, Bonus or Complementary Days will automatically be applied against customer Requested and/or Un-Returned processor days of temporary capacity (Note: These types of days are not available for i5 servers).

Failure to report billing data during a billing period for which the machine has been enabled (Enablement Feature has been ordered and the resulting Enablement Code has been shipped), will result in a bill for 90 Processor Days (estimated use) of temporary capacity.

At the end of each billing period (calendar quarter), IBM will process the reported data collected in the IBM database (MRPD), make adjustments for credit days (prepaid, bonus, and/or complementary) and then notify the sales channel, so the proper billing can take place.





Request: Step-by-Step

Step1: Customer establishes monthly reporting to IBM (whether or not temporary capacity is used). Details on how to setup electronic reporting (automated) can be found in the planning guide located at http: www.ibm.com/eserver/iseries/ondemand/cod

- Step2: Customer goes to the appropriate DST/SST Screen (WORK WITH ON/OFF CAPACITY ON DEMAND), or for i5 servers, the customer will use the appropriate HMC screen to specify the amount and duration of temporary capacity he/she wants (e.g. quantity of processors for a duration of days)
- Step3: Customer presses enter, to confirm the request, and the capacity is activated
- **Step4:** Customer assigns the activated processors to a partition (whether or not the machine is configured for LPAR) to begin use of the temporary capacity





Bill: Step-by-Step

Step1: Customer must report blling data (Requested and Un-Returned Processor Days)

at a minimum of once per month (per signed contract)

- **Step2:** At the end of each billing period (calendar quarter), IBM will process the reported data collected in the IBM database (MRPD), make adjustments for credit days (prepaid, bonus, and/or complementary) and then notify the sales channel, so the proper billing can take place.
- Step3: Sales Channel places an order for a quantity of Billing Features (One billing feature = One processor day)
- **Step4:** IBM will ship a notice to the "Ship-to-Address" outlining the activity IBM has recognized for the billing period. The notice contains the same info that has been forwarded to the e-mail addresses of the Sales Channel ... no pricing information!. The actual shipping of this notice to the "Ship-to-Address" on the order represents the fulfillment of the Billing Features from an IBM manufacturing perspective.
- Step5: Customer pays the Sales Channel and the Sales Channel pays IBM for the fulfillment of the Billing Features (Note: The customer can review a history log on the server, that contains a record for each request of temporary capacity ... can be used to validate billing charges)

Terminate: Step-by-Step

To stop the future use of temporary capacity, a Termination Code must be applied to the server: Step1: Send e-mail to CoD Administrator (ICOD@US.IBM.COM) Step2: The CoD Administrator provides a Termination Code Step3: The Termination Code is entered on the same screen used to enter an Enablement Code Step4: IBM will remove the Enablement Feature from Machine History Records **Scenario #1:** Customer requests a Termination Code because he/she does not want the server

enabled for temporary capacity any longer

Scenario #2: Customer/Partner requests a Termination Code because the customer is selling their machine (Note: A customer is required to have a Termination Code applied to the server before it is sold or comes off lease to avoid future billing for temporary capacity due to the customers failure to continue reporting use of temporary capacity)

Scenario #3: IBM or Partner requests a Termination Code because customer is not paying for temporary capacity

Scenario #4: IBM or Partner requests a Termination Code because customer is in noncompliance with the On/Off CoD contract that was signed by the customer

Reserve Capacity on Demand




Reserve Capacity on Demand (Reserve CoD)

Reserve CoD represents an "automatic" way to activate temporary capacity. Reserve CoD enables the user to place a quantity of inactive processors into the server's Shared Processor Pool which then become available to the pool's resource manager. When the server recognizes that the number of base (purchased/active) processors assigned across uncapped partitions has been 100% utilized, and at least 10% (multiple hits over a measured period) of an additional processor is needed, then a Processor Day (good for 24 hours) is charged against the Reserve CoD account balance. Another Processor Day will be charged for each additional processor put into use based on the 10% utilization rule. No additional charging will occur when the 24 hour clock expires and there is no longer a need for the extra processors.

Reserve CoD is a great way to handle peak loads that occur on a limited basis. But unlike On/Off CoD, no contracts and no reporting to IBM is required. The purchase of Reserve CoD activation time is prepaid, in blocks of 30 Processor Days (multiple blocks can be purchased at one time, or additional blocks can be purchased at a later date to increase the number of Processor Days available on the server)

The break-even pricing for Processor Days (Note: includes temporary licensing for I5/OS) on i5 servers is approximately 90 Processor Days. In other words, you could permanently activate a processor for the same price it would cost you to prepay for 90 Processor Days of Reserve CoD capacity.

Reserve Capacity Steps

STEP 1: Customer asks his/her Sales Channel to order a quantity of Processor Days

- A) Customer orders (HW configurator) a Reserve Capacity Prepaid Feature for 30 Processor Days of capacity
- B) MFS (CoD application) uses stored VPD records to generate a Reserve Capacity Prepaid Code (key) based on the quantity of Reserve Capacity Prepaid Features that were ordered
- C) The Reserve Capacity Prepaid Code is shipped from mfg (sheet of paper) and posted at a website for customer retrieval
- D) Customer enters the Reserve Capacity Prepaid Code at the server .. as a result, the Reserve Counter is set on the server to 30 Processor Days ... no inactive capacity is activated at this point!
- STEP 2: Customer assigns a quantity of Inactive Processors to the Shared Pool
 - A) Customer uses an HMC screen to "request" a quantity of inactive processors to be activated for use in the Shared Processor Pool (the processors are automatically placed in Shared Pool for use by uncapped partitions)
 - B) The server counts down one Processor Day, each time a reserve processor is called upon to complete work in the Shared Pool (100% of non-reserve capacity across un-capped partitions must be utilized before a Processor Day will be counted)
 - C) Customer receives "warning" messages when Processor Days have been used and when all of the purchased Processor Days have been used up (the reserve processors are automatically removed from the Shared Pool so no more work can be assigned).

Note: Reserve CoD may also be referred to as "debit" or "metered"

A request for trial processor (up to 2 processors) or trial memory (up to 4 GBs of memory) capacity can be made after initial install, after a processor upgrade, or after the purchase of one or more permanent processor activations.

A request for trial processor (100% of inactive processors) or trial memory (100% of inactive memory) capacity can be made one time over the life of the server, when and/if needed for unique circumstances.

You must make the trial capacity available to be re-claimed by the server at the end of the Trial Period.

Software Tier

Many partners use the Processor Feature Code value available on the server to set SW licensing fees. This value continues to be available for all i5 and iSeries servers. It is important to understand that this value does not change, no matter how many inactive processors get permanently or temporarily activated. The Processor Feature Code value (QPRCFEAT) can be displayed using the command WRKSYSVAL or retrieved using the RTVSYSVAL command.

Per Processor

With each **permanent or temporary** processor activation, it remains the customer's responsibility to comply with the SW licensing requirements of individual software vendors **IBM:** When a permanent processor activation (Activation Feature) is ordered, any required charges for IBM software which is orderable in e-config (licensed by

processor), is automatically initiated via IBM configurator

IBM: When a temporary processor activation is requested on the server, daily charges for IBM software that is licensed by processor, are required to be paid on a quarterly basis (On/Off CoD for Software)

IBM On/Off Capacity on Demand for Software

Logical Partitions and Software Licensing

- Customers set partition size, partition type, and max virtual processors at LPAR configuration
- Partition Size
 - Processing Units (PrU) number of processors assigned to a partition
 - Virtual Processors (VP)
 - Number of physical processors the partition can spread the workload across
 - Also sets upper limit for uncapped partitions
- Partition Type
 - ► All partition types are guaranteed the Processing Unit level of capacity if needed
 - Dedicated
 - If the partition is idle, other partitions <u>cannot</u> use the assigned Processing Units
 - Shared Pool
 - Capped/Uncapped
 - If the partition is idle, other partitions <u>can</u> use the assigned Processing Units
 - Uncapped
 - If other partitions are idle and an uncapped partition needs additional capacity, it will 'borrow' capacity from other partitions in the shared pool
 - Can 'borrow' to a level of virtual processors configured







Backup Copies of IBM Software

IBM license agreements allow the customer to make a backup copy of the program and use it on another machine when the primary machine is inoperable. This constitutes a temporary transfer of the license from the primary machine to the backup machine and terminates the right to use the program on the primary machine. **The IPLA agreement allows this license transfer without notification to IBM.**

IBM defines three scenarios for backup situations: "cold"; "warm"; "hot". In the first two scenarios, separate licensing for the backup machine is not needed. In a "hot" backup or "High Availability" scenario, the customer must obtain a separate license for any product that is being used concurrently on the primary and the backup machine. At a minimum, a Base Operating System (i5/OS) license is required for the "High Availability" or "Hot Backup" machine. Additional product licenses, if in use concurrently with the primary machine, are required.

- **COLD** -- a copy of the program may reside on a backup machine that is not powered up. There is no license requirement for this copy.
- **WARM** -- a copy of the program may reside on a backup machine that is powered up, is "idling", but is not doing any productive work (including mirroring transactions, development of applications, or testing). **There is no license requirement for this copy.**
- HOT -- a copy of the program may reside on a backup machine that is doing work. However, a license is required for any product that is being used concurrently with the primary machine (at a minimum, a Base Operating System OS/400 license).
 "Work" means mirroring of transactions, updating of log tapes/data, development, testing of programs and applications, any synchronization of programs, active linking with another machine, any activity that would allow an active hot-switch to occur, etc.

Software Maintenance

One year of Software Maintenance will be included with all NEW system purchases regardless of the use of the system, including High Availability or Capacity Backup machines.

Software Maintenance may optionally be renewed prior to the expiration in one year. If allowed to expire without renewal, purchasing Software Maintenance later is subject to an "After License Fee."

Hardware Maintenance/Warranty

Processor Failures

Inactive processors can be used as REPLACEMENTS for failed processors. Starting with V5R1, this
capability is offered on iSeries servers to help reduce the impact to server performance caused by a
failed processor. By re-IPLing the server after a processor fails, the customer can reestablish required
performance levels without waiting for parts to arrive on-site. If an inactive processor is not currently
activated, it will automatically be assigned as a REPLACEMENT processor and the customer can
continue processing.

Warranty for Processors

- Warranty for all processors (startup and inactive) begin when the server is installed. By having the Warranty/Service start immediately upon installation, the customer is better positioned to receive prompt service for the repair/replacement of any failing parts, helping to ensure the full complement of inactive processors are available for immediate activation.
- Maintenance agreement charges are based on the number of processors actually activated, maintenance prices will be adjusted for each <u>permanent</u> processor activation ... just like any other hardware feature add. (Note: Hardware maintenance does not increase with temporary activations)







License Information

BUILT-IN-CAPACITY

A machine may include computing resources or capabilities that are to remain inactive, or whose use is restricted, until the right to access and use the resources or capabilities is purchased (Built-in-Capacity). Cancellation of Orders

Once an Activation or Enablement Code is posted/mailed, the order is considered fulfilled and the downstream billing process will be started. If a customer decides to cancel the order, after a Code is posted/mailed, IBM will dispatch an IBM service representative to the customer location to "invalidate" the posted/mailed Code by performing a maintenance action on the Anchor/Capacity Card.

- Original Anchor/Capacity Card is replaced
- Level II is contacted to generate refreshed Code(s) that will reset the server to the "entitled" levels of capacity

iSeries server to iSeries server interchange of processor and/or package features is iSeries system password protected. iSeries server to iSeries server interchange of processor and/or package features outside IBM standard practices and procedures, may void the server warranty or service contracts.

What does it mean for CUoD or On/Off CoD?

Any unauthorized (Non IBM conversion/upgrade) movement of processor features (processor parts) and/or package features (capacity card) will disable any previously activated/enabled inactive processor capacity.

Any physical addition/removal of processor features (processor parts) and/or package features (capacity card) that results in an invalid configuration will make the server itself unusable (server will not IPL without a valid configuration).

Parts resulting from the fulfillment of an order for a processor conversion are directly tied to a target server (serial number), the parts are not transferable to a server with a different serial number. Installing the parts on a server with a different serial number is not supported by IBM.

What's new with @server i5 hardware?

- NOTE1: IBM will allow the number of Processor Parts installed in an @server i5 to be dynamically decreased (parts can be removed without an IPL or changing of Anchor Cards)
- NOTE2: IBM will allow the number of Processor Parts installed in an @server i5 to be dynamically increased (parts can be added without an IPL or changing of Anchor Cards) but the number of usable processors will be dictated by the Anchor Card
- NOTE3: IBM will allow concurrent maintenance .. meaning a Processor Part can be removed and replaced with a working part (this action can be taken without an IPL or without requiring any Anchor Card change
- NOTE4: IBM will no longer require a new System Password when the hardware is changed (there will be no use of System Passwords at all)
- NOTE5: IBM does not encourage/recommend that the Anchor Card ever be moved (Will result in the Frame and Electronic Serial number becoming out of sync)







Approved Movement of Hardware

Any movement of processor cards into an alternate @server i5 will disable any previously activated/enabled processor capacity. No capacity associated with the "additional" parts will be recognized and/or usable in the target machine.

Any movement of anchor cards into an alternate @server i5 will result in an invalid configuration and will make the target server itself unusable (server will not IPL). The anchor card should be returned to the original machine.
