Re: Correction; Papus & Native Title

Dear Editor,

Since your Aug-Sept 1996 edition I have pondered the significance of the Masonic Third Tracing Board illustrating a comment on *The Masonic Order of the Skull and Bones* on p 53 - what is the connection?

The April-May 98 edition however contains two particular factual errors which I feel I cannot let pass without comment. At p.30 Papus is named as past Grand Master of the *Ordo Templi Orientis*. This is not true as a comparison of the history of Martinism with the history of the OTO would reveal.

Papus (a French Doctor, Gerard Encausse) was Grand Master and founder of many organisations including the Ordre des Supieurs Inconnus. He was a Gnostic Bishop and a participator in the famous magical war between Stanislas de Guaita and Jules Bois. Papus organised an International Masonic Conference in Paris in 1908. During this time Papus received a patent from Theodore Reuss to establish a Supreme Grand Council General Reuss conferred upon Papus the X°(tenth degree) of OTO, and in return Papus assisted Theodore Reuss with the formation of the OTO Gnostic Catholic Church. There is a record of Papus providing Reuss with a Charter in 1901, designating him Special Inspector for the Martinist Order in Germany. Reuss also received letters, patents and a warrant from John Yarker in England.

Reuss and Carl Kellner prepared the manifesto for the OTO in 1903. Kellner died in 1905 and leadership of the Academia Masonica of OTO went to Reuss. Reuss was succeeded by Alistair Crowley, who in turn was succeeded by

Re: Australia's Tax Revenue Loss

Since an agreement was made between British and Australian governments in 1953, multinational corporations have escaped paying tax in Australia. First Assistant Commissioner for Taxation Mr Jim Kilally stated in 1996 "Multinational companies operating in Australia have evaded tax on \$200 billion annual profit exported offshore.'

In 1986 an embargo was put on the A.B.S, to stop release of figures on proportion of government and private sector foreign debt. Many Australians would like to know to whom the debt is owed, particularly after the World Bank advised Australia does not owe it anything.

The 1997 nett \$222 billion debt is obscured by \$326 billion gross foreign liability. On the basis of company tax at 32%, the 200 billion loss equals \$64 billion tax revenue lost annually. That figure divided amongst the 5 million payee taxpayers, shows they're paying the shortfall each person over taxed an annual \$8,533.33, equating to \$666.40 per month or \$164.10 weekly.

Over 7.700 multi-nationals operate in Australia and own over 83% of all business, including the majority of banks, finance and insurance companies and the top 100 pay no tax. NEW HIGHLY VENOMOUS SNAKE DISCOVERED

The latest issue of Australia's major herpetological (reptile) journal MONITOR, has announced the discovery of a new



species of highly venomous snake. Until recently the species had been confused with the King Brown Snake (Pseudechis australis), but research by several prominent herpetologists has confirmed that the snake is not only

different to the King Brown Snake, but substantially so. The species, now known as the 'False King Brown Snake' (Pailsus pailsei) is currently only known from the Mount Isa area in Queensland, although anecdotal evidence suggests that it may in fact be widespread throughout tropical Australia.

The scientific description of this species by Melbourne-based zoologist Raymond Hoser is significant, as these snakes are highly venomous and medically significant. To date there have been no venom tests on the species even though it is regarded as a 'dangerous' species. This could mean that lives are at risk in the event that people in remote areas get bitten. Fortunately the snake is not aggressive and will usually flee when approached. (The False King Brown Snake can be separated from other 'Brown' and 'King Brown' snakes in the same area by the fact that its underneath tail scales are all 'single' as opposed to 'paired' in 'Brown' snakes or 'mixed' in 'King Brown' snakes).

Hoser has called on Australian wildlife authorities to revise current laws and policies in light of the formal discovery of the new species and to allow capture of wild specimens to allow research on the species to proceed without impediment. Currently there is believed to be only one specimen in captivity (which is now at least 16 years old and blind), and only one confirmed specimen lodged in a museum. Further specimens both live and dead are urgently required for ongoing research. This includes the need for detailed venom tests and manufacture of anti-venom should the venom differ significantly from that of its nearest known relatives.

In all states people are currently allowed to kill snakes without any fear of being fined, while anyone seeking to take specimens from the wild for research purposes runs the very real risk of fines and/or jail. Currently there is an effective prohibition, nation-wide, on issuing take permits from the wild for these snakes. Hoser says this not only threatens current research, but also the long-term conservation of these snakes as they become rarer due to ongoing habitat degradation.

It is hoped that the announcement of this new species of 'Brown Snake' is widely publicised to heighten public awareness of these snakes and the fact that they are entitled to the same legal protection as more cuddly species such as Koalas.

CALIFORNIA DECRIMINALISES CAESAR SALAD

California decriminalised the sale of Caesar salad recently - and it's not a moment too soon, the U.S. Libertarian Party said. "When you outlaw Caesar salad, only outlaws will eat Caesar salad," noted the party's Director of Communications, Bill Winter. "That's why, on the issue of Caesar salad, we Libertarians have always been prolegalisation."

Selling Caesar salad became a crime

last year when Californian legislators passed a new health law banning the sale of food that used raw eggs as an ingredient. Unexpectedly, the law included Caesar salad, which uses uncooked eggs in its unique dressing.

Restaurant owners and fans of the popular salad - were outraged. The outcry convinced state legislators to file a new bill to cancel the criminal status of Caesar salad and, presumably, end what might have become a flourishing black market in contraband romaine lettuce, raw eggs, and Parmesan cheese.

The bill, signed into law by Governor Pete Wilson on Monday, has Libertarians cheering - but a little surprised.

"We have to compliment California legislators for their rare display of good sense," acknowledged Winter. "Although we're a bit surprised that they were courageous enough to toss the Caesar salad law entirely."

"We support the Constitutional right of every American to keep and bear a Caesar salad -- or, rather, to eat and buy a Caesar salad," said Winter. "All joking aside, it's a setback for those political eggheads who think they have the right to micromanage every aspect of our lives, down to the type of salad we buy in a restaurant. Hopefully, politicians will learn... to just lettuce alone."

DEAD IF YOU DO OR DON'T

Working either very many or very few hours a day increases a persons risk of a heart attack, a new study revealed recently. The scientists suspected a link between work-induced tension and blood pressure for the association with long hours.

Why a short working day should be risky was less certain. One possibility was that those who worked few hours were unhealthy to begin with. Another was that fewer work hours might lead to a deterioration in lifestyle. The Japanese study focused on 195 men aged 30-69 admitted to hospital after having a heart attack.

"BIG BROTHER" U.S. FDA TO BAN BOOKS

Not satisfied with merely controlling/banning nutritional supplements, the FDA recently decided to get into the bookbanning business. *US Food and Drug Administration* officials threatened legal action against *Stevita Co.*, for distributing books and literature about their product.

A Texas district officer of the US Food and Drug Administration ordered the destruction of three books; Cooking with Stevia: The Naturally Sweet and Calorie-free Herb; Stevia Rebaudiana: Nature's Sweet Secret; and the Stevia Story; A tale of incredible sweetness and intrigue.

James Laher of the Dallas district office of the FDA informed the company... "a current inventory must be taken by an investigator of this office, who will also be available to witness the destruction of the cookbooks, literature and other publications for the purpose of verifying compliance".

And the reason for this extraordinary campaign similar to book burning Nazi Germany? Each of the offending tracts refers to the natural sweetening properties of the herb Stevia Rebaudiana Bertoni,

better known as 'honey leaf'.

Why all the fuss? Stevia which is 30 times sweeter than sugar, contains no calories, and, most important, cannot be patented. Major multinational food companies like *Coca Cola* and *Beatrice foods*, convinced of its safety, use it to sweeten food for sale in Japan, Brazil and other countries where it is approved.

In response to mounting public pressure over this illegal action, the FDA has since contacted the company and advised them..."not to destroy the books at this time". Small comfort for those interested in freedom of information.

CALL FOR SELECTIVE HUMAN BREEDING

A survey of Chinese scientists working in the field of genetics suggests they overwhelmingly support eugenics to improve public health. The theory of eugenicswhich is considered highly controversial in the West - suggests that the human race can be improved by selective breeding. The survey which was conducted in 1993 among 255 geneticists throughout China, was reported in the British magazine *New Scientist*.

Almost unanimously by 91%, the scientists said that couples who carried the same disease-causing genetic mutation should not be allowed to have children. More than three-quarters believed that governments should require pre-marital tests to detect carriers of hereditary disease. They also supported the routine genetic testing of job applicants by employers. There was also strong backing for the genetic testing of children to see if they are susceptible to problems such as alcoholism.

The survey was carried out by Xin Mao, a scientist from the West China University of Medical Services in Chengdu. Xin Mao, who now works at the Institute of Cancer research in London defended the Chinese attitudes, saying cultural differences should be taken into account.

"The Chinese culture is quite different and things are focused on the good for society, not the good of the individual. It would shock people in the West, but my survey reflects cultural common sense," the researcher said.

The year after the survey, China introduced the controversial *Maternal and Infant Health Care Law*, which makes premarital check-ups compulsory and allows doctors to order abortions of foetuses with serious defects.
