CHILD VICTIMS OF THE GREAT WAR

By International News Service. Paris, May 23.—Little children broken by the war are one of the heart-wringing spectacles of the conflict in France. Large numbers of suffering boys and girls from the districts which the Germans gave up, have been brought here for treatment. Living amidst the blasting influences of war so long, they have become victims of a strange mental disease which has aged and stunted them.

The conditions of the men and women of France, who have been living under German tyranny, is terrible enough, but the condition of the half-starved, wounded, mentally deranged little children is even worse.
