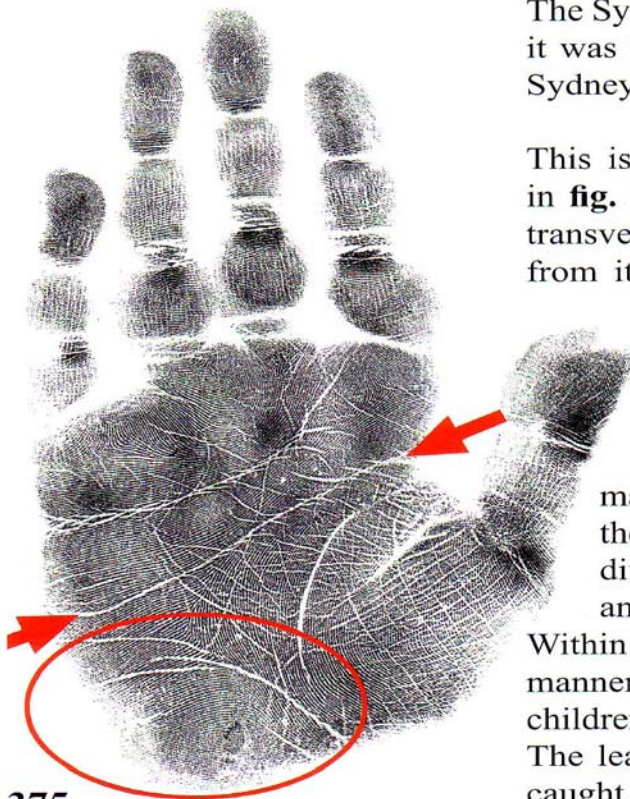

Dr. Holtzman's explains the much misunderstood Sydney Lines with an illustration (on page 392 of his book "Psychodiagnostic Chirolgy in Analysis and Therapy) , as given below.

the Sydney line



The Sydney line goes by this name because it was identified by medical geneticists in Sydney, Australia.

This is the line seen between the arrows in **fig. 375**. It is, in effect, a single lower transverse line that crosses the palm from its point of origin on the radial, or thumb side, to the far edge at the percussion side.

This line was found among young children, who could not match the learning skills of others their age. They demonstrated serious difficulty learning to read and write, and with comprehension in general.

Within a few years, and without any manner of professional intervention, these children overcame this difficulty entirely. The learning gap closed and they quickly caught up with their peers.

Being unknowledgeable of the Sydney line and its singular implications, the parents of these children and their first teachers seek the advice of counselors and experienced therapists. This almost invariably delivers a diagnosis of learning disabilities. The next station for these children is special education classes where they are made to endure intense focus on their supposed limitations.

The Sydney line appears to identify a program of growth and development in the infant and child. It has no bearing on innate intelligence or the capacity for analytical or abstract conceptualizations. Many of those carrying the Sydney line manage sophisticated studies and careers. But many never seem able to rise above the impoverished image of themselves that they recorded as children, and which they sustain as a permanent reference to their worth.
