## MEMBERSHIP APPROVAL

WHEREAS, the International Delphic Council e.V. (IDC), Rudolf-Baschant-Str. 1, D - 13086 Berlin / Germany, is an international non-governmental, not-for-profit, public benefit association of unlimited duration, duly registered and chartered under the laws of the Federal Republic of Germany under No. 15533NZ on 29 March 1995, and is the founder and parent organization of the International Delphic Movement; and

WHEREAS, the IDC is guided by the fundamental principle, as stated in its Charter 'to contribute to friendly and peaceful relations among nations and their citizens by promoting and encouraging friendly, tolerant and respectful relations among the diverse cultures of the world through cross-cultural artistic exposure and education, which undertaking is supported by the creation by the International Delphic Council of various unbiased forums for the international promotion and display of national and regional cultures and arts through performances, exhibitions and competitions'; and

WHEREAS, the IDC has received an application for membership in the IDC, dated 23rd of March 1999 from an association entitled „National Delphic Council Russia, Allrussian Public Organization“ registered under the laws of the Federation of Russian Republics; and

WHEREAS, said application has been accompanied by certain supporting documents; and

WHEREAS, said documentation is supportive of, and compatible with, the principles, purposes, goals and activities of the IDC, its Charter and By-Laws; and

WHEREAS, the applicant is aware of, and agrees to honor, the Rights and Obligations of Membership in the IDC as contained in the Tbilisi Statutes, and Section 3, Paragraph 3.3 of the pending By-Laws of the IDC, or as amended, and to be bound by said Statutes, Charter, pending By-Laws, and Resolutions of the Executive Board and World Congress of the IDC; and

WHEREAS, the applicant, pursuant to said obligations, shall undertake permanent and active efforts aimed at the sponsorship, establishment and promotion of numerous organizations formed at the city, province and regional levels within the Federal Republic of Germany, with unified or diversified cultural specialties, for adults, and juniors under the age of eighteen (18), as the 'grassroots' foundation activity to support the cultural and educational aims of the IDC, and to encourage existing organizations to sponsor or establish these 'Delphic Clubs' and 'Junior Delphic Clubs' in neighboring areas, and





WHEREAS, the applicant shall have a period of twelve (12) consecutive months from the date of application to achieve the required number of legal entity and individual members required for membership in the IDC as the National Delphic Council of Germany.

NOW THEREFORE, I, J. Christian B. Kirsch, duly elected Secretary-General of the International Delphic Council, pursuant to the authority contained in Section 12, Paragraph 1, as amended in accordance with Section 22 of the IDC Tblisi Statutes, do hereby declare the applicant to be the:

and admitted for membership in the International Delphic Council effective as of the date of application, with all rights and obligations appertaining thereto.
