PRESIDENT'S DESIRE TO FORCE CENSORSHIP APPEARS DOOMED

State Department Declines to Issue Passports to Socialist Meeting in Stockholm Because of German Propaganda. Swiss Paper Uncovers Plot of Teutons

Washington, May 23.—President Wilson's desire to force newspaper censorship into the spionage bill appears to be doomed. It is indicated that both the Senate and the House will reject the proposal.

The Republican caucus yesterday decided to oppose all censorship proposals. The conferees meet again on Friday. The Senate has twice rejected the censorship. President Wilson served notice today on both houses of congress that despite the decisive rejection of the censorship section by the Senate and the House Republicans, he has decided to throw all his power and influence behind an effort to restore it to the espionage bill.

The state departments announced today that passports will be refused to Americans attempting to attend the Socialist conference in Stockholm and will prevent the departure of Morris Hollquit, Victor Berger and Algernon Lee, delegates of the American Socialists. It is indicated that the Socialist meeting in Stockholm is nothing but a disguised German propaganda.

In connection with the German propaganda work, an apparent attempt to create ill-feeling between the United States and Switzerland has been brought to the attention of the State department. This was uncovered by the Swiss newspaper Freie Zeitung, of Berne. The purpose behind the German move is to bring about a break between the United States and Switzerland and force Switzerland to place its entire dependency on Germany.

Williamire: Wis, May 22.—Victor Revger, commenting on the government's refusal to passports to delegates to the Socialist convention said that if the state department order is not reconsidered America will be the only country not granting passports to delegates.

"No separate peace propaganda with Russia is contemplated. The international Socialist movement, however, will not take orders from Lansing any more than it did from the Czar," he said. He said this action "Is rather characteristic for a government that is fighting for Democracy."

Italy may receive credit for the device to clear the seas of submarines. The Italiam war mission, which arrived here this afternoon brought word of an invention which resulted in the sinking of thirteen German submarines in the past few weeks.

Conferences between the Italian mission and the government officials will begin tomorrows and continue for three or four weeks.

The House finally passed the \$1,800,000,000 war revenue bill this afternoon by a vote of 409 to 76. The Senate will take up the bill and probably will change it. It may cut out \$150;-000,000 from the bill. The increased second class mail rates were retained.
