REPEALING BANK CHARTERS.

The people of Virginia, we pledge him, would never sustain the doctrine of repeal—ever. It is but a few years since this audacious heresy was confined to the lower slave-holders of the New York, Boston, maintained alone by such men as Shaw and Mingo, and spouted full at ward meetings to induce the proslavery population.
