UNITED STATES OF AMERICA STATE OF LOUISIANA. CITY OF NEW ORLEANS. BE IT KNOWN that on this 11th day of September 1909...

ARTICLE I. The name and title of the corporation hereby formed is declared to be the H. W. SLOAN COMPANY, LIMITED...
