

CHARTER.

UNITED STATES OF AMERICA. PARISH OF ORLEANS. CITY OF NEW ORLEANS.

BE IT KNOWN that on this Fourteenth day of the month of October in the year of our Lord One thousand nine hundred and ten...

ARTICLE I. The name and title of the corporation hereby formed is to be the JOHN A. ALSINA COMPANY LIMITED under which name it shall have and enjoy corporate succession...

ARTICLE II. The domicile of this corporation shall be in the Parish of Orleans, Louisiana. A citation or other legal process shall be served on the President of the Company...

ARTICLE III. The objects and purposes for which this corporation is organized and the nature of the business to be carried on by it are hereby declared to be the carrying on of a general retail grocery and commission business...

ARTICLE IV. The capital stock of this corporation is hereby fixed at the sum of twelve thousand dollars (\$12,000.00) divided into one hundred shares each of the value of one hundred dollars each per share...

ARTICLE V. The corporate powers and authority of this corporation shall be vested in a President and Treasurer and two Directors, who shall constitute a Board of Directors...

ARTICLE VI. The stockholders shall be held liable for the debts and contracts of this corporation in any further sum than the amount of their shares...

ARTICLE VII. Both the stockholders subscribing to this charter and all future stockholders agree with each other not to dispose of their stock without first giving in writing to the other stockholders three days notice...

ARTICLE VIII. No stockholder shall ever be held liable or responsible for the contracts or debts of this corporation in any further sum than the amount of his shares...

ARTICLE IX. At the termination of this charter by limitation or otherwise the business and affairs of the corporation shall be liquidated by three commissioners to be appointed from among the stockholders...
