RULES REGARDING FREIGHT ON THE PORT-CHARTAIN RAILROAD.—An important notice from Superintendent Pandely, on the part of the Post-Chartrain Railroad Company, will be found on page 2 of this issue. It contains a statement of charges and conditions of rates extracted for transportation to the above road to two of the rules and conditions defining the responsibility of the Company for freight, as follows:

"The Company will not be responsible for freight or freight by fire, either in transit or at the terminal of the road."

"The responsibility of the Company as carrier ceases at the terminal of the road."

Although due care will be taken to avoid accident, yet, owing to the dangerous condition in which cotton is landed at the Lake terminals, the Company reserves the above rules, warning shipowners against the landing of cotton at their wharves, when in transit, at the Lake and wharf, or on the cotton ground at the city end.
