### PUBLIC SCHOOLS.

**THE** Regents of the Central and Primary schools having procured a healthy, commodious, and central position for the upper primary school have the pleasure of announcing to the public, that it is, this day, reopened under the care of Doctor J. A. Kimpicut, principal, and J. Duval assistant, in the Baptist Church, Lafayette square.

The lower primary school, under the care of Mr. Bigot, principal and Riviere assistant, and the Central school under that of Messrs. Murray, principal, Fochot and Roca de Santi Petri, professors, continue, as heretofore, in the old Convent of Ursulines, Condé Street.

Books and Stationary furnished by the pupils or charged separately.  
In each of the schools one hundred pupils unable to pay for their education are admitted and taught gratis. Application may be made to the principals of the several schools, the Director of the public schools, the President of the Board of Regents or the Mayor of the City.

El mismo profesor enseña tambien la Retorica, la Geografía, la Historia universal, la Doctrina de los derechos y deberes del hombre en sociedad, y la Economía politica; y ciencias que son de rigorosa necesidad en una república, para los ciudadanos que aspiran al honor de participar a la legislatura ó a la administracion pública: además, es menester una instruccion a todos los ciudadanos; de esta dependen principalmente su felicidad, el buen orden y la fuerza de la sociedad, la ejecucion y el efecto de todas las leyes, sobre todo si esta instruccion tiene, por primeros elementos, una sana y pura moral, y la doctrina de los deberes sociales.
