To whom it may concern:

I send this e-mail and letter to: [ES.WIKIPEDIA.ORG](mailto:ES.WIKIPEDIA.ORG)

I'm addressing to you on behalf of the Centro Español de Derechos Reprográficos, CEDRO (Spanish Reproduction Rights Centre'), a non-profit association of authors and publishers of books, periodicals and other publications in any medium. The association collectively protects and manages members' intellectual property rights (copying, processing, public disclosure communication to the public and distribution). You can check our statute at the web page [http://www.cedro.org/ingles\\_estatutos.asp](http://www.cedro.org/ingles_estatutos.asp) or visit at the Subdirección General de Propiedad Intelectual del Ministerio de Cultura in Madrid, Spain, Plaza del Rey nº 1.

In the exercise of our activity, we have found that the copyright work: "*Historia secreta de los mongoles*" is being offered to the public by subjects without the corresponding authorization of the rightholders in your web. This work is not subject by the terms and conditions of the creative commons public license because their rightholders did not authorized this kind of license.

In this respect, the Spanish Intellectual Property Law (RDL1/1996, as modified by Law 23/2006) establishes that corresponds to the author the exclusive exercise of the exploitation rights over his works and, in particular, the right of

reproduction, distribution, communication to the public and transformation (Article 17).

Following the abovementioned Law, the reproduction and communication to the public of the works listed above without the authorization of the rights holder, implies an infringement of the rights protected by such Law.

We submit this statement with a good faith belief that use of the aforementioned material is not authorized by the copyright owner. On the same line we swear, under penalty of perjury, that the information in the notification is accurate and that we are authorized to act on behalf of the owner of an exclusive right that is allegedly infringed.

Furthermore, the Spanish Law which regulates the Internet Service Providers (ISP) activity (Ley 34/2002, de 11 de julio, de servicios de la sociedad de la información y de comercio electrónico) establishes that providers that store data and contain files uploaded by users, are responsible for the stored information if they have effective knowledge of the illegal activity and do anything to remove the works.

Hereby, we formally request you to act legally and remove the aforementioned copyrighted work; if no act will be taken, we will feel in duty to proceed against the responsables.

We are in your service to clarify any doubt that can arise about this happen
